FEE PROPOSAL & HAZMAT TRANSITION PRESENTATIONS - INVITATION

The County of San Diego Department of Agriculture, Weights and Measures (AWM) is committed to providing quality services in a cost-effective manner while supporting a diverse agricultural community, a sustainable environment, and a fair marketplace.

In an effort to continue the dialogue, provide you with additional information, and answer any question, we will be hosting two additional workshops. Each workshop will consist of a fee proposal presentation followed by a HazMat program transitioin presentation and roundtable discussion.

We have developed a Fee Proposal which allows us to continue providing quality service; make required operational adjustments as allowed by recent regulatory changes; and comply with the County Board of Supervisors' policy to recover our costs to provide Pest Exclusion, Direct Marketing (Certified Farmers' Markets, Certified Producers), and Agricultural Verification services. These fees were last updated from 8 to 18 years ago, depending on the fee type. This will be the first presentation.

We will also discuss transitioning of the Agricultural Hazardous Materials Permit Program to the County Department of Environmental Health. This portion of the presentation will focus on changes related to the transition of the program and the impact to agricultural operations. This will be the second presentation.


