

ANNUAL REGISTRATION FEE SCHEDULE

1. **\$100.00 per Business Location** (a vehicle or business location containing one or more commercial devices) or, **\$50.00 per Co-located Business Location** which is one that:

(a) operates in, at or immediately adjacent to another business that pays an annual registration fee under this ordinance; (b) at that location has the same street address as the other business; (c) is at that location with the written permission of the other business; and (d) uses weighing devices \leq 30 lbs. Capacity or measuring devices that dispense only 5 or fewer gallons. One example is water-dispensing machines outside a grocery store.

Fee Type G \$175.00/Device for (05) Liquefied Petroleum Gas Meter (LPG):

AND an Annual Device Administrative Fee: \$8.00 per each Type G Device

Fee Type H \$10.00/Device for All Devices in Type B at co-located business \leq 30 lb Capacity or 5 or Fewer Gallons:

AND an Annual Device Administrative Fee: \$1.10 per each Type H Device
