UTILITY SUB-METER TESTING AND REGISTRATION NOTICE

Registration of utility sub-meters used for commercial purposes is required annually. Registration fees offset the cost of inspection and testing to ensure commercial devices are in compliance with state and local laws. Enclosed is the renewal application for your registration certificate.

- **Please be advised the sub-meter lab will no longer accept meters that are loose (unboxed). All meters must be submitted in boxes properly labeled with the location name.**

Please remember:

- Each location with one or more commercial sub-meters requires a separate application and fee. Registrations are not transferable from one person to another or from one location to another.
- Registrations not postmarked within 30 days of the due date will accrue penalties. A 50% penalty is applied to registrations for each 30 days of delinquency, up to 200%.
- All commercial utility sub-meters must be registered and sealed by the County Sealer before being used or placed into service.
- Replacement meters may be substituted during testing provided they are type-approved for commercial use and bear a valid County Weights and Measures Seal prior to installation.
- Submit at least 10% of each type of sub-meter (electric, vapor and water) annually to ensure all meters are tested at least once every ten years, unless other arrangements have been agreed to by the County Sealer.
- Please submit your meters according to the schedule on the reverse side. You will be notified to pick up the completed meters within 5 working days. Meters not claimed within 90 days of this notification may be subject to disposal as unclaimed property.

Example: Zip code 91932 is in Quarter 3. Please bring meters for testing between July and September.
4. Please label the meters with their installation location and bring them to:

For convenience, you may wish to contact other sub-metered properties within the same zip code and coordinate the transportation of the sub-meters in one vehicle. This may alleviate some unnecessary trips to our central testing facility.
