CERTIFIED PRODUCER (CP) CERTIFICATE APPLICATION

To participate in a certified farmers' market (CFM), a producer of fresh fruits, nuts, vegetables, shell eggs, honey, flowers, and nursery stock must obtain a Certified Producer Certificate (CPC) issued by the County Agricultural Commissioner (CAC). On-site inspections of the land controlled by the producers and verification of compliance with the requirements are conducted by the CAC. A CPC is valid for up to twelve months from the date of issue but no longer than the indicated expiration date on the certificate.

Forms and information for the completion of this application are attached.

ALL APPLICANTS SUBMIT:

- Completed and signed Application form.
- Application fees (see attached "Direct Marketing Fees") and for renewals any unpaid prior inspections fees. Method of payment:
 - Check or money order payable to: *County of San Diego*.
 - Cash, Visa or MasterCard (*walk-in only*)
- Commodities Worksheet. (Complete as best you can, inspector may assist at inspection.)

ADDITIONAL DOCUMENTS (submit when applicable):

- Authorization form(s) to sell on behalf of no more than two other CPs. (See attached "*Authorization To Sell*")
- Employee Agreement form. (Additional documentation of proof of employment status may be required.)
- Farm Leases: copy of current notarized agreement. (See attached "*Requirements for Farm Leases*")
- Partnerships, Sharecropping Agreements, and similar Contract Agreements:
 - Proof of partnership. (i.e. Federal Tax ID number)
 - Copy of current agreement. (See attached "*Requirements for Partnerships*")

RENEWALS:

- Submit application and fee 30 days prior to current CP certificate expiration date to avoid lapse. Extensions are not given.
- Certificate will only be renewed when all outstanding fees are paid in full.

PROCESSING:

- An Agricultural Inspector will schedule your property inspection once your application packet is reviewed and all fees are received.
- The CAC office will contact you when certificate is ready for your signature.
- The certificate is signed and embossed by CAC and then issued to you.

CERTIFIED PRODUCERS RESOURCES/INFORMATION

REGULATIONS (copies available by request):

Specific requirements for participation in a certified farmers' market are found in:

- California Food and Agricultural Code, Division 17, Chapter 10.5.
- California Code of Regulations, Title 3 commencing with Section 1392.
- California Retail Food Code, Chapter 12.

All agricultural products, when sold or offered for sale at a certified farmers' market, shall comply with all applicable laws and regulations.

ADDITIONAL INFORMATION:

- Scales used to sell any agricultural products by weight must be tested and sealed by a county sealer. Organic producers must be registered and certified (if sales are more than \$5,000/year) as required by the Food & Agricultural Code.
- Packaged commodities must be labeled with identity, responsibility, and quantity in accordance with the California Code of Regulations.
- Fresh fruits, nuts, and vegetables sold outside of the Certified Farmers' Market designated area must conform to size, standard pack, container, and labeling requirements pursuant to the Food and Agricultural Code.
- See attached "Self-Inspection Checklist" as a helpful guide to complying with CFM regulations.

REQUIREMENTS FOR FARM LEASES*

Every certified producer who grows on leased land must provide the CAC (County Agricultural Commissioner), **at the time of application**, with a copy of the current notarized written lease agreement which shall contain the following:

- ❑ A clear and concise accurate description of the lease property. The description shall include:
 - Present use of the property,
 - Dimensions,
 - Location, including the assessor's parcel number (APN).
- ❑ The cost of the lease.
- ❑ The beginning and ending dates of the lease.
- ❑ The date of the agreement.
- ❑ Signatures of all parties involved. A guarantee of the signatures on the agreement by a notary public executed at the time of signing by all parties.

To qualify for a certificate the producer who leases land shall:

- Assume all financial risks associated with producing agricultural products.
- Shall meet definitions of Food and Agricultural Code §47000.5.
- Enter into the agreement prior to planting of annual and biannual crops.
- Enter into the agreement prior to or within 30 days after preparing perennial field crops for the subsequent cropping pattern.
- Enter into the agreement prior to bloom of the tree and vine crops.
- Perform agricultural production upon the leased land.
- Provide additional documentation as required.*

Report any changes in lease immediately to the CAC. Changes in the terms of the lease agreement may invalidate a certified producer's certificate issued under such terms. Return all embossed certificate copies to the CAC when invalidated.

REQUIREMENTS FOR PARTNERSHIPS, SHARECROPPING, AND OTHER SIMILAR CONTRACTUAL AGREEMENTS**

Every certified producer that enters into a partnership or similar contractual agreement must provide the CAC (County Agricultural Commissioner), **at the time of application**, with a copy of the current notarized written agreement which shall contain the following:

- ❑ A clear and concise accurate description of the lease property. The description shall include:
 - Present use of the property used for practicing agricultural arts
 - Dimensions,
 - Location, including the assessor's parcel number (APN)
- ❑ A description of each party's financial and material input, and each party's involvement in the agricultural production (example: all parties have equitable responsibility).
- ❑ The date of the agreement.
- ❑ Signatures of all parties involved. A guarantee of the signatures on the agreement by a notary public executed at the time of signing by all parties.
- ❑ Statement of verification that the farm property is under exclusive control of the partnership.

To qualify for a certificate the producer who leases land shall:

- Enter into the agreement prior to planting of annual and biannual crops.
- Shall meet definitions of Food and Agricultural Code §47000.5.
- Enter into the agreement prior to or within 30 days after preparing perennial field crops for the subsequent cropping pattern.
- Enter into the agreement prior to bloom of the tree and vine crops.
- Perform agricultural production upon the leased land.
- Provide additional documentation as required.

Report any changes in agreement immediately to the CAC. Changes in the terms of the agreement may invalidate a certified producer's certificate issued under such terms. Return all embossed certificate copies to the CAC when invalidated.
