2018 Branch 2 & 3 Structural Pest Control Business Registration

News

Are your notifications up to date and correct? Be sure you are including all the required information to your customers PRIOR to the use of pesticides. This means including: 1) The pest to be controlled. 2) The name or active ingredient(s) of the pesticide to be used. 3) The required statement outlined in B&P 8538 (a)(3) and ensure ALL required contact telephone numbers are currently active and correct. 4) The date(s) and/or frequency of pesticide applications.

If you apply at a **Public School** or **Day Care Center** you MUST comply with **Healthy Schools Act (HSA)**. For more information regarding HSA, visit this website <http://apps.cdpr.ca.gov/schoolipm/> or contact us and ask to speak with a public agency inspector.

In 2017, with your help, our Department diverted over 6,000 pounds of **empty pesticide containers** from going into local landfills. These events are held three times a year in San Marcos. The next event will be on February 3, 2018. If you would like more information please call and ask to speak to a pesticide container recycling inspector or visit our website.

Reminder: you can now pay your registration fees online. Please see the enclosed flyer for step by step directions.

Save time! Save money! Over half of structural pest control businesses now use **CalAgPermits** to submit pesticide use reports saving time and effort. If you are not already using on-line reporting, give it a try. If you are a **dual licensed company**, be sure to report your usage under the appropriate license number; agricultural pesticides under your agricultural license number and structural pesticides, including second generation anticoagulant rodenticides, under your structural license number. Annual Registration Information

Structural Pest Control Operators must **register every calendar year** with the Agricultural Commissioner in all counties where they perform work. You must register **before** you advertise, solicit, or operate as a pest control business. The registration fee is **\$10.00** for a Branch 2 & 3 structural pest control business.
