News

There are recent changes to personal protective equipment (PPE) regulations regarding protective eyewear and chemical-resistant gloves. The changes are found in **Title 3 of the California Code of Regulations sections 6738.2 and 6738.3**. Visit our website at: www.sdcounty.ca.gov/awm/pesticides.html or contact your inspector to learn more about these regulations. These changes include:

- Protective eyewear needs to be ANSI Z87.1-2010 rated.
- Chemical resistant gloves must be 14 mils or thicker.

Save time! Save money! If you are using **CalAgPermits** to submit your use reports, you are no longer required to send us your structural stamps. You can now just enter the stamp number on the report page in CalAgPermits. Tutorials and staff are available to assist you. Your **email address** is more important than ever. Please be sure we have your current email address. Your email address allows us to communicate easily with you all year. We now record all of our inspections electronically. With **electronic inspection reports**, we email you a copy of the completed inspection form. Please use the space provided on your registration form to provide an email address where you would like inspection reports sent.

Annual Registration Information

Structural Pest Control Operators must **register every calendar year** with the Agricultural Commissioner in all counties where they perform work. If you advertise, solicit, or operate as a pest control business, you must register. The registration fee is **\$10.00** for a Branch 1 structural pest control business. There are three ways to register:

1. Completed San Diego County Agricultural Commissioner Branch 1 Structural Registration Form.
2. The Registration Fee (check or money order made out to "County of San Diego"). Follow the enclosed directions to pay online with Visa, MasterCard, Debit Card, Check, or a bank account.
