OVERVIEW:

The Public Authority Governing Body is asked to approve the recommended In-Home Supportive Services (IHSS) Public Authority administrative budget for Fiscal Year 2015-16 and direct the scheduling of related public hearings and budget deliberations.

FISCAL IMPACT:

Funding for operations in the amount of \$14,039,468 is based on Federal and State revenue, and Social Services Realignment revenue received by the Health and Human Services Agency. The recommended administrative budget is subject to the Governing Body's review and approval. Pursuant to Government Code § 29064, the recommended budget must be approved by June 30, 2015 for the purpose of having authority to spend until the budget is adopted. A resolution of adoption is expected to be before the Governing Body in August 2015.


