



Supporting Non-Profit Programs

Through the CECO Grant Allocation program, eligible non-profit organizations may apply for one-time funding of tangible item(s) that will enhance existing programs and/or develop new program(s) addressing diverse needs of the community. A group of CECO volunteers are tasked with assessment of all applications received and recommending selection of grant recipients to the CECO Board of Directors for approval.
