

NAME: **LAW LIBRARY BOARD OF TRUSTEES, SAN DIEGO COUNTY**

LEGAL AUTHORITY: Business and Professions Code Section 6300 and 6301.1 et seq. California Senate Bill 113 section (1)(a)

MEMBERS

APPOINTED BY: Judges of Superior Court to elect five of their number.
Board of Supervisors to appoint four attorneys, resident in the County, to serve overlapping three-year terms. At least one attorney shall be a member of the San Diego County Bar Association.
Law Library Director serves as non-voting Secretary to the Board.

MEMBERSHIP COMPOSITION:

As above.

TERMS:

The Board of Supervisors shall in January of 1997, appoint one attorney to a one-year term, one attorney to a two-year term, and one attorney to a three-year term; and as each term expires, the new appointee shall thereafter serve three-year terms.

Appointments of trustees made by Judges are for three year terms.

Terms should start on January 1st of each year.

Terms end on December 31st after 3 years.
