The requested Abatement Order is not intended to act as a Variance. The Proposed Abatement Order applies to the installation, repair, maintenance, and testing of gasoline vapor recovery equipment in San Diego County, and requires Respondents to either cease operations or obtain vapor recovery certifications, provide advance notification of installations, report all repairs or testing, have proper testing equipment onsite, and comply with District Rules 21, 61.3.1, and 61.4.1 for a period of 3 years.
