The District alleges that Respondents have installed an emergency standby diesel engine without District authority, have operated the engine during school hours for non-emergency purposes when King Chavez High School is in session, and have operated a boiler without District authority, and seeks an Abatement Order prohibiting installation and operation of the engine and boiler without authority from the District and from operating the engine for non-emergency purposes during school hours when King Chavez High School is in session.
