

**ADMINISTRATIVE CODE**

AN ORDINANCE AMENDING SECTION 820.10 OF THE ADMINISTRATIVE CODE

The Board of Supervisors of the County of San Diego ordains as follows:

**Section 1.** Section 31.203 of the Administrative Code is hereby added to read as follows:

**SEC. 31.203. VOLUNTEER RESERVE FIREFIGHTER STIPEND.**

- (a) Persons serving as Volunteer Reserve Firefighters for the San Diego County Fire Authority, shall be paid a stipend allowance to offset the costs these volunteers may incur for each shift worked. The allowance is meant to reimburse the volunteers for expenses related to travel, food, equipment and training related to the preparation for and provision of firefighting services. The allowance also provides a nominal stipend based upon the position assigned.
- (b) Stipend Amounts. Specific stipend amounts are listed by Volunteer Reserve Firefighter assignments:

<u>Assignment</u>	<u>Stipend Amount</u>
Volunteer Reserve Fire Apparatus Engineer	\$145.00
Senior Level Volunteer Reserve Firefighter	\$130.00
Journey Level Volunteer Reserve Firefighter	\$110.00
Entry Level Volunteer Reserve Firefighter	\$95.00

**Section 2.** Section 820.10 of the Administrative Code is hereby amended to read as follows:

**SEC. 820.10. STAFF ASSISTANCE.**

The Director of the Health and Human Services Agency shall provide staff assistance to the Council, with the County Military and Veterans Affairs Officer acting as an ex officio, nonvoting member of the Council.

**Section 3.** Amendments to this code shall take effect thirty (30) days after its adoption. Within fifteen days after the date of adoption of this ordinance, a summary shall be published once with the name of those members voting for and against the same in the newspaper of general circulation published in the County of San Diego.

**Section 4.** Operative Date. Operative dates by specified section are listed in the table below.


