The County of San Diego Department of Environmental Health Solid Waste Local Enforcement Agency (LEA) received and has accepted for filing an application package for a revision to the Solid Waste Facility Permit (SWFP) for Escondido Resource Recovery. The LEA is certified by the California Department of Resources Recycling and Recovery to enforce state laws and regulations at solid waste facilities within the County of San Diego excluding the City of San Diego.

<u>Description of Proposed Permit:</u> The operator has submitted an application package to consolidate its existing Escondido Resource Recovery (ERR) and SANCO Recycling transfer processing stations into the ERR SWFP; increasing the overall operational area from 53,285 square feet to 216,476 square feet, incorporate a self-haul construction demolition and inert debris processing operation, a mixed waste processing operation and an anaerobic digestion operation, increase the design capacity from 5,249 tons per day to 8,743 tons per day, increase the permitted daily tonnage from 2,500 tons per day to 3,223 tons per day (which is the existing ERR and SANCO Recycling transfer

processing stations combined permitted tonnage) and expand the current perimeter boundary from 5.97 acres to 11.1 acres. The days and hours of operation will remain Sunday – Saturday, 24 hours a day. ERR has been operating as a transfer station since 1997 and SANCO Recycling has been operating as a material processing facility since 2004.

<u>LEA Findings per §21660.3:</u> The LEA's preliminary determination pursuant to Title 27, California Code of Regulations, §21665 is that the proposed changes are a significant change and requires a revised SWFP.
