Please be advised that the County of San Diego Department of Environmental Health Solid Waste Local Enforcement Agency received and has accepted for filing an application package for a modified Solid Waste Facility Permit for the Las Pulgas Landfill. The LEA is certified by the California Department of Resources Recycling and Recovery to enforce state laws and regulations at solid waste facilities within the County of San Diego, excluding the City of San Diego.

<u>Description of Proposed Permit:</u> The operator has submitted an application package to modify the Solid Waste Facility Permit (SWFP). The proposed SWFP modification will: update the SWFP to reflect Remaining Capacity and estimated Closure Date; provide current references to supporting documents; update LEA findings; and amend the Joint Technical Document. The permit modification will not result in an increase to operating hours or permitted daily tonnage.

LEA Findings per §21660.3: The LEA has reviewed and considered the information, including the environmental effects of issuing this Solid Waste Facility Permit, for the Las Pulgas Landfill. An Environmental Impact Report (July 2002) has been filed by Camp Pendleton with the State Clearinghouse. Camp Pendleton issued a Decision Memorandum on July 9, 2015 that the proposed changes qualify as a Categorical Exclusion. A Notice of Exemption will be filed by the LEA with the State Clearinghouse for the updates discussed in this Notice. The exemption proposed is a categorical exemption under CEQA Guidelines, Article 18 § 15301 Existing Facilities which is applicable as this action consists of updating permitting conditions and some exterior alterations but involves no expansion of an existing use.
