I am writing on behalf of Laborers International Union of North America, Local Union 89, and its members living in San Diego County ("LiUNA" or "Commenters") regarding the Notice of Preparation of Environmental Impact Report ("NOP") for the Soitec Solar Development Program, comprised of four project sites (Rugged, Tierra Del Sol, LanEast and LanWest) totaling approximately 1,473 acres within the Mountain Empire Subregional Plan area in unincorporated San Diego County with an estimated electrical generation capacity of 168.5 megawatts (SCH No. 2012121018), 3800 12-010 (GPA); LOG NO. 3910-120005 (ER); TIERRA DEL SOL, 3300 12-010 (MUP), 3600 12-005 (REZ), 3921 77-046-01 (AP); RUGGED SOLAR, 3300 12-007 (MUP); LANWEST 3300 12-002 (MUP) ("**Soitec Project**").

LiUNA hereby requests and urges the County of San Diego ("County") to fully comply with the California Environmental Quality Act ("CEQA"), Public Resources Code § 21000 et seq., in all aspects of the Soitec Project, including but not limited to, County preparation and consideration of any and all CEQA documents prepared for the Project, including the Draft Environmental Impact Report ("Draft EIR"), Final EIR, and any other CEQA documents prepared for the Soitec Project, County responses to any and all comments submitted by responsible agencies, members of the public, or others on the Soitec Project, and County consideration of any and all applications for licenses, permits, or any other notices or approvals sought for the Soitec Project.

LiUNA expressly reserves the right to submit additional comments on the Soitec Project in conjunction with both the Draft EIR and Final EIR for the Project or any other future actions taken with regard to the Project.


