I've reviewed both the studies and have one minor outstanding comment. The SDG&E emission factor calculation that is included in the Tierra Del Sol study on Page 34 (calculation estimating the 1.071 lb/kWh) needs to be included in the Rugged Study in a location where GHGs offset by the project are discussed. Other than that, the studies are ready to be submitted to ARB.

Also, the pdf version of the GHG Study sent for Rugged did not include the appendix. I'm not sure if that was intentional but please ensure that the appendix is included when forwarding to ARB.

Also, I have accepted a new job but I'm not leaving the County. So you don't have to worry!
