Dear Mr. Hudson:


Our organization has sent two separate Public Record's Act requests to yourself, referenced above. We have yet received no records requested in our first request and only a partial compliance with our second request.

Our interest is in how and why the solar energy project on Mt. View Road in this community came to be blighted by about 20 acres of 27-foot-tall solar panels in the midst of a residential area. The original application for said project stipulated panel height of about seven feet. But they were constructed as 27 feet tall, and some of the original conditions of approval seem to have disappeared.

Our public records act request has been handled, to the extent that it has been handled, apparently at your direction, by Supervising Planner, Dave Prusch. I spoke today with Mr. Prusch, and was not encouraged by his comments.

Please comply with the law without further delay.
