
**Update on Community Dialogues on Child Abuse Prevention**

- *The CAPCC and Child Welfare Services have partnered with Strategies and the San Diego Family Strengthening Network to bring Community Prevention dialogues to San Diego County regions. The input from the community partners will be used to develop an integrated Community Prevention Framework for San Diego County.*
- *The first round of dialogues focused on providers, frontline workers, program managers and directors providing services. We had a great turnout, over a hundred people attended.*

**VII. Public Forum**

**Presentation and Facilitated Discussion:  
*The Children's Bureau – Strategies***

- **Summary of findings and overall feedback received at the recent community dialogues throughout the County**
- *Booklet was distributed.*
- *Presentation by Lori Clarke, Strategies' Quality Assurance Specialist. Strategies is funded by the Office of Child Abuse Prevention, California Department of Social Services.*
- *Dialogues were framed to explore the possibilities for prevention. What is a community prevention framework? It has been planned for a while, reflected in our County System Improvement Plan. It is a strategic plan that captures what we plan to do to improve services and outcomes for children and families. It gives us an opportunity to come together for greater accountability and collective impact.*
- *Building blocks: creating a common language, shared approach, shared outcomes*
- *To support the federal child welfare outcomes of Safety, Permanence, Child and Family Well-Being*

- *Prevention framework will be integrated into the County's Live Well San Diego initiative, and Child Welfare Safety Enhanced Together Practice Framework*
- *Strengthening Families is an evidence-based framework for child abuse prevention, implemented statewide: Parent Partnership, Professional Development, Policy/Systems Change; Protective Factors Framework; Implementation Science*
- *Looking at trends in national and statewide child abuse prevention gives us an opportunity to evaluate where we need to do something unique and adapted to San Diego County.*
- *Eight Dialogues/Conversation Cafés have been held in different San Diego County regions. There were lots of unique, unduplicated ideas and also trends that we heard over and over again across the Dialogues.*
- *First question asked, "What does child abuse prevention mean to you?" Feedback is that child abuse prevention is family and community strengthening.*
- *What's the role of the community in preventing child abuse and neglect? It is a shared responsibility. It is a geographic place/neighborhood, or any connection (social media), and nurturing those common bond and connections that link people.*
- *Issues: childcare and transportation*
- *Comments: availability/access to resources are different in communities; inherent inequalities; different approaches and beliefs; cultural differences; there isn't one approach that will work for everyone.*
- *"The horizon leans forward offering you space to place new steps of changes" ~ Maya Angelu*
- *Next steps – convene Dialogues with the Indian Health Council and military family collaborative*
