## Dear Supervisor Jacob:

As required by Senate Bill 621 (Battin), the two sovereign nations of Barona and Sycuan are honored to submit this letter as an endorsement for various projects that qualify for funding under this provision. As you are aware, SB 621 was enacted in 2003 to provide a framework for local communities and contributing tribes to allocate resources from the Special Distribution Fund (SDF). In 2008, AB 158 (Torrico) updated the statute. The SDF was established pursuant to tribal-state gaming compacts. In San Diego County, the SDF is funded by our two Tribal Governments. Taking into account the needs of our local communities and the recommendations of the Indian Gaming Local Community Benefit Committee, we have chosen to sponsor the following applications in the amounts stated:

Alpine Fire #1: Fuel Reduction and Public Education - \$2,960.64

County #2: HHSA - Aging and Independence Services (partial funding) - \$250,000.00

County #3: County Fire Authority - Type III Brush Fire Engine - \$225,000.00

County #4: Dept. of Parks and Recreation - Louis Stelzer Park Operations - \$9,597.00

Grossmont #5: Grossmont Hospital Heart and Cardiovascular Center - \$250,000.00

NC Fire #16: Highway 76 Emergency Vehicle Preemption Project - \$11,899.30

Ramona Fire # 17: Ramona Fire Dept. - Cardiac Monitor/Defibrillator Purchase - \$70,089.00

County #18: Sheriff Dept. - Law Enforcement on Tribal Lands Training - \$86,883.87

San Miguel #19: Type I Fire Apparatus Replacement (partial funding) - \$62,401.34

Yuima #23: Vuima MWD - Fire Protection Services - "Joves of Life" - \$22,000.00

Yuima #23: Yuima MWD - Fire Protection Services - "Jaws of Life" - \$32,000.00

TOTAL: \$1,633,178.20
