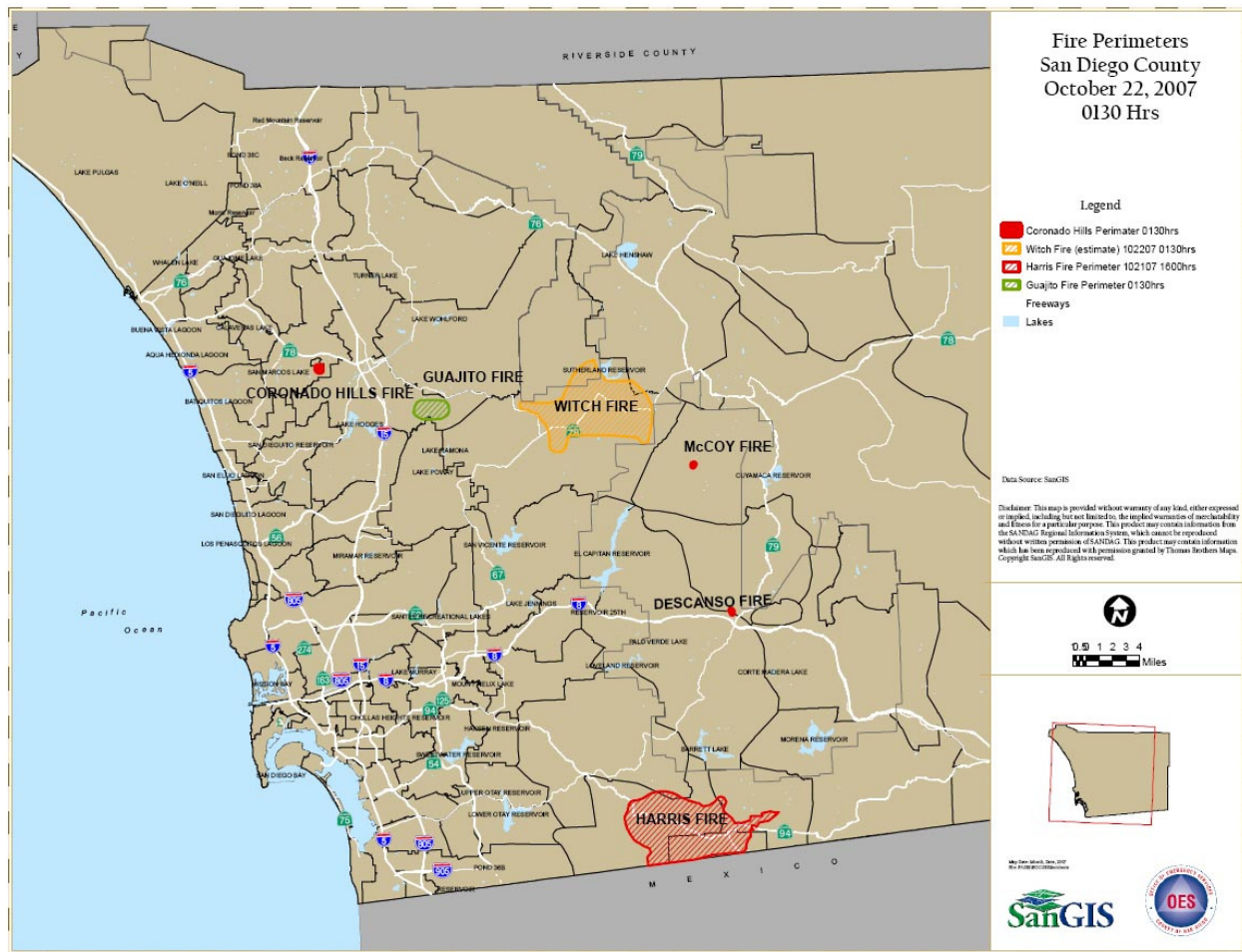

October 22, 2007: 0130 PST

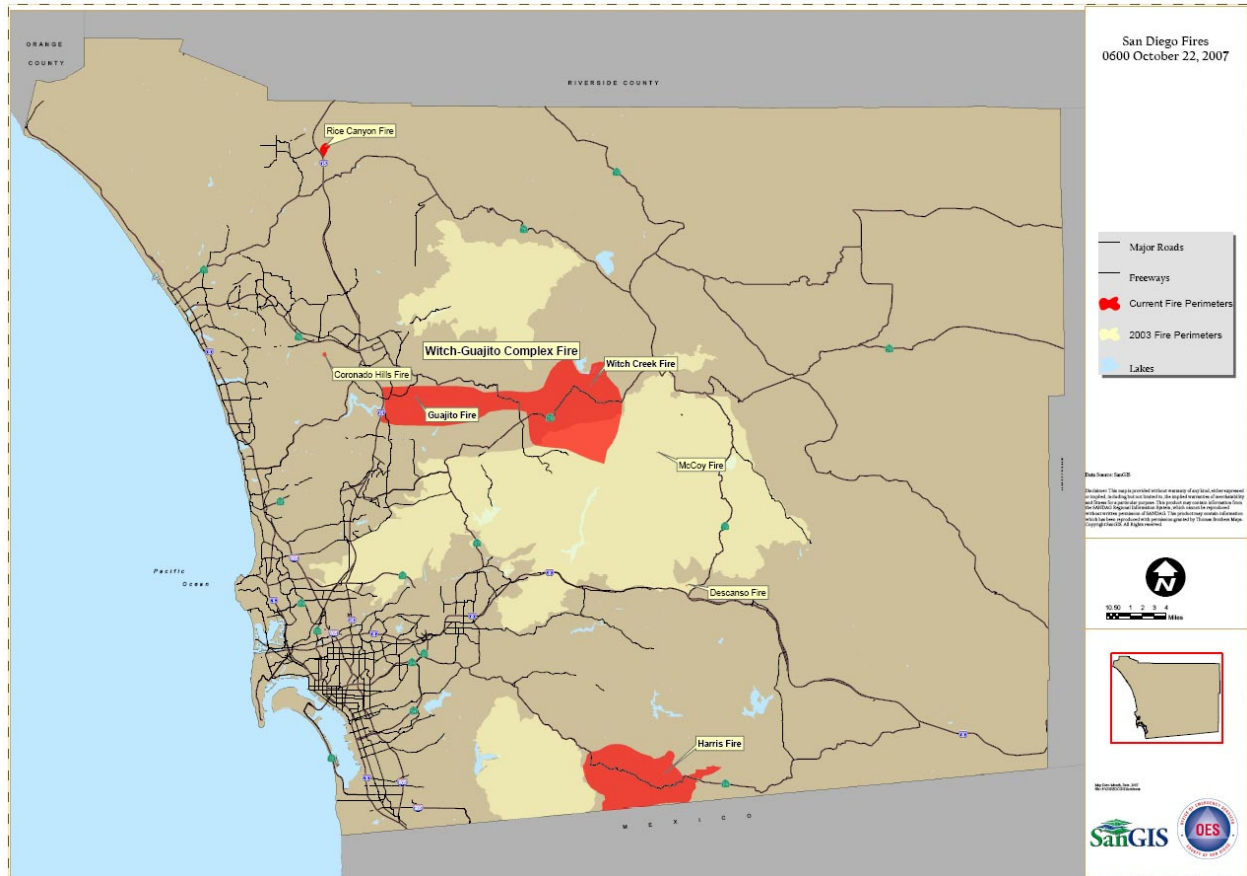

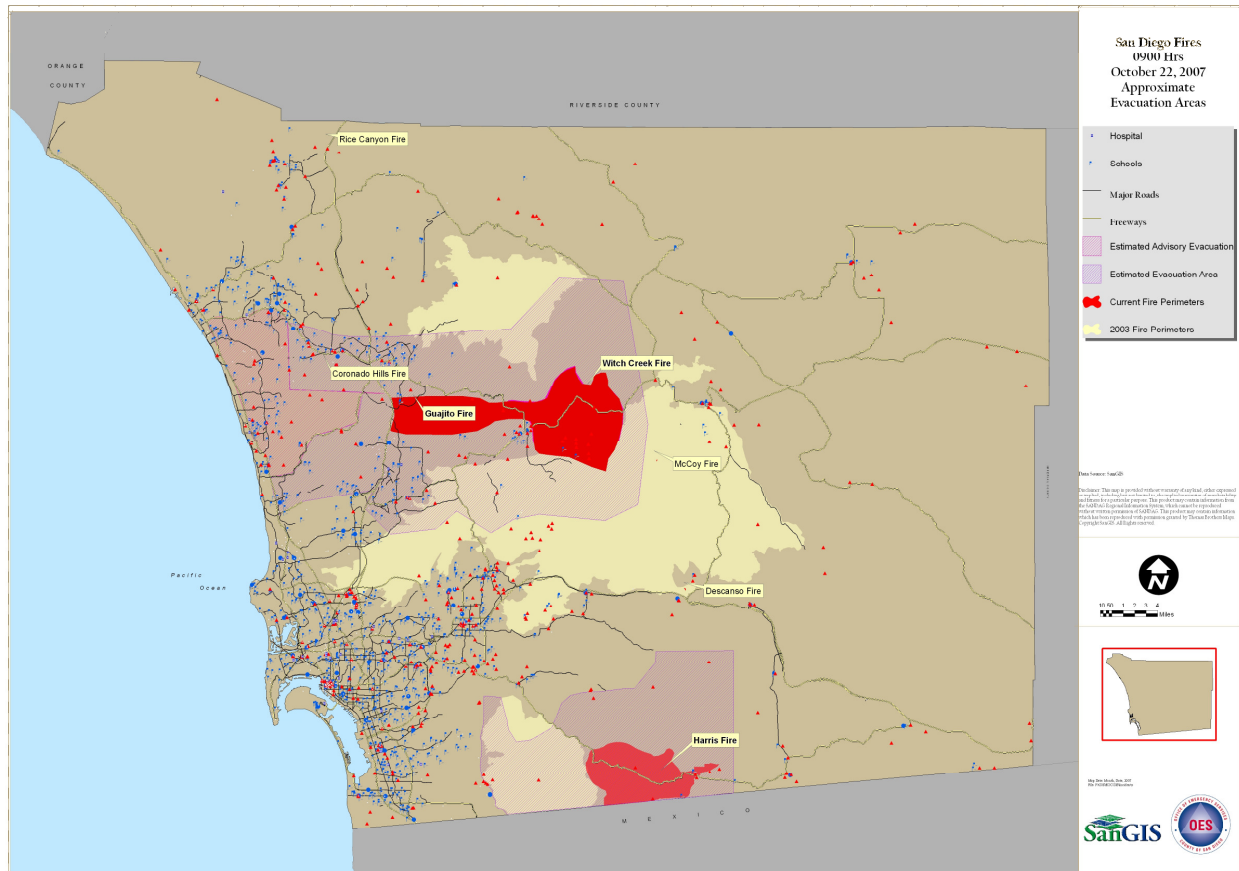

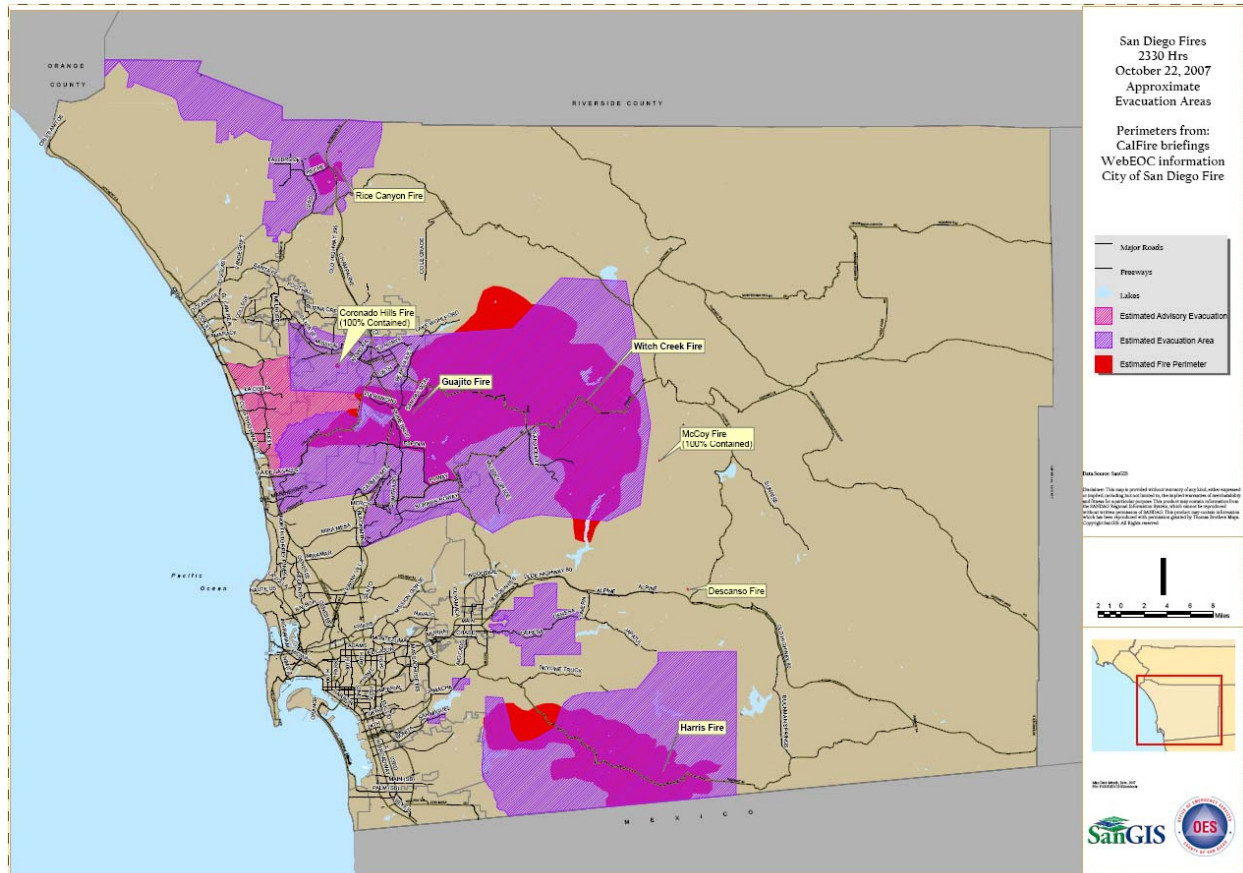

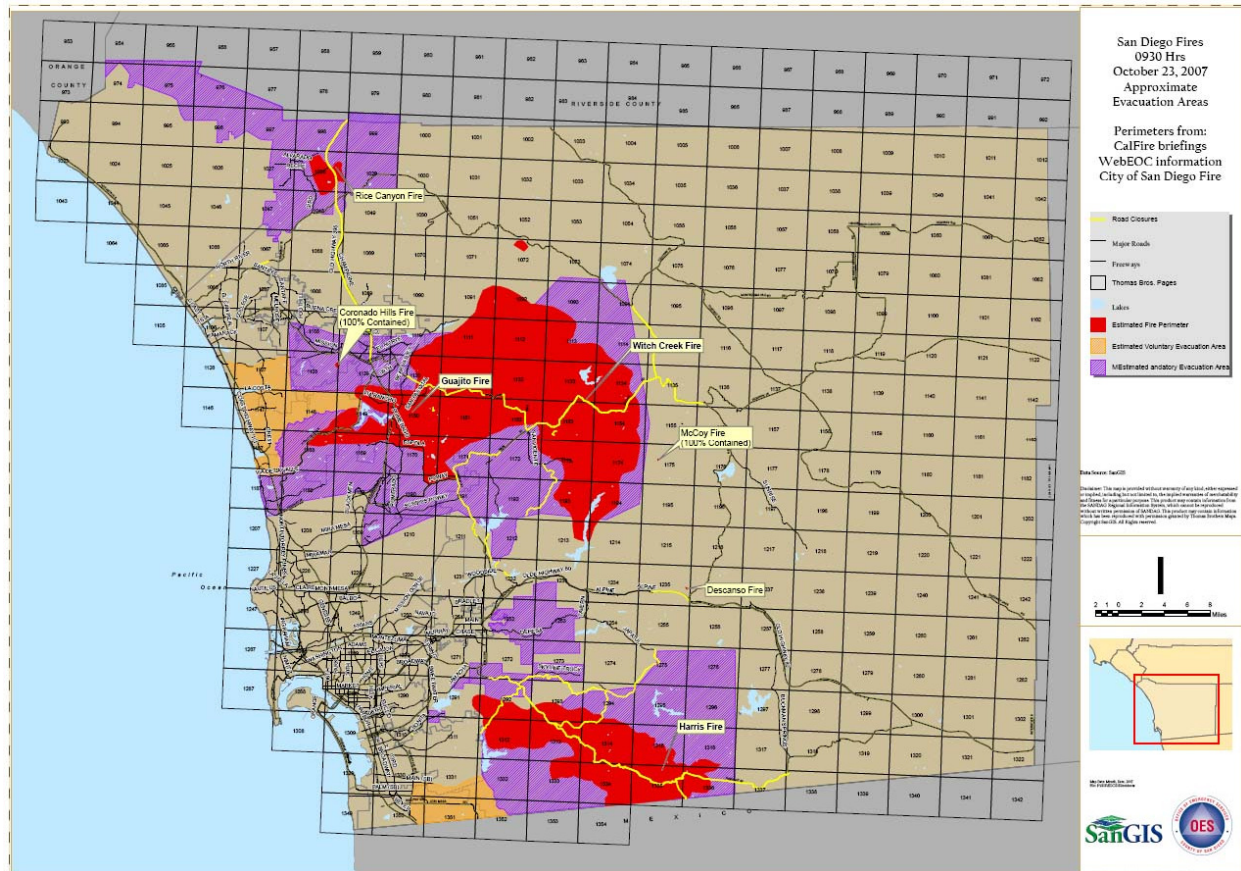

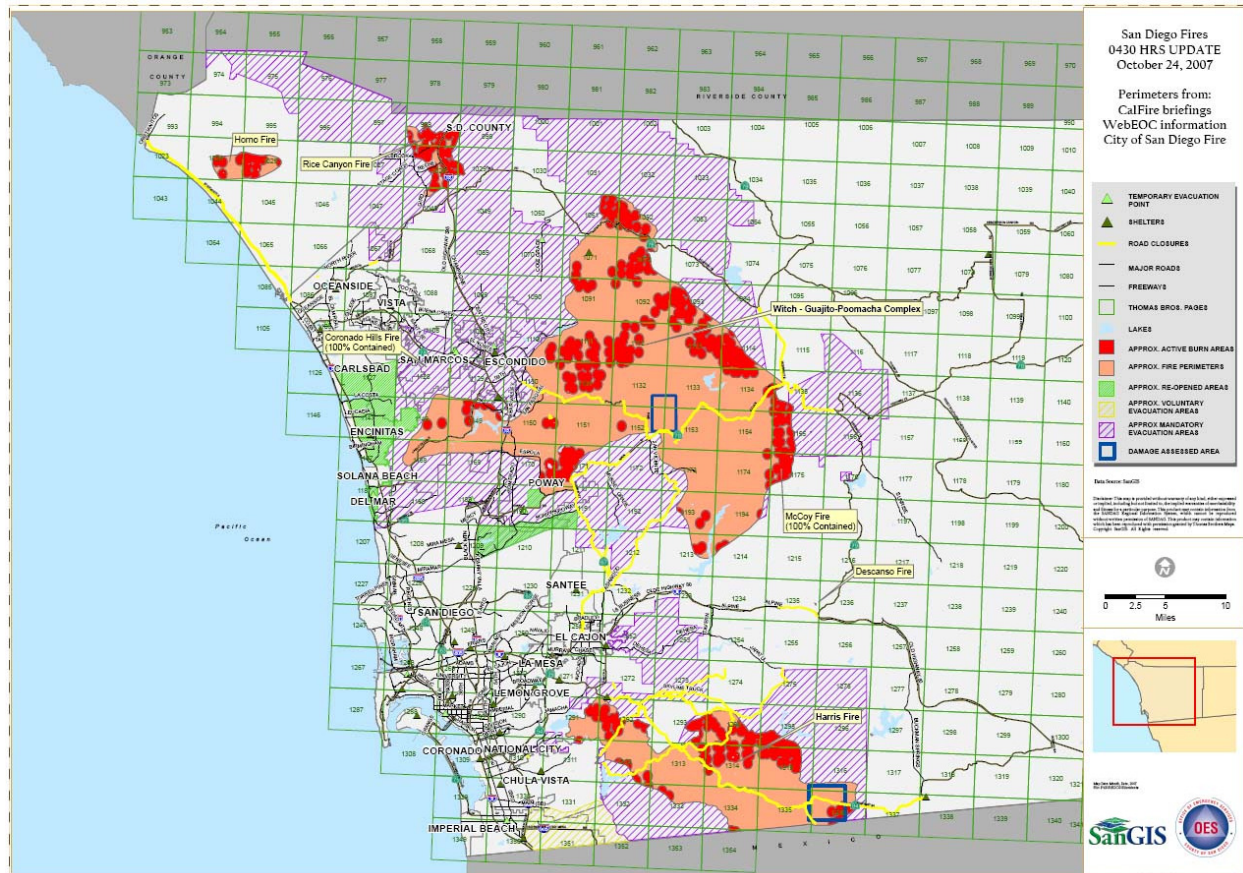

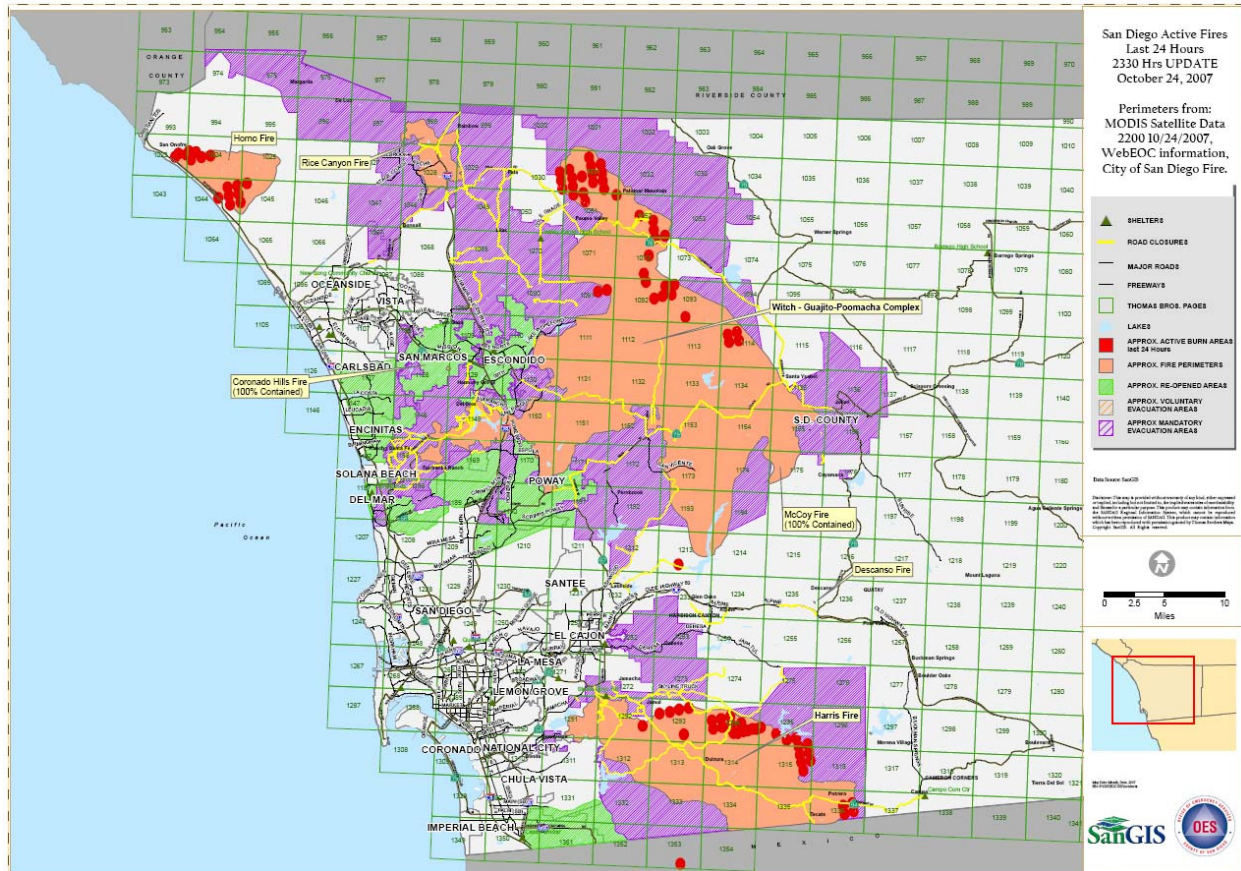

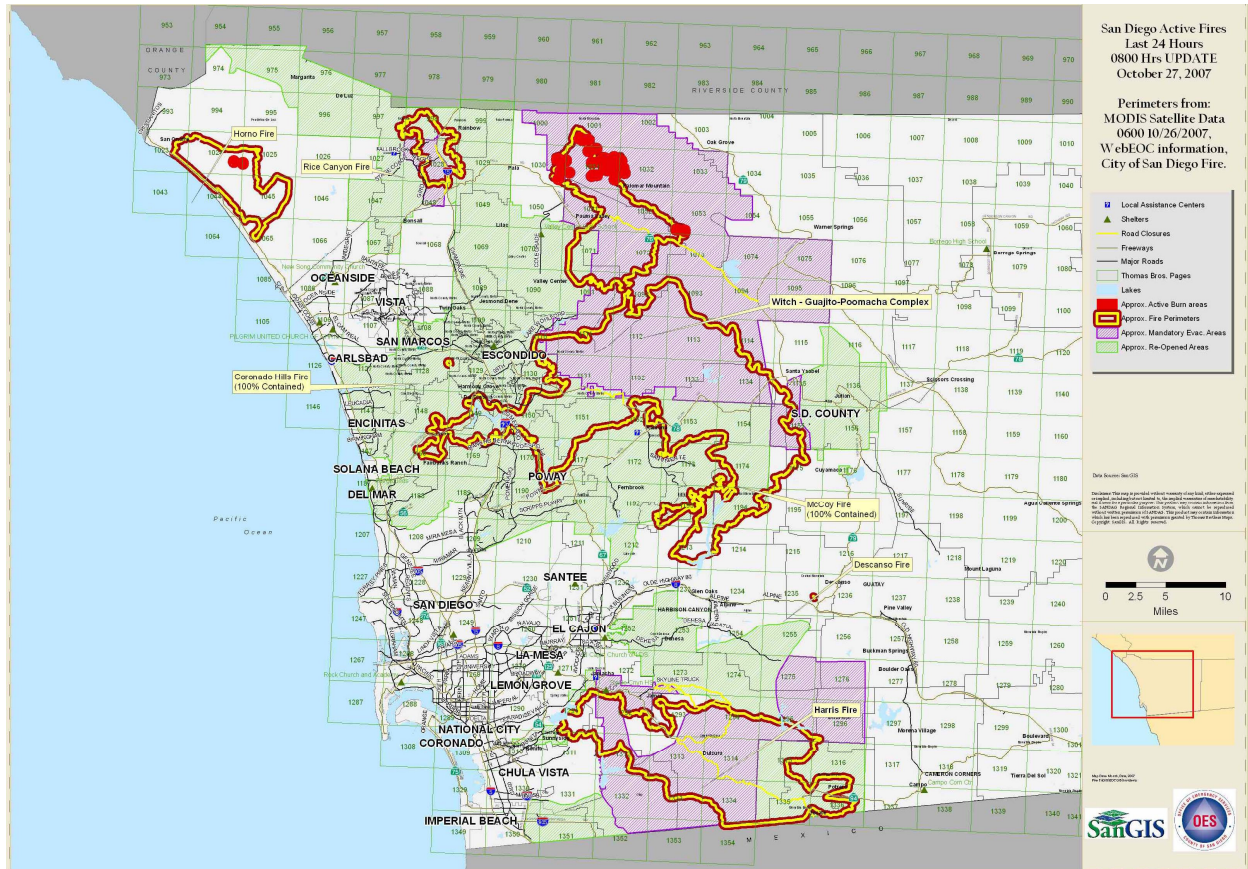

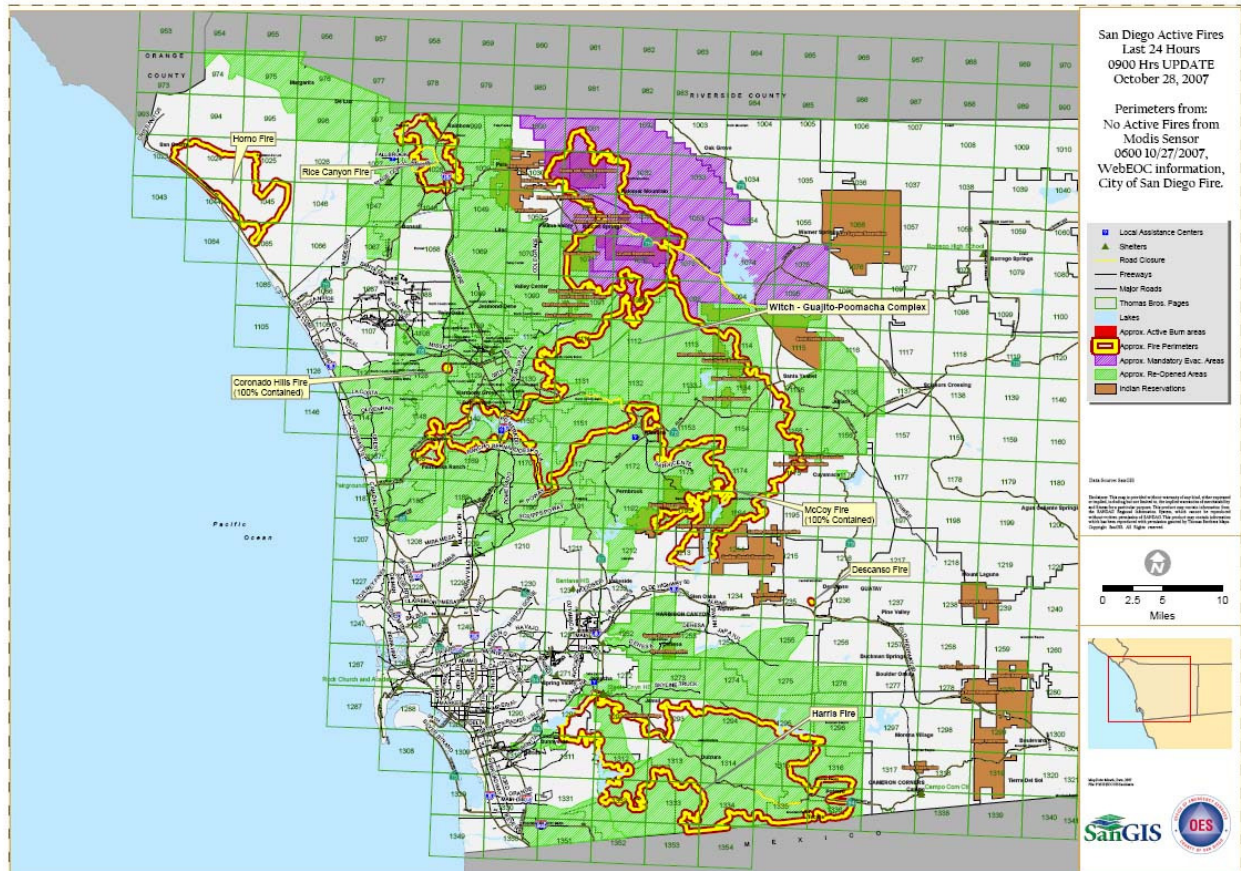

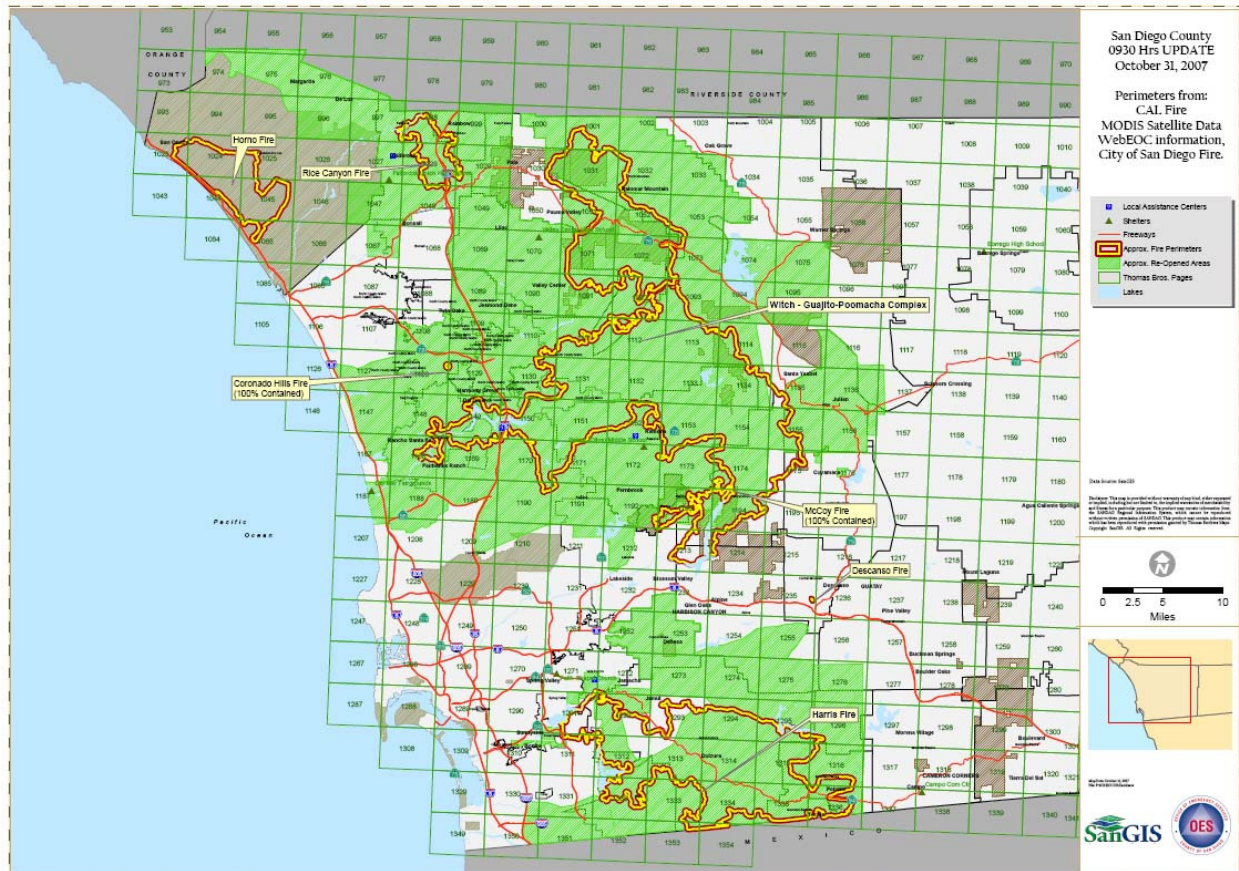

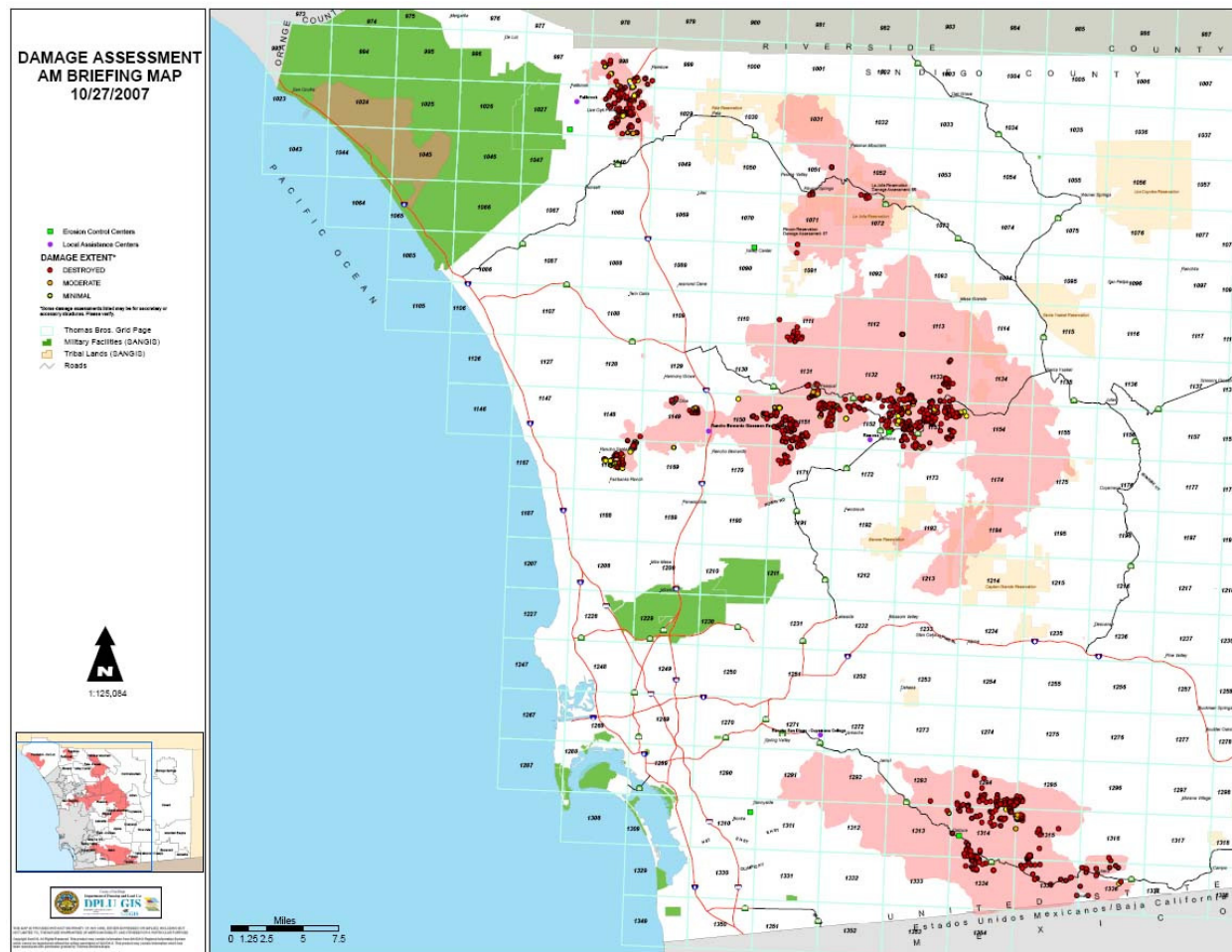

APPENDIX C: DECLARATIONS AND PROCLAMATIONS

Below is the proclamation issued by San Diego County in response to the 2007 San Diego County Firestorms:

PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY AND RESOLUTION REQUESTING GOVERNOR TO PROCLAIM A STATE OF EMERGENCY

WHEREAS, Ordinance No. 8183 of the County of San Diego empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said County is affected or likely to be affected by a public calamity and the Board of Supervisors is not in session; and

WHEREAS, the Director of Emergency Services of the County of San Diego does hereby find that on October 21, 2007 conditions of extreme peril to the safety of persons and property have arisen within this County, caused by two fires that began on the 21st day of October, 2007: the Harris Fire in South County commencing at approximately 9:45 a.m. and the Ramona Highway 78 Fire in East County commencing at approximately 12:50 p.m.; and

WHEREAS, the Board of Supervisors of the County of San Diego is not in session and cannot immediately be called into session; and

WHEREAS, this Proclamation of Local Emergency will be ratified by the Board of Supervisors within seven days of being issued; and

WHEREAS, the Director of Emergency Services finds that these emergency conditions are beyond the control of local resources, services, personnel, equipment and facilities;

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED by the Director of Emergency Services of the County of San Diego that a local emergency exists throughout San Diego County pursuant to government Code, Section 8558, and shall be deemed to continue to exist for fourteen days or until its termination is proclaimed by the Board of Supervisors; and

IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this county shall be those prescribed by State law, ordinances, and resolutions of the County, and by the County of San Diego Emergency Plan, as approved by the Board of Supervisors in September, 2006.

IT IS FURTHER ORDERED that a copy of this proclamation be forwarded to the Governor of California with the request that he proclaim San Diego County to be in a State of Emergency and further that the Governor request a Presidential Declaration.

IT IS FURTHER RESOLVED that Walter F. Ekard, Chief Administrative Officer, or his representative is hereby designated as the authorized representative of the County of San Diego for the purpose of receipt, processing, and coordination of all inquiries and requirements necessary to obtain available state and federal assistance.

**SUBJECT: OFF-AGENDA CONSIDERATION #1:
RATIFY PROCLAMATION OF LOCAL EMERGENCY:
OCTOBER 2007 FIRESTORM (DISTRICTS: ALL)**

OVERVIEW:

On October 21, 2007, the Chief Administrative Officer, serving as the County's Director of Emergency Services and as Coordinator of the Unified San Diego County Emergency Services Organization, issued a Proclamation of Local Emergency as a result of the Harris Fire in the southern portion of the County and the Ramona Highway 78 Fire in the eastern portion of the County. San Diego County Ordinance No. 8183 (County Regulatory Code Ordinances sections 31.101 et seq.) and California Government Code Section 8630(b) require that the Board of Supervisors ratify Proclamations of Local Emergency within seven days of being issued. This is additionally a request to establish appropriations in the Office of Emergency Services for the first costs related to the initial response and recovery efforts associated with Firestorm 2007.

FISCAL IMPACT:

The funds for this request are available in the County's Contingency Reserve. If approved, this request will result in up to \$3 million in initial costs related to the response to and recovery from the October 2007 Firestorm.

RECOMMENDATION:

CHIEF ADMINISTRATIVE OFFICER

1. Ratify the attached Proclamation of Local Emergency made by the Chief Administrative Officer on October 21, 2007.
2. Find that there is a need for continuing the local emergency until no longer needed, subject to Government Code 8630(c) review requirements.
3. Transfer appropriations of \$3 million from the General Fund Contingency Reserve to the Office of Emergency Services for the costs related to the initial response and recovery efforts associated with the October 2007 Firestorm. **(4 VOTES)**

25.1 ACTION:

PROCLAMATION OF EXISTENCE OF A LOCAL EMERGENCY AND RESOLUTION REQUESTING GOVERNOR TO PROCLAIM A STATE OF EMERGENCY

WHEREAS, Ordinance No. 8183 of the County of San Diego empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency when said County is affected or likely to be affected by a public calamity and the Board of Supervisors is not in session; and

WHEREAS, the Director of Emergency Services of the County of San Diego does hereby find that on October 21, 2007 conditions of extreme peril to the safety of persons and property have arisen within the County of San Diego, caused by several fires, the first two of which commenced on October 21, 2007, at approximately 9:45 a.m. The fires consist of the Harris, Witch, Rice, Poomacha, Coronado Hills, Guajito, McCoy, and Horno Fires and;

WHEREAS, the Board of Supervisors of the County of San Diego is not in session and cannot immediately be called into session; and

WHEREAS, this Proclamation of Local Emergency will be ratified by the Board of Supervisors within seven days of being issued; and

WHEREAS, the Director of Emergency Services finds that these emergency conditions are beyond the control of local resources, services, personnel, equipment and facilities;

NOW, THEREFORE, IT IS HEREBY PROCLAIMED AND ORDERED by the Director of Emergency Services of the County of San Diego that a local emergency exists throughout San Diego County pursuant to government Code, Section 8558, and shall be deemed to continue to exist for fourteen days or until its termination is proclaimed by the Board of Supervisors; and

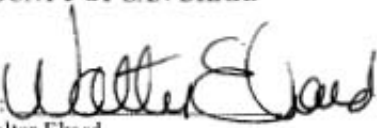
IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of said local emergency the powers, functions, and duties of the emergency organization of this county shall be those prescribed by State law, ordinances, and resolutions of the County, and by the County of San Diego Emergency Plan, as approved by the Board of Supervisors in September, 2006.

On October 21, 2007, the Chief Administrative Officer, acting as Director of Emergency Services for the County of San Diego and as Coordinator of the Unified San Diego County Emergency Services Organization, issued a Proclamation of Local Emergency as a result of multiple wildfires in San Diego County. Overview

On October 21, 2007, the Chief Administrative Officer, serving as the County's Director of Emergency Services and as Coordinator of the Unified San Diego County Emergency Services Organization, issued a Proclamation of Local Emergency as a result of the Harris Fire in the southern portion of the County and the Ramona Highway 78 Fire in the eastern portion of the County. San Diego County Ordinance No. 8183 (County Regulatory Code Ordinances sections 31.101 et seq.) and California Government Code Section 8630(b) require that the Board of Supervisors ratify Proclamations of Local Emergency within seven days of being issued. This is additionally a request to establish appropriations in the Office of Emergency Services for the first costs related to the initial response and recovery efforts associated with Firestorm 2007.

BACKGROUND:

Commencing on October 21, 2007 two fires broke out in San Diego County, one in the southern portion of the county near Potrero and the other in the eastern section of the County near Ramona. Due to extreme Santa Ana conditions, characterized by fierce wind gusts and low humidity, these fires quickly began to burn out of control. As of 11:00 p.m. on October 21, 2007 the Harris Fire and the Ramona Highway 78 Fire were both burning out of control encompassing more than 20,000 acres. The fires also burned at least 12 structures, caused injuries to at least nine individuals, including firefighters, and claimed the life of one individual.

On October 21, 2007 at 2:46 p.m. the Chief Administrative Officer, acting as the County Director of Emergency Services and Coordinator of the Unified San Diego County Emergency Services Organization issued a Proclamation of Local Emergency as a result of the Harris Fire and the Ramona Highway 78 Fire. Included in the County's Proclamation of a Local Emergency is a request for Governor's Proclamation as well as a request for a Presidential Declaration that an emergency exists in San Diego County. Under San Diego County Ordinance No. 8183 (County Regulatory Ordinances section 31.101 et seq.) and the 5th Amended Emergency Services Agreement, the Director of Emergency Services/Coordinator of the Unified San Diego County Emergency Services Organization is empowered to proclaim a local emergency when the Board of Supervisors is not in session. The extreme weather conditions and fast-moving fires warranted a proclamation of a local emergency. A copy of the proclamation was forwarded to the Governor's Office at 5:49 p.m. on October 21. However, California Government Code Section 8630(b) requires that the governing board ratify the proclamation with seven days. Section 8630(c) further requires review of the state of emergency at subsequent Board meetings until the state of emergency is terminated.

The Board's ratification of the Proclamation of Local Emergency will:

- Give public employees, the County, Cities and Special Districts legal immunities for emergency actions taken.
- Enable the County and other local governments to request State and Federal assistance under the State and Federal Disaster Assistance Programs if State and Federal Proclamations are issued.
- Allow the Chief Administrative Officer (or authorized official) to take preventive measures necessary to protect and preserve public health and safety.

On October 21, 2007, the Governor proclaimed a State of Emergency in San Diego County. The Presidential Declaration of Emergency is pending upon the writing of this document. The County's Emergency Operations Center has been on continuous activation since October 21st. The County continues to deploy resources to the emergency response for evacuation and resident safety and will begin to move toward the recovery phase of the disaster. In that phase the County will establish and equip Local Assistance Centers to assist in the Recovery. It will also be necessary to acquire equipment, supplies and services to be used for the initial phase of debris removal and soil erosion control. To begin to respond to the needs of the residents of San Diego County during and following this emergency, these initial funds of \$3 million are requested. This action provides only initial funding. As the extent of the disaster is determined, additional resources may be necessary. As detailed assessments and cost estimates are developed, we will return to your Board to allocate additional funding.

Linkage to the County of San Diego Strategic Plan

This recommendation supports the Safe and Livable Communities Initiative and the Regional Leadership required discipline of the County's Strategic Plan.

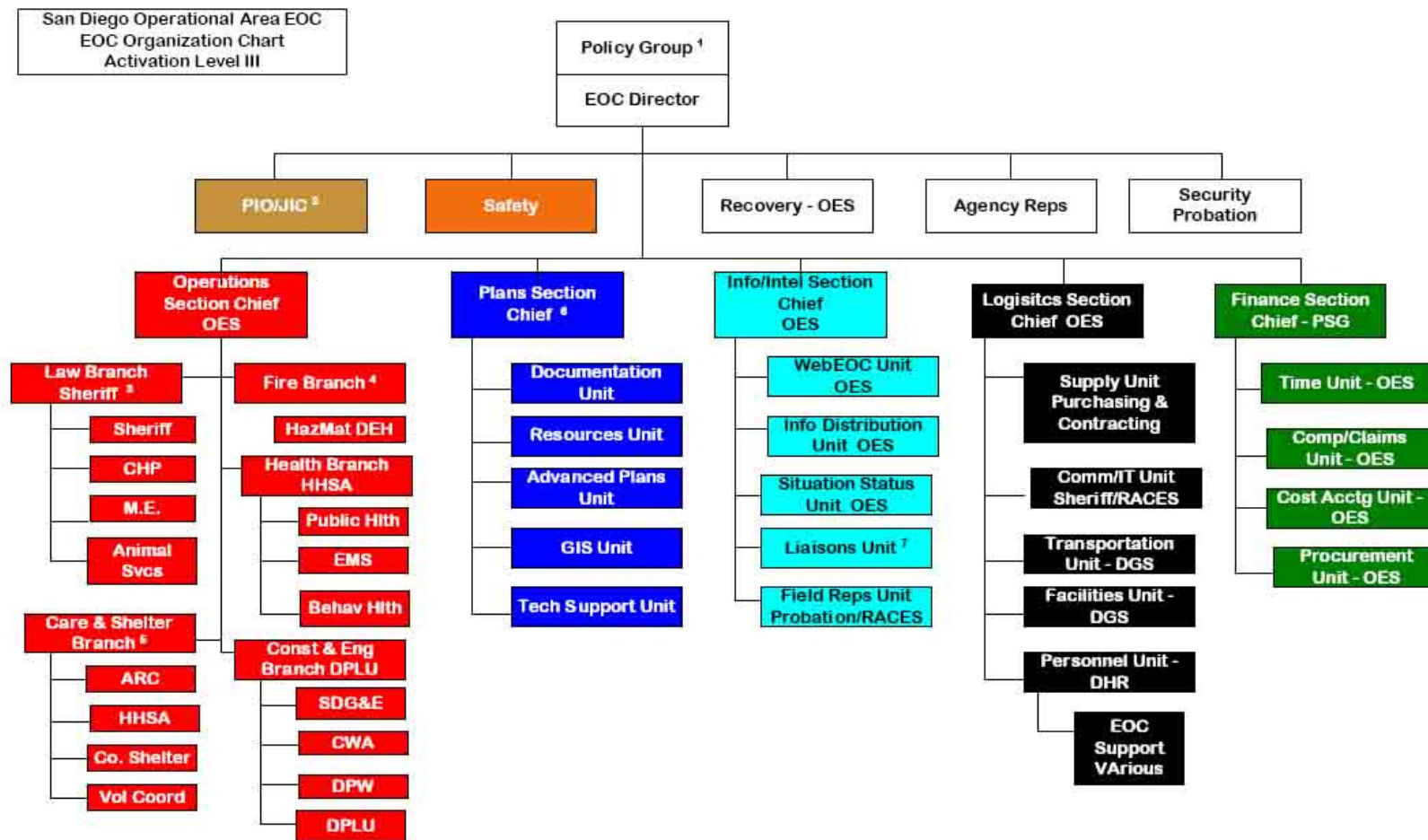
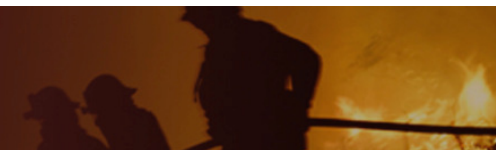
APPENDIX D: OAEOC ORGANIZATION CHART – LEVEL 3 ACTIVATION
