 - B. **SDG&E Re-conductor of Boulder Creek Transmission Line:** San Diego Gas & Electric (SDG&E) is replacing wood poles with steel poles in high fire risk areas of the county. Don Parent notified chair about a project starting up this week to re-conductor a line between the Descanso Substation north (about eight miles) toward Santa Ysabel. This line is one that is part of the wood to steel project mentioned in my earlier note about our eventual work in the Cleveland National Forest. However, this current project is being done as a regular maintenance job and is only to replace the conductors at this time and not the poles. It is expected to take 6 - 8 weeks. As mentioned in my earlier note, the wood to steel project is a major endeavor and will be done over a five year period. This particular stretch is one in need of replacement for safety reasons. The work will be done using existing access roads so it won't have the impact of the pole changeout project scheduled in the coming years. It was hoped that this line upgrade could be done with the pole change out project but it's been determined that the age and condition of the line is such that it warrants earlier action for safety reasons.
