1. CALL TO ORDER at 7:01 PM.
2. PLEDGE OF ALLEGIANCE
3. DETERMINATION OF MEMBERS PRESENT
Present: Scotty Ensign, Lynn Hopewell, Ken Brennecke, Jim Cooper, Cheryl Wegner, and David Stone who arrived at 7:06 PM.
Excused absences: Dawn Perfect and Jamie Holabird
4. Corrections/Approval to T&T Minutes 3-24-14, 1-5-15
T&T Minutes for 3-24-2014; A motion by Jim Cooper and seconded by Cheryl Wegner was passed unanimously to take up this issue at the next T&T meeting in March to allow enough time for all members to read and familiarize themselves with the contents.
T&T Minutes for 1-15-15; A motion by Jim Cooper and seconded by Cheryl Wegner to approve the minutes passed unanimously with the correction that the next meeting should be corrected to read 2-2-2015 rather than 1-5-2015.
5. ANNOUNCEMENTS
There were no announcements.
6. PRESENTATIONS FROM THE PUBLIC ON NON-AGENDA ITEMS ONLY
Joe Minervini had three concerns that were postponed until Item 10 on the agenda was reached (Agenda Item Requests).

ACTION ITEMS:

7. (Transportation/Trails Subcommittee Project) 13th Street Bridge Project and Inclusion of Trails as Part of Project
A motion by Jim Cooper and seconded by Cheryl Wegner was passed unamously to table this item until more information about the design of the project could be acquired with the proviso that the following concerns for the project be reflected in these minutes (1) the equestrian crossing area is adequately designed for the safety of multiuse trail users, (2) that the surface be textured to provide adequate traction, and (3) that adequate safety signage for right hand turns from Maple Street onto 13th Street be provided.
8. Due to resignation of one member, a seat is open on the T&T Subcommittee and a new member will be voted on. People interested in serving on the Transportation/Trails Subcommittee should plan to attend and bring a Letter of Interest of Interest
Bob Hailey stepped down leaving the vacancy. The vacancy has not been advertised to the public and so this item was tabled until the March meeting. Scotty will also be stepping down and a new Chairman will be named for the T&T at the 2-5-2015 meeting of the RCPG.
9. Concerns from Members

Cheryl Wegner expressed the concern that the T&T Subcommittee did not have either the Community Trails Master Plan or the Ramona Road Master Plan as reference documents and that needed to be corrected. She will provide the Community Trails Master Plan and the Ramona Roads Master Plan is available on the County of San Diego website.

10. Agenda Item Requests

Joe Minervini had three agenda item requests:

- (1) That the T&T discuss sending a letter to the County about the signal at San Vicente and 11th Street. The apparent problem is that for North bound traffic the signal always defaults to red. However, since the new signal at H Street and San Vicente will probably affect the timing of the signal at 11th and San Vicente this request was denied. Jim Cooper made the motion and Cheryl Wegner seconded. It passed unanimously.
- (2) That the T&T recommend to CalTrans that Highway 67 be widened from the intersection of Dye Road to the intersection of Ramona Street/Day Street. Because the Supervisors were aware of this problem, the tree colonnade advocates would become involved, and there was no CalTrans priority for this issue the request was denied. Jim Cooper made the motion and Cheryl Wegner seconded. It passed 5 to 1.
- (3) That the T&T request rework of the Form Based Code specifically to reconcile the disparity of allowable buildable units from 24/acre in the Form Based Code with 7/acre in the Ramona Community Plan and also the inadequate amount of onsite parking provided by apartment projects (one per unit) as these affect traffic in the area. It was pointed out that these issues are ongoing with the Village Design Group architects and that the Traffic Study associated with the apartment project next to the Lutheran Church on 16th Street will trigger further discussion on this issue. The request was denied 5-1. Jim Cooper made the motion and Cheryl Wegner seconded.

11. Adjournment

On a motion by Jim Cooper and seconded by Lynn Hopewell the meeting was adjourned by a vote of 6 to 0.

The next meeting will be held at the Ramona Community Center on March 2nd, 2015 at 7:00 PM.
