X-1 This comment is introductory in nature and does not raise a significant environmental issue for which a response is required.

X-2 This comment takes issue with how the DEIR was prepared. It appears also that the commenter disagrees with the analysis prepared for potential impacts to agricultural resources. It should be noted that the proposed ordinance applies to areas outside of Boulevard, including areas with important farmland. Therefore, the County determined there was a potential for significant impacts to agriculture.

X-3 This comment does not raise environmental issues for which a response is required. However, the County stresses that two of the project objectives are to: 1) Streamline and clarify the approval process for the development and operation of small wind turbines; and 2) Update regulations for large wind turbines to be consistent with current wind turbine technologies and designs.
