Hi Sarah,

We have been meeting with the applicant since early September regarding next steps in their processing schedule. We have consistently expressed to the applicant that December 12th was not an achievable Planning Commission date. We again met with the applicant this Wednesday and explained why December 12th was still not a feasible date.

Following that Wednesday meeting, we continued working with Darren on the best strategy moving forward (special hearing, etc) and it is my understanding that Mark briefed you on this on Wednesday. It just so happened that the Chamber of Commerce meeting occurred as we have been working though getting these scheduling issues across to the applicant.

At this point, we feel that the applicant has come to the mutual understanding that December is not doable.

We have been working on our plan moving forward which includes a January 16th Planning Commission date and a February 4th Board of Supervisors date. With this plan, we feel that we will be able to achieve the applicant's goal of a February 4th BOS hearing while ensuring we don't rush to a PC hearing before we are ready or before giving the public ample time to review documents. We have discussed this plan with the applicant but have not yet confirmed that the logistics work. With our confirmation this morning that the logistics will work, we will inform them that this is the plan moving forward.
