| <p><b>TERM:</b> Members of the Review Board shall be appointed by affirmative vote of a majority of the members of the Board of Supervisors (BOS) from a list of candidates submitted by the community. The terms of office of all members shall be four years. A member may be re/appointed for a second term or removed by a majority of the BOS.</p> <p>The Alpine Design Review Board consists of five members, as follows:</p> <ul style="list-style-type: none"><li>• Seats 1 &amp; 3 are currently nominated by the Planning Group.</li><li>• Seats 2, 4 and 5 are currently nominated by the Alpine Chamber of Commerce.</li><li>• The member for Seat 5 shall be nominated by the Chamber of Commerce, from a slate of five persons associated with the Alpine business community who have been selected by the Alpine Planning Group.</li></ul> <p>Members shall reside, maintain a business, or own property or be employed in the Community Planning Area. Emphasis shall be given to the following:</p> <ol style="list-style-type: none"><li>1. One of the members nominated by the Alpine CPG shall be a building or design professional, such as an architect, landscape architect, planning consultant, civil engineer, unless the Group is unable to find an acceptable candidate with such a professional background.</li><li>2. The nominee for Seat 2 shall be an owner of property in zoned or used for business purposes.</li><li>3. Candidates with design backgrounds in architecture, landscape architecture, urban planning, fine arts, and in construction.</li><li>4. At least one representative of the community planning or sponsor group.</li><li>5.
