## NOTICE OF PUBLIC HEARING

### COUNTY OF SAN DIEGO CONSORTIUM 2015-16 CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT 2017-18 ANNUAL FUNDING PLAN STRATEGY COMMUNITY DEVELOPMENT BLOCK GRANT, HOME INVESTMENT PARTNERSHIPS, AND EMERGENCY SOLUTIONS GRANT PROGRAMS

Notice is hereby given that the Board of Supervisors will hold a public hearing at 9 a.m. on September 13, 2016, in Room 310 of the County Administration Center, 1600 Pacific Highway in San Diego regarding the Fiscal Year (FY) 2015-16 Consolidated Annual Performance and Evaluation Report (CAPER) and the preparation of the 2017-18 Annual Funding Plan.

The County is required to prepare a CAPER each year which describes program accomplishments during the last fiscal year for the Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) programs. The San Diego “Urban County” CDBG and ESG Programs fund housing and community development activities in the unincorporated area and in six participating cities (Coronado, Del Mar, Imperial Beach, Lemon Grove, Poway, and Solana Beach). The San Diego County HOME Consortium Program provides funds for housing activities in the CDBG and ESG Program areas and in six Consortium cities (Carlsbad, Encinitas, La Mesa, San Marcos, Santee, and Vista).

The FY 2015-19 Consolidated Plan was approved by the Board on April 7, 2015, and includes a community needs assessment, the identification of available resources to address priority community needs, and a strategic five-year plan. As a subcomponent of the Consolidated Plan, an annual Action Plan must be completed each year for the County’s CDBG, HOME, and ESG programs. The FY 2017-18 Annual Funding Plan will soon be prepared and will identify activities recommended for funding in FY 2017-18.

The public is invited to attend the public hearing to comment on the CAPER and to obtain the views of citizens on housing and community development needs prior to the preparation of the FY 2017-18 Annual Funding Plan. The public may also provide comments in writing during the 30-day comment period ending September 13, 2016. The CAPER can be accessed at [www.sdhcd.com](http://www.sdhcd.com).
