

SEVENTH AMENDMENT TO JOINT EXERCISE OF POWERS AGREEMENT
BETWEEN THE COUNTY OF SAN DIEGO AND THE CITY OF EL CAJON
CREATING AN AGENCY TO BE KNOWN AS
THE GILLESPIE FIELD DEVELOPMENT COUNCIL

This Seventh Amendment is made and entered into this 28th day of June, ~~2010~~, by and between the County of San Diego, a political subdivision of the State of California, hereinafter referred to as "County", and the City of El Cajon, a municipal Corporation of the State of California, hereinafter referred to as "City".

WHEREAS, on March 19, 1974, the City and County entered into a Joint Powers Agreement for a period of ten years creating the Gillespie Field Development Council; and

WHEREAS, City and County amended the Joint Powers Agreement to extend the term for an additional one year to expire on March 18, 1985; and

WHEREAS, City and County amended the Joint Powers Agreement to extend the term for an additional three years to expire on March 18, 1988; and

WHEREAS, City and County amended the Joint Powers Agreement to extend the term for an additional three years to expire on March 19, 1991; and

WHEREAS, City and County amended the Joint Powers Agreement to extend the term for an additional ten years to expire on March 18, 2001; and

WHEREAS, City and County amended the Joint Powers Agreement to extend the term for an additional two years to expire on March 18, 2003; and

WHEREAS, City and County amended the Joint Powers Agreement to extend the term for an additional seven years to expire on July 11, 2010; and

WHEREAS, City and County desire to extend the term of the Joint Powers Agreement for an additional four years to expire on July 11, 2014;

NOW THEREFORE, it is mutually agreed by and between the parties hereto to amend the Joint Exercise of Powers Agreement Between the County of San Diego and the City of El Cajon Creating an Agency to be Known as the Gillespie Field Development Council (County Document No. 485943) by amending Section 2.A. thereof to read in its entirety as follows:

"Section 2. Term.

- A. This Agreement shall commence March 19, 1974 and shall continue in full force and effect until July 11, 2014, or until such lesser time as the parties hereto should

mutually find that the objectives of the Agreement have been substantially achieved.”

All other terms and conditions of the Joint Powers Agreement shall remain in effect.
