Each diagnosis is assigned a code(s) according to ICD-9-CM

Rate is the ratio of the number of hospital discharges during the year to the number of persons in the civilian population on July 1 of that year;
rate per 10,000 population

Average length of stay is the total number of days of care accumulated at time of discharge by patients discharged during the year,
divided by the number of patients discharged.
