

Description of Project:

This project will fund the acquisition cost for two (2) Automated License Plate Readers (ALPRs) and two (2) marked Sheriff's patrol vehicles for the Santee Sheriff's Station.

The highest number of calls for service received by the Sheriff's Department from Tribal lands is vehicle theft. Even as the incidence of other crimes has dropped in our region, vehicle thefts have continued to rise. The most common sites for thefts are parking lots located at shopping centers, malls, apartment complexes, entertainment venues, and transit stops. The motives behind the thefts are diverse, including:

- To facilitate other crimes, particularly robberies and violent assaults
- To sell the vehicle
- To sell the parts
- To trade for drugs
- To go joyriding
- To commit insurance fraud
- To defraud the lender or body shop

The Santee Sheriff's Station proposes to deploy two radio cars equipped with ALPR technology. The radio car services the areas that include the Barona Casino and the surrounding areas. Deputies will be responsible for "sweeping" the parking lots of the casino and community to identify stolen cars and to respond accordingly.

The most obvious use for the ALPR is the recovery of stolen vehicles, but the ALPR system is able to recognize and match license plate information against any database or conduct surveillance in any environmental setting and under any lighting conditions.

The law enforcement application benefits:

- Traffic Management
- Narcotics and drug interdiction
- Surveillance and vehicle patterns
- Criminal warrants and fugitive apprehension
- Stolen vehicles and wanted vehicles (BOL alerts)
- Automobile repossessions
- Amber Alert Program
- Speed enforcement and speed analysis
- Perimeter control
- Covert and overt design options

- Intelligence gathering
- International/Domestic Terrorism Watch list targets
- Parole/probations violations
- Sex Offender monitoring

Information captured by the system is searchable and when retrieved can supply date, time, location (by GPS coordinates) and a color photo of the vehicle. This system is easily operated by the deputy in the vehicle. It is run in the "background" of the normal Mobile Data Computer (MDC) operations. If a target vehicle is located by the system an alert is sounded and the deputy will see a color photograph of the vehicle and the license plate.

The presence of the ALPRs as a crime fighting tool will insure increased recovery of stolen vehicles, greater apprehension for criminal suspects for auto theft and other related crimes, and will provide greater security and safety for the community. The technology provided by the ALPRs offers a more accurate and timely information for staff making enforcement decisions.

Cost of Project:

The total projected cost of two (2) patrol cars, both equipped with an ALPR is \$159,255.20. The cost breakdown is as follows:
