

Ozone is a ground-level air pollutant formed when emissions from motor vehicles, industrial plants, consumer products, and other sources interact under the influence of sunlight and heat. As seen below, ozone pollution levels have declined significantly in the region, however the region has yet to attain the NAAQS for ozone. Accordingly, the District has prepared a draft, updated Ozone Attainment Plan that proposes further reductions of ozone-forming air pollutant emissions and forecasts attainment of the NAAQS for ozone by federal deadlines.

### **State Implementation Plan for Attaining National Ozone Standards**

The U.S. Environmental Protection Agency classifies regions regarding their status for attaining Federal ozone standards. Currently, San Diego has two classifications: Serious non-attainment for a 2008 standard and Moderate non-attainment for a 2015 standard. (Join the webinars to learn more.) Accordingly, the District is required to submit a State Implementation Plan (SIP) for each ozone standard in order to fulfill requirements of the Federal Clean Air Act to attain these standards. The requirements include provisions for Reasonably Available Control Technology and other Reasonably Available Control Measures, demonstrations of Reasonable Further Progress and attainment, and contingency measures to be implemented if the ozone standards are not attained by federal deadlines.
