Commissioner Turigliatto- The Jakes youth event for the San Diego National Wild Turkey Federation was held at Lake Wohlford on June 24. The event was attended by 103 kids with no issues. The National Wild Turkey Foundation will be installing a drinker for wildlife in the Cleveland National forest.

Commissioner Carle-Made a 12 day tour of National Parks in Northern Arizona and Southern Utah. He also read about two cases of large monetary fines for lobster poaching in San Diego County and wondered how that might affect our grant funding budget.

Commissioner Bransford-The San Diego Wildlife Federation will be hosting an open house at the Hollenbeck Canyon Facility on the last weekend in August, Date TBD. The San Diego Chapter of Quail Forever will also be hosting a banquet on August 12th.
