2018 Pest Control Business License Registration Notice

News

If you apply at a **Public School** or **Day Care Center** you **MUST** comply with Healthy Schools Act (HSA). For more information regarding HSA, visit this website <http://apps.cdpr.ca.gov/schoolipm/> or contact us and ask to speak with a public agency inspector.

Save time! Save money! Over half of agricultural pest control businesses now use **CalAgPermits** to submit pesticide use reports. If you are not using on-line reporting, give it a try. Visit our website at www.sdcounty.ca.gov/awm/envreg.html or contact your inspector for more information to get started.

In 2017, with your help, our department diverted over 6,000 pounds of **empty pesticide containers** from going into local landfills. These events are held three times a year in San Marcos. The next event will be on February 3, 2018. If you would like more information please call and ask to speak to a pesticide container recycling inspector or visit our website.

Bee aware! If you apply pesticides which say “**toxic to bees**” on the label, we strongly encourage you to visit our website www.sdcounty.ca.gov/awm/pesticides.html or call your inspector to learn more about your important role and responsibilities in bee protection.

Annual Registration Information

Pest Control Businesses, including Maintenance Gardener Pest Control Businesses, must **register every calendar year** with the Agricultural Commissioner in all counties where they perform work. You must register **before** you advertise, solicit, or operate as a pest control business. The registration fee is **\$75.00** for a Pest Control Business and **\$25.00** for a Maintenance Gardener Pest Control Business.

Register by mail, in person, or online:

Please provide the following information:

1. Completed San Diego County Agricultural Commissioner Pest Control Business Registration Form
2. Copy of a Qualified Applicator License or Certificate (valid through December 2018 or 2019)
3. Copy of your Pest Control Business License (valid through December 2018 or 2019)
4. Completed Application for Pest Control Equipment Registration (enclosed **yellow** form, required only if your company is using power equipment)
5. The Registration Fee (check or money order made out to “County of San Diego”). Follow the enclosed directions or go to <https://publicservices.sdcounty.ca.gov/citizenaccess/> to pay online with Visa, MasterCard, Debit Card, Check, or a bank account.
