2019 Branch 2 & 3 Structural Pest Control Business Registration

News

New FIPRONIL label restrictions! Commonly used fipronil based products have new labels that limit when and how they can be applied for **general pest control**. Some of the major changes include:

- Maximum rate of **0.03%**
- Maximum of **4** applications a year
- Maximum **6 inch** spray band up and out around foundation
- Minimum **60 days** between applications
- **No** applications to garage doors and driveways.
- **No** applications made between **November 1 and February 28**

Save time! Save money! Over half of structural pest control businesses now use **CalAgPermits** to submit pesticide use reports saving time and effort. If you are not already using on-line reporting, give it a try. If you are a **dual licensed company**, be sure to report your usage under the appropriate license number; agricultural pesticides under your agricultural license number and structural pesticides, including second generation anticoagulant rodenticides, under your structural license number. Annual Registration Information

Structural Pest Control Operators must **register every calendar year** with the Agricultural Commissioner in all counties where they perform work. You must register **before** you advertise, solicit, or operate as a pest control business. The registration fee is **\$10.00** for a Branch 2 & 3 structural pest control business.
