### News

**Title 3 California Code of Regulations 6695 – Use of Carbon Monoxide Pest Control Devices:** New regulations, effective October 1, 2022, can be viewed at this link: <https://www.cdpr.ca.gov/docs/legbills/calcode/030206.htm#6695>.

If you apply pesticides at a **Public School** or **Day Care Center** you **MUST** comply with the Healthy Schools Act (HSA). For more information regarding HSA, visit this website: <http://apps.cdpr.ca.gov/schoolipm/>.

### Annual Registration Information

It is a violation to perform work in San Diego county without first registering with the County Agricultural Commissioner. Failure to register can result in fines of at least \$250. If you are dual licensed, please remember your Structural Pest Control Business must also be registered yearly. You must register **before** you advertise, solicit, or operate as a pest control business. The registration fee is **\$75.00** for a Pest Control Business and **\$25.00** for a Maintenance Gardener Pest Control Business.

Please provide the following:

1. Completed San Diego County Agricultural Commissioner Pest Control Business Registration Form
2. Copy of a Qualified Applicator License or Certificate (valid through December 2023 or 2024)
3. Copy of your Pest Control Business License (valid through December 2023 or 2024)
4. Completed Application for Pest Control Equipment Registration (enclosed **yellow** form, required only if your company is using power equipment. Handheld equipment and backpack sprayers are exempt.)
5. The Registration Fee (check or money order made out to “County of San Diego”). Follow the enclosed directions or go to <http://publicservices.sandiegocounty.gov/CitizenAccess/Default.aspx> to pay online with Visa, MasterCard, Debit Card, Check, or a bank account.
6. If paying online, you must submit the above listed items 1-4. Please email them to [PRP.AWM@sdcounty.ca.gov](mailto:PRP.AWM@sdcounty.ca.gov) or return the items by mail in the envelope provided.
