### News

**You can pay your registration fees online.** Please see the enclosed flyer for step-by-step directions.

**\*Don't Forget\* BeeWhere** is an online mapping program that allows you to check for the presence of beehives before you write your recommendation. You are responsible for protecting bees when recommending pesticides and play an important role in **bee protection**. Visit: <https://beewhere.calagpermits.org> for more information.

**Recycle Empty Pesticide Containers:** Our department holds recycling events in San Marcos. If you would like more information, please call and ask to speak to a pesticide container recycling inspector.

Please remember, if you use pest control adviser software to write your recommendations it is still your responsibility to ensure the site and/or commodity is listed on the pesticide label. We have seen instances where the computer software does not evaluate the label correctly. Don't assume the software is always correct. Review the actual label to assure your recommendation is in compliance with all the requirements.

Do you know when a licensed Pest Control Adviser (PCA) -written recommendation is required? It is required for:

- **Any pesticide application** to publicly-owned land such as parks, golf courses, street medians, etc.
- When a Pest Control Business applies a Restricted Material at a non-production agricultural site such as a park, golf course, street median, etc.
- Whenever you make production agricultural recommendations.

### Annual Registration Information

It is a violation to perform work in San Diego county without first registering with the County Agricultural Commissioner. Failure to register can result in fines of at least \$250. Register prior to writing recommendations to avoid penalties. The registration fee is **\$10.00** for a PCA headquartered within San Diego county and **\$5.00** for a PCA headquartered outside of San Diego county.
