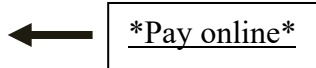
Fieldworker Training Reminder: Employers are required to assure the training of all workers who enter fields within 30 days after any pesticide (herbicide, insecticide, fungicide, etc.) has been applied. Workers must be fully trained **before** entering these fields and at least **annually** thereafter. Annual Registration Information

It is a violation to perform work in San Diego county without first registering with the County Agricultural Commissioner. Failure to register can result in fines of at least \$250. The **annual** registration fee is **\$75.00**.

You can pay your registration fees online. Please see the enclosed flyer for step-by-step directions.

Register by mail or online:



Please provide the following:

1. A completed 2021 County of San Diego Farm Labor Contractor Registration form (*enclosed*). Please include your email address on the form.
2. A copy of your current Farm Labor Contractor's Certificate of Registration obtained from the State of California. If your State Farm Labor Contractor's License is expired, submit a copy of your unexpired United States Department of Labor Farm Contractor's license.
3. The Registration Fee (check or money order made out to "County of San Diego"). Follow the enclosed directions, or go to <http://publicservices.sandiegocounty.gov/CitizenAccess/Default.aspx> to pay online with Visa, MasterCard, Debit Card, Check, or a bank account.
4. If paying online, you must submit your completed registration form and current Farm Labor Contractor's Certificate of Registration or United States Department of Labor Farm Contractor's license. Please email the documents to PRP.AWM@sdcounty.ca.gov or return the documents by mail in the envelope provided.
