## **2023 Branch 1 Structural Pest Control Business Registration**

### **News**

**Online Notice of Intent (NOI) Submittals:** You can submit NOIs online, cancel, or reschedule jobs and keep track of monthly NOI submittals for certification. To register for an account please call (858) 694-8980 and we will assist you to set up your account.

**Structural Fume Enforcement Program (SFEP) Change:** Beginning in 2023, San Diego county will no longer be a participant of the SFEP. Due to this change, companies will not be required to pay the \$8 per fume fee for fumigations taking place after December 31, 2022.

**Title 3 California Code of Regulation 6780 (b) – Fumigation Safety Reminder:** When using the California Aeration Plan (CAP), steps must be completed in sequence. When not using CAP, your Fumigation Safety Program requires the use of either continuous monitoring or an air-supplied respirator.

**CalAgPermits** can be used to electronically submit your use reports. If you use CalAgPermits you are not required to send us your structural stamps. Enter the structural stamp number on the report page when submitting reports. To obtain an account please call (858) 694-8980 and we will assist you.

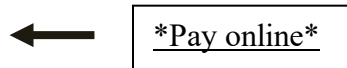

### **Annual Registration Information**

It is a violation to perform work in San Diego county without first registering with the County Agricultural Commissioner. Failure to register can result in fines of at least \$250. You must register **before** you advertise, solicit, or operate as a pest control business. The registration fee is **\$10.00** for a Branch 1 Structural Pest Control Business.

1. Completed San Diego County Agricultural Commissioner Branch 1 Structural Registration Form.
2. The Registration Fee (check or money order made out to “County of San Diego”).
