SUBJECT: SHERIFF - ACCEPT AND ESTABLISH APPROPRIATIONS AND ESTABLISH A TRUST FUND FOR THE DISARMING PROHIBITED PERSONS TASK FORCE, ESTABLISH APPROPRIATIONS FOR THE FISCAL YEAR 2018 URBAN AREA SECURITY INITIATIVE AND, ADOPT A RESOLUTION FOR THE FISCAL YEAR 2019 STATE HOMELAND SECURITY PROGRAM AND URBAN AREA SECURITY INITIATIVE (DISTRICTS: ALL)

OVERVIEW

The California State Budget Act of 2019 appropriated three million dollars to the Board of State and Community Corrections (BSCC) to support gun violence reduction pilot programs in the Counties of Alameda, San Diego, Santa Cruz, and Ventura. This is a request to authorize the Sheriff's Department to accept revenue funds, establish appropriations of \$80,000, and establish a trust fund to deposit funds received from BSCC for the Disarming Prohibited Persons (DPP) program, for the project period of July 1, 2019 through June 30, 2022 and to establish appropriations in the amount of \$80,000 in the Sheriff's Department. This is also a request to authorize the Sheriff, and/or designee, to review and execute all required grant and grant-related documents, including agreements with other government and non-government agencies for the distribution and/or reimbursement of grant funds where necessary to carry out the purposes of the DPP program in this year and subsequent years and, any annual extensions, amendments, and/or revisions thereof that do not materially impact or alter the services or funding levels.

The Sheriff's Department ability to provide the highest quality public safety services is enhanced by grant awards from the U. S. Department of Homeland Security's (DHS) Homeland Security Grant Program (HSGP). The HSGP's fund a range of critical preparedness activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas. These grant programs include the State Homeland Security Program (SHSP), Urban Area Security Initiative (UASI), and Operation Stonegarden (OPSG). On August 7, 2012 (4), the Board of Supervisors authorized the Sheriff to apply for and accept HSGP funds on behalf of the San Diego Law Enforcement Coordination Center (SD LECC) in future years if there are no material changes to the grant terms and funding levels. On February 14, 2017 (1), the Board of Supervisors authorized the Sheriff, or designee, to apply for and accept HSGP grant funds in subsequent years, and to review and execute all required HSGP grant and grant-related documents. On May 21, 2019 (2), the Board approved awards from the DHS Fiscal Year 2018 HSGP to support the SHSP for the SD LECC and to support the UASI for the project period September 1, 2018 to May 31, 2021. This is a request to authorize the Sheriff's Department to establish additional appropriations for the Fiscal Year 2018 HSGP UASI grant program in the amount of \$21,000 to complete critical preparedness activities for the project period September 1, 2018 to May 31, 2021.

On September 26, 2019 the Sheriff's Department received notification from the California Governor's Office of Emergency Services (Cal OES) of Fiscal Year 2019 HSGP grant award in the amount of \$2,047,500, contingent upon Board approval of resolution. This is also a request to authorize the Board of Supervisors to adopt a governing body resolution authorizing the Sheriff and designated Sheriff's Department personnel to execute any actions necessary for the purposes of the Fiscal Year 2019 HSGP SHSP and UASI grant programs for the SD LECC. Once the Resolution is fully executed, the Sheriff will return to the Board to establish appropriations based on the grant award.

RECOMMENDATION(S) SHERIFF

- Waive Board Policy B-29, Fees, Grants, Revenue Contracts Department Responsibility for Cost Recovery, which requires full cost recovery for grants, as these grant programs do not recover full cost.
- 2. Authorize the Sheriff's Department to accept \$1,000,000 in revenue funds from the Board of State and Community Corrections for the Disarming Prohibited Persons program for the project period of July 1, 2019 through June 30, 2022.
- 3. Establish appropriations of \$80,000 in the Sheriff's Department, Salaries & Benefits, based on unanticipated revenue from the Board of State and Community Corrections for the Disarming Prohibited Persons program for the project period of July 1, 2019 through June 30, 2022. (4 VOTES)

Authorize the Sheriff, and/or designee, in subsequent years, to accept funds from the Board of State and Community Corrections for the Disarming Prohibited Persons program and, in this year and subsequent years, to review and execute all required grant and grant-related documents, including agreements with other government and non-government agencies for the distribution and/or reimbursement of grant funds where necessary to carry out the purposes of the Disarming Prohibited Persons program and, any annual extensions, amendments, and/or revisions thereof that do not materially impact or alter the services or funding levels.
- 6. Establish appropriations of \$21,000 in the Sheriff's Department, Services & Supplies, based on unanticipated revenue from the U. S. Department of Homeland Security, Fiscal Year 2018 Homeland Security Grant Program, Urban Area Security Initiative (UASI) passed through the City of San Diego Office of Homeland Security, for the project period September 1, 2018 through May 31, 2021. (4 VOTES)
- 7. Adopt a Resolution entitled: A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO RELATING TO THE FISCAL YEAR 2019 HOMELAND SECURITY GRANT PROGRAM STATE HOMELAND SECURITY PROGRAM (SHSP) AND URBAN AREA SECURITY INITIATIVE (UASI).

FISCAL IMPACT

Disarming Prohibited Persons (DPP)

Funds for this request are partially included in the Fiscal Year 2019-20 Operational Plan for the Sheriff's Department. If approved, this request will result in current year estimated costs of \$103,200 and revenue of \$80,000. The funding source is revenue from the Board of State and Community Corrections Disarming Prohibited Persons Trust Fund (\$80,000) and existing General Purpose Revenue in the Sheriff's Department (\$23,200). The revenue recovers Sheriff's Department direct costs but does not reimburse all costs associated with administrative overhead and support estimated at \$23,200. There will be no additional staff years.

Urban Area Security Initiative - Sheriff

Funds for this request are partially included in the Fiscal Year 2019-20 Operational Plan for the Sheriff's Department. If approved, this request will result in current year estimated costs of \$21,277 and revenue of \$21,000. The funding source is revenue from the U. S. Department of Homeland Security (DHS) Fiscal Year 2018 Homeland Security Grant Program (HSGP) Urban Areas Security Initiative (\$21,000) and existing General-Purpose Revenue in the Sheriff's Department (\$277). The revenue recovers Sheriff's Department direct costs but does not reimburse all costs associated with administrative overhead and support estimated at \$277. There will be no additional staff years.

2. SUBJECT: REVIEW AND CONTINUE LOCAL HEALTH EMERGENCY AND LOCAL EMERGENCY REGARDING COVID-19 (DISTRICTS: ALL)

OVERVIEW

On February 14, 2020, the San Diego County Public Health Officer issued a Declaration of Local Health Emergency, pursuant to California Health and Safety Code Section 101080, as a result of the international COVID-19 outbreak. Additionally, on February 14, 2020, pursuant to California Government Code 8630, the Chief Administrative Officer, serving as the County

of San Diego Director of Emergency Services and as the Coordinator of the Unified San Diego County Emergency Services Organization, issued a Proclamation of Local Emergency regarding COVID-19. On February 19, 2020 (1), the San Diego County Board of Supervisors (Board) ratified the Declaration of Local Health Emergency and Proclamation of Local Emergency. Health and Safety Code Section 101080 requires that the Board review the need for continuing the local health emergency at least every 30 days, and California Government Code Section 8630 requires that the Board review the need for continuing the local emergency every 60 days.

Today's action requests the Board review the Declaration of Local Health Emergency and find that there is a need to continue the local health emergency until no longer needed, subject to statutory review requirements. In addition, today's actions request the Board to review the Proclamation of Local Emergency and find that there is a need for continuing the local emergency until no longer needed, subject to statutory review requirements.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Review the need for continuing the local health emergency identified in the attached Declaration of Local Health Emergency made by the Public Health Officer on February 14, 2020.
- 2. Find that there is a need for continuing the local health emergency, subject to California Health and Safety Code Section 101080 requirements.
- 3. Review the need for continuing the local emergency identified in the attached Proclamation of Local Emergency made by the Chief Administrative Officer on February 14, 2020.
- 4. Find that there is a need for continuing the local emergency, subject to California Government Code Section 8630(d) requirements.

FISCAL IMPACT

The costs in responding to the international novel coronavirus (COVID-19) outbreak to the County of San Diego (County) and the impacted hospitals (UCSD, Rady Children's, and Scripps Health) is estimated to be approximately \$2.3 million through February 24, 2020. The County share of these costs is approximately \$0.5 million, primarily for clinical and administrative support staff in the coordination, surveillance, laboratory services, communication, and management of the COVID-19 local health emergency and local emergency, as well as related services, operations and supplies, including requested ambulance standby and transport services. The County fiscal responsibility does not include various hospital-related costs for patient care, which is estimated to be approximately \$1.8 million for the same time period, or for the shelter and basic care of those who were quarantined at the Marine Corps Air Station Miramar location, of which we do not have cost estimates. Current County costs are being covered by existing department appropriations, including the use of County Health and Human Services Agency Management Reserves, and are funded with General Fund fund balance, Realignment, and General-Purpose Revenue. Staff are pursuing federal and State reimbursement for all County costs incurred. There is no change in net General Fund and no additional staff years.

3. SUBJECT: ADOPTING BEST PRACTICES TO PROMOTE RECOVERY AND PROTECT PUBLIC HEALTH (DISTRICTS: ALL)

OVERVIEW

Syringe Services Programs (SSPs) is a medically approved strategy with over 30 years of academic research to demonstrate its effectiveness. As the elected body that oversees the County Public Health Services and Behavioral Health Services, it is our obligation to ensure County staff have thoughtful, research-based tools and strategies at their disposal to save lives and protect public health. While some SSPs are perceived as controversial due to lack of education and understanding, we should not steer away from implementing evidence-based practices that promotes recovery, save lives and protects the public health.

Today, I am proposing to update the Board's position in a 1997 Board Resolution opposing needle exchange programs by directing the Chief Administrative Officer to develop a Comprehensive Harm Reduction Strategy, including Syringe Services Programs, engage a third-party subject matter expert to review local data, establish best practices and involve local advisory boards and coalitions to implement a harm reduction strategy in additional to pursuing available State and federal funding.

The benefits of SSPs include prevention of infectious disease, connections to treatment and reducing needlestick injuries and overdose. SSPs are associated with an estimated 50 percent reduction in HIV and HCV incidence. SSPs is also a bridge to substance use disorder treatment and other health services. New users of SSPs are five times more likely to enter drug treatment and three times more likely to stop using drugs than those who don't use the programs. SSPs also protect first responders and the public by providing safe needle disposal and reducing the presence of discarded needles in the community.

Despite these benefits, the Board's 1997 resolution about SSPs prevents SSPs from being used by our public health and/or behavioral health departments. This is putting our County at a disadvantage. Under the current policy our health professionals, highly trained and skilled individuals are prohibited from even studying SSPs. They cannot collect data on tactics, use and/or implementation strategies, or services to be administered by the County or a contractor.

Additionally, due to our current policy opposing SSPs, our County Health and Human Services Agency and the citizens that should have benefited from the intervention have missed out on countless federal and state grants, including the recent \$15.2 million budget allocation establishing the California Harm Reduction Initiative for SSPs and technical assistance.

Annually, the County's funding award for HIV prevention has been reduced by the California Department of Public Health, Office of AIDS (CDPH-OA), due to the County's inability to include clean syringe exchange in our prevention strategy and contracts.

This 23-year-old policy is outdated and does not position our County health experts to most effectively protect the public health and safety of our residents.

I urge your support for developing a comprehensive harm reduction strategy.

RECOMMENDATION(S) SUPERVISOR NATHAN FLETCHER

- 1. Direct the Chief Administrative Officer (CAO) to develop a Comprehensive Harm Reduction Strategy, including Syringe Services Programs that should be incorporated into current and future County initiatives that aim to prevent and reduce the transmission of disease and infection, and to engage individuals with substance use disorders by linking to treatment and other services to prevent and reduce substance use, drug related deaths, overdose and improve overall quality of life.
- 2. Direct the Chief Administrative Officer to engage a third-party subject matter expert, subject to available funding, to review local data, establish best practices, consider local resources and involve local advisory boards and coalitions such as the Methamphetamine Strike Force, County HIV Planning Council and Eliminate Hepatitis C Initiative Coalition in the implementation of a harm reduction strategy.
- 3. Authorize the Chief Administrative Officer to apply for current and future fiscal year funding to support harm reduction strategies that would assist in achieving the County's HIV Getting to Zero and Eliminate Hepatitis C Initiatives among others.

FISCAL IMPACT

The one-time cost for procuring a third-party subject matter expert is estimated to be \$50,000 to \$70,000, subject to available program/grant revenue. There will be no change to general fund net costs and no additional staffing.

AGREEMENT BETWEEN THE COUNTY OF SAN DIEGO AND RADY CHILDREN'S HOSPITAL SAN DIEGO DESCRIBING POSSIBLE TERMS FOR THE DEVELOPMENT AND OPERATION OF A BEHAVIORAL HEALTH HUB FOR CHILDREN AND YOUTH AND A PARKING STRUCTURE ADJACENT THERETO (DISTRICTS: ALL)

OVERVIEW

In response to community need, the San Diego County Board of Supervisors (Board) has taken several actions to enhance, expand, and innovate the array of behavioral health programs and services in the region - broadly referred to as the Behavioral Health Continuum of Care. These actions have brought together justice partners, hospitals, community health centers, community-based providers, and other stakeholders to create system-wide changes to ensure people have access to behavioral health services to meet their immediate needs and support their long-term recovery.

Today's item provides an update on efforts to establish a behavioral health hub in North Central San Diego County which, when operational, will provide critical services to children and youth through a partnership between the County of San Diego (County) and Rady Children's Hospital -San Diego (Rady). In addition, today's action requests that the Board authorize the Agency Director, Health and Human Services Agency, to execute a Memorandum of Understanding between the County and Rady setting forth general terms for as-yet-to-be negotiated agreements between the two entities to develop the hub on County-owned property, to develop a parking structure for joint use, and to make the necessary environmental findings.

These actions complement the ongoing work across systems to provide optimal behavioral health resources that are regionally distributed and coordinated, thereby supporting the County's *Live Well San Diego* vision for a region where all residents have the opportunity to build better health, live safely, and thrive.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Find that the proposed actions are exempt from California Environmental Quality Act (CEQA) review pursuant to sections 15061(b)(3) and 15378(a) of the CEQA Guidelines.
- 2. Authorize the Agency Director, Health and Human Services Agency to execute the Memorandum of Understanding (MOU) between the County and Rady Children's Hospital San Diego.
- 3. Direct the Chief Administrative Officer to return to the San Diego County Board of Supervisors with a final agreement or agreements between the County of San Diego and Rady Children's Hospital San Diego or a related entity or entities, subject to and upon completion of any necessary environmental review, to make necessary environmental findings and take other appropriate actions.

FISCAL IMPACT

There is no current year fiscal impact with today's recommendations. The potential capital project is anticipated to be fully funded by Rady. The anticipated cost for the operations of the North Central Region Children's Health Hub is subject to negotiations and final agreement. It is anticipated that the operational costs would be funded by program revenue. There will be no change in net General Fund cost and no additional staff years.

5. SUBJECT: AUTHORITY TO ENTER INTO A SINGLE SOURCE AGREEMENT WITH THE REGIONAL TASK FORCE ON THE HOMELESS FOR A FLEXIBLE HOUSING SUBSIDY POOL, AND AUTHORIZE ALLOCATION OF UP TO \$2,200,000 OF CALIFORNIA EMERGENCY SOLUTIONS AND HOUSING FUNDS FUNDING FOR USE IN THE POOL (DISTRICTS: ALL)

OVERVIEW

On November 19, 2019 (12), the San Diego County Board of Supervisors (Board) directed the Chief Administrative Officer to conduct a feasibility study on the implementation of a Flexible Funds for Housing Program also referred to as a "Flexible Housing Subsidy Pool (FHSP)" and report back in January 2020. On January 28, 2020 (2), staff returned to the Board to present the feasibility study which presented options for a County of San Diego (County) managed FHSP or a collaborative FHSP with the Regional Task Force on the Homeless (RTFH). At that time, the Board requested staff work with the RTFH to explore developing a regional, collaborative FHSP. In addition, the Board requested staff investigate sources for funding to allocate to the FHSP, prioritizing the unincorporated area, identifying time-limited assistance

opportunities and protecting the General Fund. In addition, the Board requested staff develop guiding principles for future funding contributions. Today's item requests authority to enter into a single source contract with the RTFH to administer a regional FHSP as RTFH provides a countywide approach based on unique knowledge and efficiencies, and leverages other funding sources.

These efforts align with the County of San Diego's *Live Well San Diego* vision for a region that is healthy, safe and thriving by creating opportunities to further address the housing and service needs of people experiencing homelessness in San Diego County.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. In accordance with Board Policy A-87, Competitive Procurement, approve and authorize the Director of the Department of Purchasing and Contracting to enter into negotiations with the Regional Task Force on the Homeless and subject to successful negotiations and a determination of a fair and reasonable price, award a contract for Flexible Housing Subsidy Pool implementation and administration for an initial term of up to one year, and up to four one-year option periods and up to an additional six months if needed, and to amend the contracts as needed to reflect changes to requirements and funding.
- 2. Approve the allocation of up to \$2,200,000 of California Emergency Solutions and Housing funds to the Flexible Housing Subsidy Pool
- 3. Approve the Guiding Principles related to future funding contributions to the FHSP found in Attachment A, which is on file with the Clerk of the Board.

FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2019-21 Operational Plan in the Health and Human Services Agency. If approved, depending on when implemented, this request will result in costs and revenue of approximately \$400,000 in Fiscal Year 2019-20, \$450,000 in Fiscal Year 2020-21, and \$450,000 in each Fiscal Year through 2023-24. The funding sources are \$800,000 from Round One and \$1,400,000 from Round Two awarded through the California Emergency Solutions and Housing grant. There will be no change in net General Fund cost and no additional staff years.

6. SUBJECT: RECEIVE THE FEASIBILITY STUDY TO EXPAND THE VET
CONNECT PROGRAM TO THE DEPORTED VETERANS SUPPORT
HOUSE LOCATED IN TIJUANA, BAJA CALIFORNIA, MEXICO AND
DIRECT THE CHIEF ADMINISTRATIVE OFFICER TO BEGIN
PROGRAM PLANNING TO IMPLEMENT THE PROGRAM
(DISTRICTS: ALL)

OVERVIEW

The San Diego County Board of Supervisors (Board) is committed to providing enhanced resources and supportive services to local veterans. On April 30, 2019 (20), the Board approved formal support of California legislative proposals aimed at enhancing services to assist veterans with successful reintegration into civilian life. Additionally, on October 15, 2019 (3), the Board approved implementation of Community Care Coordination to assist justice-involved veterans with reintegration back into their communities of origin throughout San Diego County.

The County of San Diego (County) Health and Human Services Agency (HHSA), Office of Military and Veterans Affairs (OMVA) provides services to veterans and their families throughout the San Diego region. In 2015, OMVA partnered with the San Diego County Library and established Vet Connect, a secure video teleconferencing system located at designated County libraries, to provide greater accessibility to resources for active duty military, veterans, dependents and survivors living in rural areas of the region.

On December 10, 2019 (21), the Board directed the Chief Administrative Officer to research the feasibility of expanding a Vet Connect station with secure internet connection in Tijuana, Baja California, Mexico, at the Deported Veterans Support House (The Bunker) and report back in 90 days. A feasibility study was conducted in collaboration with HHSA, the County Technology Office, the County information technology vendor and The Bunker. This study looked at the feasibility of technology infrastructure, services, and finances under a variety of options and scenarios. Based on this study, it was determined that it would be feasible to implement a Vet Connect station in Tijuana, Baja California, Mexico at The Bunker.

Today's item requests the Board receive the feasibility study to expand the Vet Connect program to Tijuana, Baja California, Mexico, at the Deported Veterans Support House. In addition, staff seeks the Board's approval to take the next steps to establish a Vet Connect station at The Bunker in Tijuana, Baja California, Mexico. Today's action supports the County's *Live Well San Diego* vision by promoting the health and well-being of veterans.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Receive the feasibility study to expand the Vet Connect program to the Deported Veterans Support House (The Bunker) located in Tijuana, Baja California, Mexico.
- 2. Direct the Chief Administrative Officer to begin implementation of establishing a Vet Connect station at The Bunker in Tijuana, Baja California, Mexico.

FISCAL IMPACT

7. SUBJECT: RECEIVE THE ELIMINATE HEPATITIS C SAN DIEGO COUNTY INITIATIVE UPDATE REPORT (DISTRICTS: ALL)

OVERVIEW

On November 13, 2018 (15), the San Diego County Board of Supervisors (Board) authorized staff to develop and launch the *Eliminate Hepatitis C San Diego County Initiative*, a public-private partnership using a collective impact approach to eliminate Hepatitis C virus (HCV) as a public health threat in San Diego County and to report back to the Board in approximately 12 months with recommendations. During the one-year planning process, efforts from County staff and stakeholders across healthcare, government, and consumer sectors were coordinated to address local HCV elimination. This process was facilitated by the American Liver Foundation, Pacific Coast Division. Recommendations have been developed with the goal to decrease morbidity and mortality of Hepatitis C cases in San Diego County.

Despite advancements in testing and treatment, HCV remains a significant public health issue that affects many populations. Since 2000, more than 2,500 cases per year of chronic HCV have been reported in San Diego County. From 2011 to 2016, HCV was listed as an underlying cause of at least 70-100 deaths in San Diego County annually. Treatment for HCV has advanced greatly, and a highly effective cure for HCV exists with minimal side effects. The development of this cure, coupled with prevention efforts, led the U.S. Centers for Disease Control and Prevention and the U.S. Department of Health and Human Services to determine that it is possible to eliminate HCV as a public health threat in the U.S. The recommendations developed during the planning process in San Diego County aim to

eliminate HCV through activities focused on education, prevention, screening, treatment, surveillance, and policy alignment. The primary target of the *Eliminate Hepatitis C San Diego County Initiative* is to decrease new cases of chronic HCV by 80% and reduce HCV mortality by 65% in San Diego County, by 2030.

Today's action is to receive the report of recommendations for the *Eliminate Hepatitis C San Diego County Initiative* and requests authorization for the Agency Director, Health and Human Services Agency, to pursue future funding opportunities related to Hepatitis C elimination efforts. HHSA will provide ongoing updates to the Board on the implementation plan. This item supports the Building Better Health and Living Safely components of the *Live Well San Diego* vision by bolstering local efforts that eliminate a curable disease to improve longevity and quality of life.

RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Receive the report of recommendations for the *Eliminate Hepatitis C San Diego County Initiative*.
- 2. Authorize the Agency Director, Health and Human Services Agency, to pursue funding opportunities for current and future fiscal years related to Hepatitis C elimination efforts.

ISSUANCE OF CHARTER SCHOOL REVENUE BONDS BY THE CALIFORNIA MUNICIPAL FINANCE AUTHORITY FOR THE BENEFIT OF URBAN DISCOVERY ACADEMY IN AN AGGREGATE AMOUNT NOT TO EXCEED \$22,000,000 (DISTRICT: 4)

OVERVIEW

The County has received a request from the California Municipal Finance Authority ("CMFA" or "Authority") to conduct a public hearing as required by the Internal Revenue Code and to approve the Authority's issuance of one or more series of charter school revenue bonds in an aggregate principal amount not to exceed \$22,000,000 (the "Bonds"), for the benefit of Urban Discovery Academy, a California nonprofit public benefit corporation and the sole member of both Fourteenth Street Holdings LLC, a California limited liability company and Russ Boulevard Holdings LLC, a California limited liability company ("Borrowers"). The Borrowers have applied for the financial assistance of the Authority to finance the acquisition of a ground leasehold interest in certain parcels of land located at 1400 Park Boulevard, San Diego, California 92101 (the "Project Site") operated as a charter school known as Urban Discovery Academy; the design, construction, renovation, equipping and furnishing of the building(s) to be used as education facilities at the Project Site (the "Facilities"); reimbursing the Borrowers for capital expenditures made by the Borrowers in connection with the Facilities; funding capitalized interest and a reserve fund, if necessary, with respect to the Bonds; and paying certain expenses incurred in connection with the issuance of the Bonds (collectively, "Project").

The Authority is authorized to assist in financing for nonprofit public benefit organizations or for-profit corporations with a public benefit project wishing to issue revenue bonds, including the Borrowers. In order to initiate such a financing, the Borrowers are asking the County of San Diego, a member jurisdiction in which the project resides to: (1) conduct a public hearing to satisfy the public approval requirement of Section 147(f) of the Internal Revenue Code; and

(2) approve the Authority's issuance of the Bonds. Although the Authority will be the issuer of the Bonds for the Borrowers, the financing cannot proceed without the approval of an applicable legislative body.

Today's recommendations will provide the Authority with the required authorization to pursue its determination to issue the Bonds on behalf of the Borrowers for the Project.

11. SUBJECT: SUPPORT SENATE BILL 378 - REIMBURSING RESIDENTS AND BUSINESSES DURING POWER SHUT-OFFS (DISTRICTS: ALL)

OVERVIEW

Investor-owned utilities (IOU), such as San Diego Gas & Electric (SDG&E), have been proactively shutting off power to millions of customers across California to reduce the chances of their electrical equipment igniting a fire. In San Diego County, SDG&E has proactively shut off power to residents and business owners in the back country numerous times, and the impact and hardship these communities experience is profound.

To address the impact power shut-offs have on communities and businesses, Senator Wiener introduced SB 378, which would require utilities to reimburse customers for impacts during power-shutoff events. Specifically, SB 378 would require utilities to establish a procedure for customers, local governments, and others affected by power shut-off events to recover their costs. The bill would prohibit utilities from billing customers during a power shut-off event and lays out specific penalties for utilities if they fail to act in a reasonable and prudent manner in the execution of a power shut-off event.

Today's action directs the Chief Administrative Officer to draft a letter expressing this Board of Supervisors' support for State Senate Bill 378 to San Diego County's legislative representatives in Sacramento, and add to the County's Legislative Program support for legislation or administrative actions to hold power companies responsible for the effects of power shut-off events, including compensation for financial costs incurred during an event.

14. SUBJECT: FISCAL YEAR 2019-20 SECOND QUARTER OPERATIONAL PLAN STATUS REPORT AND BUDGET ADJUSTMENTS (DISTRICTS: ALL)

OVERVIEW

This report summarizes the status of the County's Fiscal Year 2019-20 Adopted Operational Plan, as measured by projected year-end fund balance from current year operations. The projected year-end balance for the General Fund is \$118.0 million, and \$175.7 million for all budgetary funds combined. The projected fund balance anticipates variances from the Fiscal Year 2019-20 Amended Budget, which assumes that a portion of management reserves are not used, General Purpose Revenue will perform better than estimated, and all business groups will produce operating balances.

Transfers and revisions to the adopted budget can be made by formal action of the Board of Supervisors in accordance with the California County Budget Act, Government Code (GC) Section 29125. Increases to the overall budget require 4 votes while transfers of appropriations between departments within the same budgetary fund that do not increase the overall budget or the cancellation of appropriations require a majority vote. However, transfers of appropriations to facilitate transfers between budgetary funds require 4 votes even if the overall budget is not increased.

In the Public Safety Group (PSG), recommendations include appropriations adjustments for the purchase of Sheriff's vehicles, for a vocational training program to serve additional adult probation clients, and for the purchase and installation of generators for various fire stations.

In Health and Human Services Agency, recommendation include adjustment to fund the replacement of obsolete equipment for emergency medical transports.

In the Land Use and Environment Group (LUEG), recommendations include appropriation adjustments for new emergency generators at the Descanso and Potrero County libraries, to provide funding for Woodhaven Park Well and Fitness Trail, for access improvements at Heyneman Park, for roof repairs to the 4S Ranch Sports Park Building D, for the design and environmental study for Casa de Oro Library, for the design and parcel expansion of Lincoln Acres Park, for additional amenities at Estrella Park, and for the design and environmental analysis of an additional parking and restroom building at the Sweetwater Park/South County Bicycle Skills Course.

In the Finance and General Government Group (FGG), recommendations include appropriations adjustments for developer reimbursements funded by bond proceeds from the Harmony Grove Community Facilities District, for a vertical transportation study at multiple sites and to provide funding for the North County Regional Center Roof Replacement.

15. SUBJECT: SAN DIEGO UNIFIED SCHOOL DISTRICT 2020 GENERAL OBLIGATION REFUNDING BONDS (DISTRICTS: 1, 2, 3, 4)

OVERVIEW

A bond election was held in the San Diego Unified School District, County of San Diego, State of California ("District") on November 4, 2008. At this election, more than 55% of the qualified electors of the District voted for the issuance and sale of general obligation bonds of the District for various purposes in the maximum principal amount of \$2,100,000,000 (the "Authorization").

On April 16, 2014, the District issued its San Diego Unified School District 2014 General Obligation Bonds (Dedicated Unlimited Ad Valorem Property Tax Bonds) (Election of 2008, Series G) ("2014 General Obligation Bonds") in the aggregate principal amount of \$50,000,726.45.

On February 25, 2020, the District Board adopted a resolution to authorize the issuance and sale of a series of the San Diego Unified School District 2020 General Obligation Refunding Bonds in an aggregate principal amount not to exceed \$95,000,000 to refund all or a portion of the 2014 General Obligation Bonds.

Today's recommendation will authorize the Treasurer-Tax Collector to enter into a Paying Agent Agreement with the District and to formally direct the Auditor and Controller to

maintain the tax roll for the San Diego Unified School District 2020 General Obligation Refunding Bonds.

17. SUBJECT: GENERAL SERVICES - AUTHORIZATION FOR SINGLE SOURCE PROCUREMENT FOR UPGRADING CONTROL SYSTEMS TO SUPPORT THE EMERGENCY GENERATORS AT EDGEMOOR SKILLED NURSING FACILITY (DISTRICT: 2)

OVERVIEW

The Edgemoor Skilled Nursing Facility located at 655 Park Center Drive, Santee, CA 92071 provides 24-hour long term skilled nursing care for individuals with complex medical needs who require specialized interventions from highly trained staff.

A Skilled Nursing Facility is required to have emergency power available to ensure the continuous operation of critical life safety systems in the event of a power outage. Currently, emergency power is provided via two Kohler diesel powered generators. The control systems for these generators have reached the end of their useful life. Software upgrades and system component replacement are necessary to keep the generators functioning properly and the facility functioning in compliance with the State of California Skilled Nursing Facility operating requirements including the Office of Statewide Health Planning and Development, and the California Department of Public Health, Licensing and Certification Division. Bay City Electric Works is currently the only Kohler authorized sales and service distributor for generators and control systems including transfer switches, switchgear, and related aftermarket parts in California.

Today's request is for Board of Supervisors (Board) approval of a single source procurement of Bay City Electric Works services estimated at \$300,000. This procurement qualifies for an exception to the competitive procurement requirements of Board Policy A-87. Today's action would authorize the County of San Diego to enter into a contract with Bay City Electric Works to upgrade the existing Kohler emergency generator control systems including switchgear software, programmable logical controller, and related component system hardware. Work is expected to take approximately four months following the execution of a service contract.
