**HA1. SUBJECT: FISCAL YEAR 2015-16 HOUSING AUTHORITY BUDGET
(DISTRICTS: ALL)**

OVERVIEW:

This is a request to approve the Housing Authority of the County of San Diego's (Housing Authority) budget for Fiscal Year 2015-16 and take related actions involving Housing Authority programs. The recommended budget will appropriate funds already under contract with the U.S. Department of Housing and Urban Development and approved by the Housing Authority Board of Commissioners.

The Housing Authority is funded primarily by the U.S. Department of Housing and Urban Development and operates several housing programs that benefit extremely low-, very low-, and low-income households in the unincorporated area of the County and in the participating cities of Chula Vista, Coronado, Del Mar, El Cajon, Escondido, Imperial Beach, La Mesa, Lemon Grove, Poway, San Marcos, Santee, Solana Beach, and Vista. All costs of operating these programs are revenue offset. There is no cost to the County General Fund.

FISCAL IMPACT:

If approved, this request will result in costs and revenue of \$138,831,731 in Fiscal Year 2015-16. The funding sources are the U.S. Department of Housing and Urban Development, U.S. Department of Agriculture, County of San Diego Department of Housing and Community Development, Housing Choice Voucher Program Housing Assistance Payment Reserve and Administrative Reserve Funds, Mainstream Administrative Reserve Fund, Moderate Rehabilitation Administrative Reserve Fund, Public Housing Operating Reserve Fund, Real Estate Reserve Fund, Santee Successor Agency, Public Housing Rental, and other miscellaneous revenue.

BUSINESS IMPACT STATEMENT:

This request will have a positive impact on the business community, as the Housing Authority of the County of San Diego (Housing Authority) budget will provide rental income to landlords participating in the Housing Authority Rental Assistance Programs. The Urban County Home Repair Program will provide construction contractors the opportunity to compete for rehabilitation work on privately-owned units.

RECOMMENDATION:

EXECUTIVE DIRECTOR/CHIEF ADMINISTRATIVE OFFICER

1. Approve the Housing Authority Budget for Fiscal Year 2015-16.
2. Establish appropriations of \$138,831,731 for the Housing Authority of the County of San Diego for Fiscal Year 2015-16.
3. Authorize the Director, Department of Housing and Community Development to transfer appropriations within the Housing Authority's three program groupings.

4. Authorize the Chair of the Board of Commissioners, acting on behalf of the Board of Commissioners, to certify the Fiscal Year Public Housing Authority Board Resolution approving the Fiscal Year 2015-16 Housing Authority Budget.
5. Adopt a Resolution entitled: A RESOLUTION OF THE HOUSING AUTHORITY OF THE COUNTY OF SAN DIEGO BOARD OF COMMISSIONERS APPROVING FISCAL YEAR 2015-2016 HOUSING AUTHORITY BUDGET, INCLUDING PUBLIC HOUSING.


