1. SUBJECT: NOTICED PUBLIC HEARING:

AN ORDINANCE TO ADOPT BY REFERENCE THE COUNTY OF SAN DIEGO DEFENSIBLE SPACE FOR FIRE PROTECTION ORDINANCE (DISTRICTS: ALL)

#### **OVERVIEW**

The County of San Diego Board of Supervisors (Board of Supervisors) adopted the Defensible Space for Fire Protection Ordinance (Defensible Space Ordinance) in its current form on May 10, 2011 (9). The Defensible Space Ordinance sets forth various requirements for property owners to increase the resilience of their homes. The ordinance applies within: (1) all unincorporated areas of the County of San Diego (County) outside of fire protection or municipal water districts providing fire protection services, and (2) any fire protection or municipal water district providing fire protection services if the district adopts the Defensible Space Ordinance by reference through enactment of its own district ordinance.

The Defensible Space Ordinance applied to the unincorporated areas of the County through the former County Service Area No. 135 (CSA 135). With the recent formation of the San Diego County Fire Protection District (SDCFPD), the SDCFPD Board of Directors (Board of Directors) is requested to enact a district ordinance adopting the County's Defensible Space Ordinance by reference. The jurisdictional footprint of CSA 135 and SDCFPD are identical, and therefore there will be no change in the defensible space requirements for residents and property owners within SDCFPD. Administrative and enforcement authority of the Defensible Space Ordinance may be delegated to the County through a memorandum of understanding between the County and SDCFPD, and is being presented to the Board of Directors as a separate action today.

Today's requested action is for the Board of Directors to enact a district ordinance adopting by reference the County of San Diego's Defensible Space Ordinance.

#### RECOMMENDATION(S) EXECUTIVE DIRECTOR

On June 29, 2021:

- 1. Find that the proposed action is not subject to or exempt from California Environmental Quality Act (CEQA) review pursuant to CEQA Guidelines sections 15061(b)(3) and 15060(c)(3). The proposed action is not a project as defined by CEQA and it can be seen with certainty that there is no possibility that these actions will have a significant effect on the environment.
- 2. Approve the introduction of the Ordinance (first reading), read title, and waive further reading of the Ordinance: AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE SAN DIEGO COUNTY FIRE PROTECTION DISTRICT TO ADOPT BY REFERENCE THE COUNTY OF SAN DIEGO DEFENSIBLE SPACE FOR FIRE PROTECTION ORDINANCE.

If, on June 29, 2021, the San Diego County Fire Protection District Board of Directors takes action as recommended, then on July 13, 2021, consider and adopt (second reading): AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE SAN DIEGO COUNTY FIRE PROTECTION DISTRICT TO ADOPT BY REFERENCE THE COUNTY OF SAN DIEGO DEFENSIBLE SPACE FOR FIRE PROTECTION ORDINANCE.

#### **EQUITY IMPACT STATEMENT**

Taking the proposed action will result in increased community resilience and decreased likelihood of the need to rebuild whole communities after devastating wildfires. There are 33,544 parcels with 24,759 structures within the SDCFPD that will be affected. Of the affected parcels, 93% are within areas considered High or Very High Fire Hazard Severity Zones. In addition, data presented by the San Diego Local Agency Formation Commission (LAFCO) in May 2020 found that more than four-fifths of the SDCFPD jurisdictional area qualifies as a disadvantaged unincorporated community. This designation is based on annual median income. It is influenced in part by a higher level of unemployment and increased number of individuals collecting retirement compared to county-wide LAFCO data. This shows that there are communities that could be devastated by both the physical and financial risks of wildfire.

This recommendation will require individuals to continue performing defensible space work on their properties or pay for the work to be completed. Based on the jurisdictional area's demographics, SDCFPD works with local fire safe councils and other community organizations to assist individuals who are differently abled, elderly, or do not have the financial resources to perform defensible space work themselves. SDCFPD and CAL FIRE San Diego Unit staff refer individuals to grant-funded programs that assist in performing this work. By referring individuals to community organizations, SDCFPD aims to reduce unintended consequences of ability, age, and financial resources that can be a prohibitive factor to community resiliency, though these organizations cannot guarantee financial resources to assist every eligible individual.

Finally, to ensure community members know the requirements of the Defensible Space Ordinance and community resources available to assist achieving them, SDCFPD, in conjunction with the CAL FIRE San Diego Unit, will visit every parcel in its jurisdiction on a triennial basis. These visits ensure parcels are compliant with the Defensible Space Ordinance and provide an opportunity to engage with community members on further steps they can take to increase wildfire readiness.

#### **FISCAL IMPACT**

There is no fiscal impact associated with the enactment of a district ordinance adopting by reference the County of San Diego Defensible Space for Fire Protection Ordinance. There will be no change in net General Fund costs and no additional staff years.

2. SUBJECT: SAN DIEGO COUNTY FIRE PROTECTION DISTRICT - JOINT AGREEMENT BETWEEN THE COUNTY OF SAN DIEGO AND SAN DIEGO COUNTY FIRE PROTECTION DISTRICT (DISTRICTS: ALL)

#### **OVERVIEW**

On April 6, 2021 (1), the Board of Supervisors of the County of San Diego (County) and Board of Directors of the San Diego County Fire Protection District (SDCFPD) authorized the County's Chief Administrative Officer and SDCFPD's Executive Director or designee to enter into an agreement outlining the organizational and financial structure between the two entities to ensure the continuance of services within the SDCFPD jurisdictional area.

Today's proposed action is to memorialize the agreement and designate the terms of the relationship between the County and SDCFPD, including the services to be provided by the County for the benefit of the SDCFPD, SDCFPD responsibilities, and use of County staff by SDCFPD.

## RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

Acting as the Board of Directors of the San Diego County Fire Protection District:

- 1. Find that the proposed actions are not subject to the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(5) because they involve organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment.
- 2. Authorize the Deputy Executive Director or designee to take all actions necessary to enter into and implement an agreement formalizing the organizational and financial structure with the County, and amend as needed (Attachment A, on file with the Clerk of the Board).

#### **EQUITY IMPACT STATEMENT**

This Operational Plan is intended to provide resources to address inequities in County services by engaging community voices, enhancing data analysis to identify disparities, developing meaningful outcome indicators, and creating a County government culture of equity, belonging, and racial justice.
