IA1. SUBJECT: ADOPTION OF FINAL FISCAL YEAR 2015-16 ADMINISTRATIVE BUDGET FOR THE IN-HOME SUPPORTIVE SERVICES PUBLIC AUTHORITY

OVERVIEW:

On May 5, 2015 (IA01), the Governing Body received the recommended County of San Diego In-Home Supportive Services (IHSS) Public Authority administrative budget for Fiscal Year 2015-16 and set June 3, 2015 as the date of the public hearing for the budget. This item requests adoption of the Fiscal Year 2015-16 final administrative budget for the Public Authority by resolution, which is required by State statute.

The IHSS program provides in-home assistance to approximately 25,900 low-income, aged, blind, and disabled individuals enabling many to remain safely in their home and reducing the need for more costly placements in nursing homes or other care facilities. The Public Authority provides a number of services to the 20,600 IHSS home care workers which include payroll services and funding for health and dental benefits for these workers, as well as home care worker enrollment including criminal background checks. The Public Authority also provides Registry services to IHSS recipients in need of a caregiver.

FISCAL IMPACT:

The recommended action results in the formal adoption of the \$14,039,468 budget for the Public Authority for Fiscal Year 2015-16. This provides spending authority for the Public Authority.
