1. SUBJECT: DISTRICT ATTORNEY - AUTHORIZATION FOR A SINGLE SOURCE SERVICE CONTRACT FOR IMPROVING CRIMINAL JUSTICE RESPONSES TO CRIME VICTIM SERVICES (DISTRICTS: ALL)

OVERVIEW

The County of San Diego District Attorney's Office (SDCDA) is the largest local provider of services to victims and families, assisting approximately 15,000 crime victims annually. On January 28, 2020 (13), the Board of Supervisors (Board) authorized the lease agreement for the District Attorney's North County Family Justice Center (One Safe Place) to establish multi-disciplinary partnerships with community providers and deliver coordinated and effective services to victims and families, including but not limited to victims of child abuse, sexual assault, domestic violence, human trafficking and elder abuse.

One primary partnership at One Safe Place will be established with Palomar Health Forensic Health Services (Palomar) due its long history of providing services to victims and their participation and collaboration with advocacy, investigative, and prosecutorial agencies. Palomar's expertise in working with underserved and marginalized victim populations provides a unique opportunity, post examination, for immediate follow up care and engagement in safety planning and addressing the therapeutic treatment and other needs of victims and families.

If approved, today's action would authorize the Director, Department of Purchasing and Contracting to enter into a single source service contract with Palomar to provide supportive services to include but not limited to needs assessment and case management, therapeutic treatments, triage and referral services, and other ancillary services for crime victims and their families.

**RECOMMENDATION(S)
DISTRICT ATTORNEY**

In accordance with Board Policy A-87, Competitive Procurement, approve and authorize the Director of the Department of Purchasing and Contracting to enter into negotiations with Palomar Health, Inc., and subject to successful negotiations and a determination of a fair and reasonable price, award a contract for the delivery of supportive and ancillary services for crime victims and their families at One Safe Place, for up to five years anticipated to begin January 1, 2021 and ending December 31, 2026 and an additional six months if needed, and to amend the contract as needed to reflect changes to service needs or funding requirements subject to the approval of the District Attorney.

FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2020-21 Operational Plan for the District Attorney's Office. If approved, this request will result in estimated annual costs and revenue of \$1.5 million. The funding source is Proposition 172 Special Revenue Fund. Subsequent years funding will be included in the future operational plans. There will be no change in net General Fund cost and no additional staff years.

OVERVIEW

The County of San Diego (County), as a recipient of the U.S. Department of Housing and Urban Development (HUD) entitlement program funding, is required to develop a five-year Consolidated Plan for long term planning purposes and is also required to develop an Annual Plan in the spring of each year to identify specific projects to be funded during the upcoming fiscal year. Administered by the Health and Human Services Agency, Housing and Community Development Services (HCDS), funds from four federal entitlement programs including the Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Housing Opportunities for Persons with AIDS (HOPWA) and Emergency Solutions Grant (ESG) support a wide variety of housing and community development activities in the region.

During the development of the Annual Plan, the County opens a public comment period and holds a public meeting within its jurisdiction to obtain resident input as part of the Needs Assessment Stage. A total of two public hearings per year must be held to obtain citizens' views and to respond to proposals and questions, to be conducted at a minimum of two different stages of the program year, which are statutorily required by HUD. Today's hearing serves as the first hearing of the program year and provides an opportunity for the Board of Supervisors to receive public comment which will guide the development of the draft Fiscal Year 2021-22 Annual Plan.

Today's action will also authorize HCDS to amend the Fiscal Year 2020-21 Annual Plan to allocate funding for the necessary roof repairs and/or replacement to a County owned facility that is leased to Fraternity House, a HOPWA program funded residential care facility for the chronically ill, and to receive an allocation of Community Development Block Grant-Disaster Recovery (CDBG-DR) funds, which are administered by the State of California, Department of Housing and Community Development (State HCD).

Today's actions support the County's *Live Well San Diego* vision by ensuring low-income residents have access to suitable living environments as well as to enhance the quality of life for residents by encouraging decent and affordable housing.

RECOMMENDATION(S)

CHIEF ADMINISTRATIVE OFFICER

1. Find in accordance with Section 15061(b)(3) of the California Environmental Quality Act (CEQA) Guidelines that it can be seen with certainty that there is no possibility that the activities in question may have a significant effect on the environment, and that it is therefore, exempt from CEQA review.
2. Hold this public hearing to receive public input on housing and community development needs and priority non-housing community development needs for consideration in development of the Fiscal Year 2021-22 Annual Plan Strategy.
3. Receive public comment on the reallocation of Housing Opportunities for Persons with AIDS (HOPWA) program funds and amendment to the Fiscal Year 2020-21 County of San Diego Consortium Annual Plan.
4. Approve and authorize an amendment to the Fiscal Year 2020-21 County of San Diego Consortium Annual Plan for the reallocation of \$180,000 in HOPWA program funds for the necessary roof repairs and/or replacement at Fraternity House.

FISCAL IMPACT

Funds for these requests are partially included in the Fiscal Year (FY) 2020-21 Operational Plan for the Health and Human Services Agency (HHS). If approved, these requests will result in costs and revenues of \$180,000 for the reallocation of Housing Opportunities for Persons with AIDS (HOPWA) to cover necessary roof repairs and/or replacement and \$405,845 for the Community Development Block Grant-Disaster Recovery (CDBG-DR) program to support multi-family housing development for a total of \$585,845. The funding sources are HOPWA and CDBG-DR. There will be no change in net General Fund costs and no additional staff years.

BUSINESS IMPACT STATEMENT

The proposed recommendation will have a positive impact on the business community. HUD funded projects typically include construction that will be implemented by private firms selected through competitive bid processes.

OVERVIEW

A novel coronavirus (COVID-19) was detected in Wuhan City, Hubei Province in China in December 2019. Since then, the virus has rapidly spread across the globe, resulting in the World Health Organization (WHO) declaring COVID-19 a pandemic on March 11, 2020.

On February 14, 2020, the San Diego County Public Health Officer issued a Declaration of Local Health Emergency, pursuant to California Health and Safety Code Section 101080. Additionally, on that day, pursuant to California Government Code 8630, the Chief Administrative Officer, serving as the County of San Diego (County) Director of Emergency Services and as the Coordinator of the Unified San Diego County Emergency Services Organization, issued a Proclamation of Local Emergency regarding COVID-19.

The County continues to make significant efforts to slow the spread of COVID-19. Today's action requests the Board of Supervisors (Board) receive an update on the local COVID-19 response. It is also recommended that the Board take any other action necessary to address the COVID-19 pandemic emergency response. Today's proposed actions support the County's *Live Well San Diego* vision by protecting the health of residents against the COVID-19 pandemic.

RECOMMENDATION(S)

CHIEF ADMINISTRATIVE OFFICER

1. Receive an update on the COVID-19 response.

FISCAL IMPACT

The County of San Diego (County) has been allocated a total of \$387.8 million of CARES Act, Coronavirus Relief Fund (CRF) revenue to address the COVID-19 emergency. The County of San Diego Board of Supervisors established a CARES Act framework for use of these funds and allocated the entire \$387.8 million for an array of programs and response efforts. These costs include public health and medical services, testing, tracing, treatment, temporary housing assistance, sanitation, food distribution services, allocations to the 17 cities that did not receive direct CARES Act funds, childcare vouchers, childcare provider grant program, economic stimulus program, child welfare outreach, Behavioral Health telehealth, compliance efforts, rental assistance and administrative support. Unless there is legislative change, the CARES Act funding must be spent by December 30, 2020, and any unspent dollars are to be returned to the US Treasury. Today's update will include the latest spending estimates and trends for these programs, including any anticipated over or under spending for any of the components of the CARES Act framework so that the Board can consider if any additional action is needed to ensure we maximize the full use of the CARES Act funds. In addition, the County will continue to pursue other federal and State stimulus revenue, including FEMA.

BUSINESS IMPACT STATEMENT

This action will help support individuals, families and small businesses impacted by COVID-19.

(DISTRICTS: ALL)**

OVERVIEW

Pursuant to California Elections Code Section 21550-21553 and the Charter of the County of San Diego, the responsibility to draw the new supervisorial district boundaries will be done by the County's Independent Redistricting Commission (IRC). From May 18, 2020 through July 31, 2020, the Clerk of the Board of Supervisors received applications from San Diego County residents to serve on the IRC. The Clerk of the Board of Supervisors verified the applicants' voter registration status with the Registrar of Voters, rated the applications in accordance with the requirements listed in the aforementioned Elections Code, and identified the 60 most qualified applicants.

The Clerk of the Board of Supervisors is required to select, by random drawing, eight applicants from the pool of qualified applicants to serve on the IRC. The random drawing will be conducted in two rounds. The first round will select one commissioner for each of the five supervisorial districts. The second round will select three commissioners from the pool of remaining applicants.

The eight randomly selected commissioners will meet to select six more commissioners from the pool of qualified applicants to form a commission with 14 citizens. The full commission must be created no later than December 31, 2020.

RECOMMENDATION(S)

CHIEF ADMINISTRATIVE OFFICER

1. Observe a random drawing conducted by the Clerk of the Board of Supervisors to select one commissioner for the County's Independent Redistricting Commission from each of the five supervisorial district sub pools established by the Clerk.
2. After completing the first random drawing, observe a second random drawing conducted by the Clerk of the Board of Supervisors from all the remaining applicants, without respect to sub pools, to select three additional commissioners.
3. Establish appropriations of \$750,000 in the Finance and General Government Group Executive Office, Services & Supplies as a preliminary budget for required support of the County's Independent Redistricting Commission in Fiscal Year 2020-21 based on available General Fund fund balance. **(4 VOTES)**

FISCAL IMPACT

There is no fiscal impact associated with the Board's observation of the random drawing to select eight commissioners for the County's Independent Redistricting Commission. There will be no change in net General Fund cost and no additional staff years.

Funds for support of the Commission's tasks are not included in the Fiscal Year 2020-21 Operational Plan in the Finance and General Government Group Executive Office. If approved, this request will result in costs of \$750,000 in Fiscal Year 2020-21 and will be funded by available General Fund fund balance. County staff may return to the Board to request additional appropriations at a later date, subject to the needs and direction of the full Commission once seated. There will be no additional staff years.

OVERVIEW

The Board of Supervisors serves as the Code Reviewing Body for any local government, other than cities, with jurisdiction wholly within the County, per Government Code Section 82011. The recommended action would approve the adoption of the new Conflict of Interest Codes submitted by the Leon L. - 8. SUBJECT: GENERAL SERVICES - AUTHORIZATION TO ADVERTISE AND AWARD A CONSTRUCTION CONTRACT FOR THE INSTALLATION OF A NEW EMERGENCY GENERATOR AT THE JULIAN FIRE STATION (DISTRICT: 2)**

OVERVIEW

The County of San Diego employs a comprehensive approach to emergency and disaster response and recovery. Fire stations are a key component that makes these services available. On April 8, 2019, the San Diego Local Agency Formation Commission (LAFCO) certified the dissolution of the Julian Cuyamaca Fire Protection District (JCFPD) and expansion of County Service Area 135's latent power fire protection and emergency medical service area to include former Julian Cuyamaca Fire Protection District territory. As a result, the County of San Diego acquired Julian Fire Station 56, which was previously owned and operated by JCFPD and its volunteer firefighters. As a part of this acquisition, it is the County of San Diego's responsibility to assure that its fire stations are equipped with the necessary tools to provide timely and effective emergency medical services and fire protection to the residents of County Service Area 135. This includes the installation of a permanent emergency generator at Julian Fire Station 56 to ensure these services continue during a power outage.

Today's request is for the Board of Supervisors to authorize the Director, Department of Purchasing and Contracting to advertise and award a construction contract for the installation of a permanent emergency generator at the Julian Fire Station. If approved, construction is expected to begin in January 2021 with estimated completion in April 2021.

RECOMMENDATION(S)

CHIEF ADMINISTRATIVE OFFICER

1. Find that the proposed project for the generator work at the Julian Fire Station is exempt from the California Environmental Quality Act (CEQA) review pursuant to CEQA Guidelines Section 15301.

13. SUBJECT: CARES ACT FUND REALLOCATION IN RESPONSE TO UNSPENT APPORTIONMENTS (DISTRICTS: ALL)

OVERVIEW

COVID-19 has not only been a debilitating disease to many within our region, and the world, but has also created an economic crisis. This economic crisis has led to housing and food insecurity, business closures, unemployment, health impacts, and other wellness issues. To help combat these adverse impacts, the County of San Diego (County) received critical dollars from the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act fund was apportioned to ensure equitable support for our communities, businesses, and the constituents we serve. To date, a portion of the CARES ACT dollars have not been expended. Previous actions from the Board of Supervisors (Board) that have not been totally expended include: \$8.6 million for the Great Plates program; \$5 million for telehealth behavioral health; \$7.5 million for the Test, Trace, Treat Strategy (T3); \$1.6 million for child welfare economic stimulus services; and \$1.1 million in interest gained on the CARES Act fund. These figures are estimates based on the best information to date and will be verified prior to the Board

meeting. Today's action would reallocate the unspent CARES Act funds to date to ensure the County receives full benefit of the CARES Act relief fund without expiration and to prevent the requirement to relinquish unspent funds.

RECOMMENDATION(S)
VICE-CHAIRMAN JIM DESMOND

1. Approve the following reapportionments to the CARES Act Funding:
 - a. \$8.6 million from the Great Plates 1 and 2 Programs to food banks in the San Diego region.
 - b. \$5 million from Telehealth Behavioral Health to rental assistance for behavioral health patients.
 - c. \$7.5 million from unspent T3 and \$1.6 million from unspent child welfare economic stimulus services to the Economic Stimulus Program (divided equally among the five districts).

14. SUBJECT: RESOLUTION REQUESTING LOCAL CONSULTATION AND THE USE OF HOSPITAL CAPACITY METRICS FOR CALIFORNIA'S COVID-19 HEALTH ORDER (DISTRICTS: ALL)

OVERVIEW

On August 29, 2020, the State implemented its Blueprint for a Safer Economy (Blueprint) that places each of California's 58 counties into one of four color-coded tiers. Under the Blueprint, the level of COVID-related restrictions for businesses, schools, places of worship in each county are based on countywide case rates per 100,000 people (which are adjusted based on levels of testing in the county), the countywide positivity rate and health equity.

Since the beginning of the pandemic, the Public Health Officer for the County of San Diego, Dr. Wilma Wooten, has been working closely with the California Department of Public Health (CDPH). As the Public Health Officer for San Diego County, Dr. Wooten is responsible for the public health of the fifth most populous county in the nation-a population larger than twenty states.

The County of San Diego is fully committed to safe re-opening that does not overload our hospital system or increase the COVID-19 death rate in our region. While the Blueprint focuses on cases, it does not account for hospital capacity and readiness to provide medical treatment. Dr. Wooten has been working closely with CDPH to request that the Blueprint provide an adjustment based upon hospital capacity. This strategy would fully align with the Governor's original Proclamation of a State of Emergency, which not only focused on cases but was out of a concern that "the number of persons requiring medical care may exceed locally available resources."

The devastating impacts that interventions have on businesses and their workforce has been severe. It is critical that metrics that impact 3.3 million San Diegans, be based on data and information that adequately reflects local conditions. Despite having robust contact tracing, large-scale testing capacity, suitable hospital and medical capacity, focused local non-pharmaceutical interventions, compliance programs, and regional partnerships, the current metrics and adjustment factors can still force small businesses to close.

Today's action would direct the Chief Administrative Officer to draft a resolution of the Board of Supervisors which ratifies the Public Health Officer's professional guidance and provides the added value of the full support of the Board of Supervisors.

- 15. SUBJECT: GENERAL SERVICES - RATIFICATION OF EMERGENCY CONTRACT AND REPORT OF ACTION PURSUANT TO PUBLIC CONTRACT CODE SECTION 22050 FOR EMERGENCY REPAIRS AT THE HEALTH AND HUMAN SERVICES AGENCY HEALTH SERVICES COMPLEX, 3851 ROSECRANS STREET (DISTRICT: 4)**

OVERVIEW

On September 25, 2020 the two chillers at the Health and Human Services Agency (HHS) Health Services Complex (HSC), located at 3851 Rosecrans Street, San Diego experienced a catastrophic failure causing them to operate at fifty percent capacity. These catastrophic

failures have caused chiller temperatures to rise upwards of 66 degrees and fluctuate with outside weather temperatures. These temperatures affect the cooling and the ability to maintain Indoor Air Quality (IAQ) in accordance with American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRE) Standards 55 and 62.1. This impacts the Public Health core functions at this location including the San Diego County Psychiatric Hospital which has a dependency on these chillers. To ensure the continuity of operations, a temporary chiller is being secured. To mitigate the risk of further issues and ensure the continued provision of essential public services, it was necessary to declare an emergency and forgo competitive solicitation of the repair, remediation, and restoration work. In accordance with County Administrative Code Section 402, "Emergency Purchases," a notice to proceed for emergency repairs was issued to ACCO Engineered Systems, Inc., a contractor with previous County facility experience.

Total repair cost is estimated at \$210,000.

In accordance with Public Contract Code Section 22050, staff requests the Board of Supervisors (Board) to ratify the emergency contract and receive the report set forth in this Board letter that emergency repair work at the HSC did not permit a delay resulting from competitive solicitations for bids and that the immediate award of a contract was necessary to respond to the emergency. The Board is also requested to find that there is a need to continue the emergency repair of the Chillers.

RECOMMENDATION(S)

CHIEF ADMINISTRATIVE OFFICER

1. Find the proposed project is statutorily exempt from California Environmental Quality Act (CEQA) review pursuant to Sections 15269(b) and 15301 of the CEQA Guidelines because the proposed project is for emergency repairs to a publicly owned service facility necessary to maintain service essential to the public health, safety or welfare, and because it consists of the minor alteration of existing public facilities involving negligible or no expansion of existing use.
2. Pursuant to Section 402 of the County Administrative Code, ratify the contract with ACCO Engineered Systems, Inc. for emergency repairs of the Health Services Complex chillers, on the basis that public interest and necessity demanded immediate expenditure of funds on an emergency basis without competitive bidding.
3. Pursuant to Public Contract Code Section 22050(b)(3)(a), receive the report set forth in this Board letter that the emergency repair of the Health Services Complex chillers did not permit a delay resulting from competitive solicitations for bids and that the immediate award of a contract was necessary to respond to the emergency.
4. Pursuant to Public Contract Code Section 22050(c)(2)(a), find that there is a need to continue emergency repairs of the Health Services Complex chillers without giving notice for bids to let a contract. **(4 VOTES)**

FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2020-21 Operational Plan for the Department of General Services Facilities Management Internal Service Fund. If approved, this request will result in costs and revenue of approximately \$210,000. The funding source are charges to the client department. There will be no change in net General Fund cost and no additional staff years.
