#### 1. SUBJECT: ADMINISTRATIVE ITEM:

SECOND CONSIDERATION AND ADOPTION OF ORDINANCE: TRAFFIC ADVISORY COMMITTEE AND RELATED CEQA EXEMPTION (09/27/2023 - ADOPT RECOMMENDATIONS INCLUDING INTRODUCING AN ORDINANCE; 10/25/2023 - SECOND READING OF AN ORDINANCE, UNLESS ORDINANCE IS MODIFIED ON SECOND READING) (DISTRICTS: 1, 4, & 5)

#### **OVERVIEW**

On September 27, 2023 (4), the Board of Supervisors took action to further consider and adopt the ordinance on October 25, 2023.

The Traffic Advisory Committee (TAC) supports the Department of Public Works (DPW) traffic engineering program. The TAC was established by the Board of Supervisors (Board) in the 1960s to provide traffic regulations and recommendations within the unincorporated areas of the region. To be effective, TAC proposes policies that will enhance safety, reduce congestion, and be legally enforceable. The TAC meets every six weeks to review proposed additions, deletions, or changes to regulatory traffic control devices such as speed limits, stop signs, traffic signals, and parking regulations on County of San Diego (County) maintained roads. Upon receipt of a request or recommendation for the implementation of a traffic safety measure in unincorporated areas, the TAC reviews and investigates the requested item, including engineering and traffic condition studies. TAC recommendations are provided to the Board for consideration.

The TAC recommends the Board act on four items from the June 9, 2023, TAC meeting agenda:

Approval of Item 1-A on Grand Avenue in La Presa (District 1), Item 5-A on Fruitvale Road in Valley Center (District 5), and Item 5-B on Sunset Drive in San Pasqual (District 5) would support speed enforcement which enhances roadway safety and retains mobility. Properly posted speed limits provide feedback to drivers to improve traffic safety, reduce the number and severity of collisions, and allow for fair enforcement.

Approval of Item 4-A at Hilton Head Road and Inverary Drive in Hillsdale (District 4) will provide safety enhancement measures for pedestrians, bicyclists, and all other roadway users by assigning a full stop to all approaches at intersections. Properly posted stop controls at intersections reduce the number and severity of collisions by assuring reasonable drivers enter intersections at a low speed and have more time to take heed of the traffic situation.

The Board's action on Item 4-A at Hilton Head Road and Inverary Drive in Hillsdale (District 4) does not revise the San Diego County Code of Regulatory Ordinances (County Code) and therefore does not require a second reading of an ordinance. Board direction on September 27, 2023, would allow for implementation by DPW.

The Board's action on Item 1-A on Grand Avenue in La Presa (District 1), Item 5-A on Fruitvale Road in Valley Center (District 5), and Item 5-B on Sunset Drive in San Pasqual (District 5) would introduce an ordinance to amend speed limit zones. This action would revise the County Code and requires two steps. On September 27, 2023, the Board would consider the TAC items. If the Board takes action as recommended on September 27, then on October 25, 2023, a second reading and adoption of ordinances amending the County Code would be necessary to implement the Board's direction. If the proposed ordinance is altered on September 27, 2023, then on that date a subsequential meeting date will be selected for the ordinance's adoption.

#### **CHIEF ADMINISTRATIVE OFFICER**

Consider and adopt the following Ordinance:

ORDINANCE AMENDING SECTIONS 72.163.55., 72.161.25.2. AND 72.161.27. OF THE SAN DIEGO COUNTY CODE RELATING TO SPEED LIMITS ON COUNTY MAINTAINED ROADS IN SAN DIEGO COUNTY. (Items 1-A, 5-A, & 5-B).

#### **EQUITY IMPACT STATEMENT**

The review of traffic signs, intersection controls, and roadway markings supports vehicle safety on County of San Diego-maintained roads. The transportation system must be safe for all road users, for all modes of transportation, in all communities, and for people of all incomes, races, ethnicities, ages, and abilities. Understanding travel patterns, where correctable crashes are occurring, and the disproportionate impacts on certain communities will allow the Department of Public Works to identify actions to address the underlying causes, improve safety, and ensure there is justice in the enforcement of traffic regulations.

DPW's Local Roadway Safety Plan reviews correctable collisions along road segments within the unincorporated areas of the region and utilizes the Healthy Places Index (3.0) and CalEnviroScreen 4.0 to ensure underserved populations are prioritized. The Traffic Advisory Committee (TAC) relies on the Local Roadway Safety Plan and performs reviews of regulatory traffic control devices such as signs and markings. While adherence to sign and marking standards developed by the California Department of Transportation is crucial to obtaining the compliance of the majority of drivers, the TAC also relies on various community engagement methods such as the Tell Us Now! Mobile app, toll-free hotlines, and a customer service request program to intake reports on a wide variety of traffic concerns and ensure the concerns are addressed.

#### SUSTAINABILITY IMPACT STATEMENT

The Traffic Advisory Committee has made addressing sustainability a top priority by partnering with local communities and industry leaders in a public forum every six weeks to find timely, reasonable, and cost-effective in-road traffic solutions that reduce costly traffic delays, mitigate vehicle idling to reduce emissions, improve fire response times and regional readiness, and ensure justice in enforcement of traffic regulations.

#### FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2023-24 Operational Plan in the Department of Public Works Road Fund. If approved, this request will result in costs and revenue of \$7,760 in Fiscal Year 2023-24 for staff time, materials, and supplies. The funding source is State Highway User Tax Account. There will be no change in net General Fund cost and no additional staff years.

#### 2. SUBJECT: NOTICED PUBLIC HEARING:

EAST COUNTY ADVANCED WATER PURIFICATION PROJECT OPEN SPACE VACATION AND AN ADDENDUM TO PREVIOUSLY ADOPTED MITIGATED NEGATIVE DECLARATIONS, PDS2023-VAC-23-001 AND PDS2023-ER-23-14-011; LAKESIDE COMMUNITY PLAN AREA (9/27/2023 - SET HEARING; 10/25/2023 - HOLD HEARING) (DISTRICT: 2)

#### **OVERVIEW**

On September 27, 2023 (6), the Board of Supervisors set a hearing for October 25, 2023.

Planning & Development Services (PDS) is processing a request from the Padre Dam Municipal Water District (Applicant) to vacate an Open Space Easement Vacation (Vacation) (see Attachment B, open space area to be vacated) for a permanent water and pipeline easement for the East County Advanced Water Purification project (Project) that is located on a privately owned parcel (see Attachment F, ownership disclosure form) in the Lakeside Community Plan Area (see Attachment A, vicinity map).

The Vacation is proposed within a 0.25 acres area of a 10.47-acre vacant and undeveloped open space parcel that is located west of El Monte Road and north of Lake Jennings Park Road along Laurel Canyon Road in the Lakeside Community Planning Area, within unincorporated San Diego county (APN 395-014-24). The open space parcel is privately owned, and the property owner has authorized Padre Dam Municipal Water District to process the requested vacation on their property. The vacation was granted as part of Final Map 15458 in a document recorded on August 11, 2005 (Doc No. 2005-0687366, see Attachment E). The Project proposes to vacate a 0.25-acre portion Biological Open Space Easement, which was dedicated to comply with the California Environmental Quality Act (CEQA) and protect the biological resources within the area. The Project originally planned and studied the installation of the underground pipeline through this area. This Vacation is required to allow the encroachment and construction of a portion of the Project, which includes an underground pipeline within the existing Open Space Easement, identified in Attachment B.

The Project is presently under construction and will treat wastewater generated in the service areas of the Joint Power Authority, a partnership between public agencies (Padre Dam Municipal Water District, City of El Cajon, County of San Diego, and Helix Water District), and recycle the water using state-of-the-art technology to create a sustainable supply of drinking water for residents of East County, including the unincorporated community of Lakeside. If the Vacation is approved, construction of the pipeline can continue at the project site. If the Vacation is not approved, the Project would need to be redesigned to avoid the Open Space Easement, resulting in delays to construction and redesign of the Project. The existing use on the subject parcel will not change and the vegetation in the vacated area will be restored once the Project is completed in 2025.

If the item is not heard by the Board on September 27, 2023, the first hearing of the item would not be until October 11, 2023, which would delay final action on the item until November 2023, resulting in a significant delay to the construction and the overall project timeline. Docketing the item for a later hearing would cause further delays to construction, and the overall project

schedule, and further impact the communities surrounding the project. The longer the item is delayed, the more difficult it is for the construction team to return to the area to complete the remaining work. The delay would impact the completion of this important and critical regional project, increasing costs on a taxpayer funded effort and delaying this public infrastructure project that will provide clean water to the public.

Today's request requires two steps: September 27, 2023, it is requested that the Board set a date for a public hearing on October 25, 2023, and provide public notice of that hearing, which includes posting at the project site. If the Board takes action recommended on September 27, 2023, then on October 25, 2023, it is requested that the Board consider and adopt a resolution to vacate a portion of the referenced open space easement, record A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO VACATING A PORTION OF THE OPEN SPACE EASEMENT.

### RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Adopt the environmental findings, which include findings in accordance with Section 15162 and 15164 of the California Environmental Quality Act (CEQA) Guidelines that there are no substantial changes in the East County Advanced Water Purification project (Project) or in the circumstances under which the Project is undertaken that involve significant new environmental impacts which were not considered in the previously adopted Mitigated Negative Declaration (MND) completed in 2018 and Subsequent MND completed in July 2022, that there is no substantial increase in the severity of previously identified significant effects, and that no new information of substantial importance has become available since the MNDs were adopted (Attachment C).
- 2. Adopt the Resolution entitled: A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN DIEGO VACATING A PORTION OF THE OPEN SPACE EASEMENT PDS2023-VAC-23-001 (Attachment D).
- 3. Direct the Clerk of the Board to record the Resolution pursuant to the Streets and Highways Code Section 8325.

#### **EQUITY IMPACT STATEMENT**

This resolution will provide public benefit through use of the lands made available by the vacation for the purposes of facilitating a new local drinking water supply. The proposed Vacation is in the public interest because it will allow the construction of a pipeline that will be used to reduce the amount of wastewater discharged into the ocean and provide a new local water supply for East County. Further, the vacated area will be restored and revegetated to open space.

#### SUSTAINABILITY IMPACT STATEMENT

The proposed action to vacate an existing open space easement will allow the construction of a pipeline used to reduce the amount of wastewater discharged into the ocean and provide a new sustainable local water supply for east county. The area to be vacated will also be restored and revegetated back to open space after the pipeline is installed, so the area will continue to function as open space.

#### FISCAL IMPACT

Funds for this request are included in the Fiscal Year 2023-24 Operational Plan in Planning & Development Services. If approved, this request will result in costs and revenue of approximately \$5,000 and will cover the staff time involved with preparing the resolution, public notice, Board letter, and public hearing documents. The funding source is provided by the Joint Power Authority. There will be no change in net General Fund cost and no additional staff years.

# 3. SUBJECT: SEMI-ANNUAL REPORT OF GIFTS AND DONATIONS TOTALING OVER \$5,000 TO THE DEPARTMENT OF PARKS AND RECREATION AND RELATED CEQA EXEMPTION (DISTRICTS: ALL)

#### **OVERVIEW**

The County of San Diego (County) Department of Parks and Recreation (DPR) enhances the quality of life in the San Diego region by providing exceptional parks and recreation experiences and preserving the significant natural resources so that people can enjoy clean air, clean water, rich biodiversity, and access to open space. DPR's ability to provide exceptional customer service to millions of patrons each year is supported by donations from the San Diego County Parks Society (Parks Society). The Parks Society is a nonprofit organization that was established in 1980 to support and improve DPR's vast park system. The Parks Society's support through donations helps to maintain and operate DPR parks and assists with ongoing and expanded programming.

Board of Supervisors (Board) Policy A-112, Acceptance and Use of Gifts and Donations, permits the acceptance of donations by the administrative head of each department of the County. County Administrative Code Section 66, Acceptance of Gifts, requires Board ratification of the acceptance of such gifts and approval prior to the expenditure of the gift if the amount exceeds \$5,000.

During the period of January 1, 2023 to June 30, 2023, DPR received donations from the Parks Society totaling \$47,492.17. These donations provided the materials and funding for multiple holiday events, active recreational activities and equipment, educational programs, and animal care at parks throughout the County. This includes only one donation over the \$5,000 amount (\$6,380.02) to purchase a replacement bronze historic site marker for Los Peñasquitos Park. A complete list of programs receiving donations, donation types, and parks supported by the Parks Society is shown in Attachment A.

Today's proposed action is to accept DPR's Report of Gifts and Donations for the period of January 1, 2023 to June 30, 2023, from the Parks Society of \$47,492.17, including the ratification for the single donation over \$5,000 to purchase a plaque for Los Peñasquitos Park. There is no fiscal impact associated with these recommendations. There will be no change in net General Fund cost and no additional staff years.

### RECOMMENDATION(S) CHIEF ADMINISTRATIVE OFFICER

- 1. Find that the proposed actions are not subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Sections 15060(c)(2) and (3) and 15378(b)(5).
- 2. In accordance with County of San Diego (County) Administrative Code Section 66, *Acceptance of Gifts* and Board of Supervisors (Board) Policy A-112, Acceptance and Use of Gifts and Donations, accept the County Department of Parks and Recreation Report of Gifts and Donations from the San Diego County Parks Society for the period of January 1, 2023 to June 30, 2023, totaling \$47,492.17.
- 3. In accordance with County Administrative Code Section 66 and Board Policy A-112, ratify the acceptance of the gift and donation of \$47,492.17 from the San Diego County Parks Society on June 21, 2023.

#### **EQUITY IMPACT STATEMENT**

The acceptance of donations from the San Diego County Parks Society (Parks Society) assists the Department of Parks and Recreation (DPR) to continue and expand special events, community celebrations and activities in nature for the benefit of all residents and visitors. The donations allow DPR to provide additional supplies and services to youth, families, and communities to encourage the sharing of experiences, cultural traditions, and resources to strengthen a sense of belonging. Donations in this period included bus transportation for elementary school children from Cajon Valley Union, Chula Vista Elementary, La Mesa-Spring Valley, and San Diego Unified School Districts to DPR parks as part of the Discovery Program. The Discovery Program immerses students and teachers from urban areas in nature-related activities designed to educate them about scientific phenomenon and the history of the local environment, including a classroom visit by a DPR Park Ranger and follow-up field trip to that Ranger's Park. Donations also supported multiple nature based special events like National Trails Day, Wings Over Wetlands (San Elijo) and Wilderness Gardens Park 50th Anniversary. These donations also support the Summer Movies in the Park program where families can enjoy free movies under the stars, throughout the park system. The donations also supported the First

Time Camping Program that now provides camping space and equipment for no cost for families camping for the first time at Tijuana River Valley Park, Dos Picos Park, Lake Morena Park and Guajome Regional Park. The Parks Society provided the tents, sleeping bags, chairs and other equipment needed for a first-time camping experience.

#### SUSTAINABILITY IMPACT STATEMENT

The Department of Parks and Recreation (DPR) is committed to balancing recreation opportunities with efforts to protect and preserve our region's land, vegetation, wildlife, and natural resources. Programs are planned to support these efforts while expanding the number of residents that can experience DPR parks and programs. Donations from the San Diego County Parks Society (Parks Society) support these goals by providing donations to expand programs, like Movies in the Park, provide care and food for Animal Ambassadors that are used in interpretation programs at schools and parks to connect youth and families to the wildlife in DPR parks, and provide bus transportation for school children to participate in the Discovery Program in eight DPR parks (Stelzer, El Monte, Felicita, Flinn Springs, Guajome Regional, Los Peñasquitos, Otay Lakes, San Dieguito) to learn about nature and sustainability. Parks Society donations support large environmental based events like Wings Over Wetlands at San Elijo Park and National Trails Day at various trails.

#### FISCAL IMPACT

There is no fiscal impact associated with these recommendations. The Department of Parks and Recreation received donations from the San Diego County Parks Society totaling \$47,492.17 from January 1, 2023 to June 30, 2023. There will be no change in net General Fund cost and no additional staff years.

During the period of January 1, 2023, to June 30, 2023, DEHQ received donations totaling \$29,201.30 in non-cash donations to cover registration fees and travel costs for DEHQ staff to attend a professional association conference for the Certified Unified Program Agency (CUPA) hosted by the California CUPA Forum Board. Attendance supports DEHQ staff training in hazardous waste and materials laws and regulations.

Board of Supervisors (Board) Policy A-112, *Acceptance and Use of Gifts and Donations*, permits the acceptance of donations by the administrative head of each department of the County if specified conditions are met. County Administrative Code Section 66, *Acceptance of Gifts*, requires Board ratification of the acceptance of such gifts and approval prior to the expenditure of the gift, if the gift exceeds \$5,000.

Today's proposed actions are to accept DEHQ's Report of Gifts and Donations for the period of January 1, 2023, to June 30, 2023, and to ratify the acceptance and expenditure of gifts by DEHQ that exceeded \$5,000. Donations received during this reporting period from a non-profit and professional association were used to support DEHQ staff training.

Gifts and donations received are monitored and publicly disclosed in accordance with all County policies. Expenditures are internally tracked by DEHQ to ensure transparency and accountability of donations and gifts received and to provide for the equitable distribution of resources.

#### **OVERVIEW**

The Asset Management Division of the Department of General Services (DGS) is processing a request from the owner of Assessor's Parcel Number (APN): 115-240-05, to summarily vacate a portion of Palmas Drive offered for public street dedication, and the two areas reserved for the future westerly extension of Palmas Drive as a public street within APN: 115-240-04 and 115-240-05. A summary vacation is a streamlined process by which a public road, or a public service easement is abandoned. A summary vacation may be requested by the public if the easement interests are found to be excess to County of San Diego (County) needs and are not required for the purposes for which they were obtained.

The properties subject to the vacations are located within the Warner Springs Community Plan Area in the unincorporated community of Warner Springs. The County Department of Public Works (DPW) has determined that the portion of Palmas Drive offered for public street dedication, and the reservations for the future street are excess and no longer needed for present or future public use because Palmas Drive was never constructed, is not County-maintained and is not a part of the General Plan Mobility Element. The vacation of the offer of dedication and reservations will remove encumbrances that could allow for better use of the subject properties.

Today's request is for the Board of Supervisors to adopt a Resolution to summarily vacate a portion of Palmas Drive offered for public street dedication, and the two reservations for future street use, which are excess right-of-way not required for street or highway purposes.

#### **OVERVIEW**

The Asset Management Division of the Department of General Services (DGS) is processing a request to summarily vacate a portion of Buena Vista Avenue/Pointe Parkway dedicated to the County of San Diego (County) in 1979 as a condition of approval for Tentative Map No. 3581-1, and an Irrevocable Offer of Dedication (IOD) for Public Highway, made in 1990. A summary vacation is a streamlined process by which a public road, or a public service easement is abandoned. A summary vacation may be requested by the public if the easements are found to be excess to County needs and are not required for the purposes for which they were obtained.

The properties subject to the road vacation are located within the Spring Valley Community Plan Area in the unincorporated community of Spring Valley. The County Department of Public Works (DPW) has determined that a portion of Buena Vista Avenue/Pointe Parkway, and all the IOD for a public highway, together with the rights granted therein to extend drainage facilities, excavation, and embankment slopes beyond the rights-of-way, are excess and no longer needed for present or future public use because the Buena Vista Road/Pointe Parkway was never constructed, is not County-maintained, and is not part of the General Plan Mobility element. The easement for the public highway was originally acquired in 1979 to provide access to a County-maintained public right-of-way for Tentative Map (TM) No. 3581, and then in 2007 for TM No. 5299RPL6, but is no longer needed because both TM's expired and in 2017 the County Department of Parks and Recreation purchased the majority of TM 5299RPL6 as Open Space

Preserve Land. The IOD was acquired in 1990 for the future construction of Ivy Street, at its intersection with Buena Vista Avenue/Pointe Parkway, that was also not constructed, is not County-maintained, and is not part of the General Plan Mobility element. Ivy Street was originally dedicated in 1911 on Map No. 1317. The vacation of these road easements will remove encumbrances that could allow for better use of the subject properties.

Today's request is for the Board of Supervisors to adopt a Resolution to summarily vacate a portion of Buena Vista Avenue/Pointe Parkway, and the IOD, together with the incidental rights granted therein to extend drainage facilities, excavation, and embankment slopes beyond the rights-of-way, which are excess rights-of-way not required for street or highway purposes.
