If you would like to speak in person at the meeting on an agenda item, complete and submit a speaker form before the Commission hears it. You will be called at the time the item is heard. For virtual public comment, after the Chair opens the comment period, raise your hand by tapping the "Raise Your Hand" button on your computer, tablet, or smartphone, or by dialing *9 on your phone. Speakers will be called in the order in which hands are raised. Each person may speak only once on a particular item. When staff call on you, unmute your device by following the on-screen prompt or by dialing *6 on your phone. You may address the Commission on any matter not listed on the agenda. Complete and submit a speaker form in person or virtually by following the instructions above. California's open meeting laws do not allow the Commission to discuss or take any action on any matter
