For virtual public comment, after the Chair opens the comment period, raise your hand by tapping the "Raise Your Hand" button on your computer, tablet, or smartphone, or by dialing *9 on your phone. Speakers will be called in the order in which hands are

raised. Each person may speak only once on a particular item. When staff call on you, unmute your device by following the on-screen prompt or by dialing *6 on your phone. You may address the Commission on any matter not listed on the agenda. Complete and submit a speaker form in person or virtually by following the instructions above. California's open meeting laws do not allow the Commission to discuss or take any action on any matter not listed on the agenda at today's meeting. At its discretion, the Commission may add the item to a future agenda or refer it to staff or a committee. You can also submit a comment in writing via email to arts@sdcounty.ca.gov or by mail to 1600 Pacific Highway, Room 152, San Diego, CA 92101.
