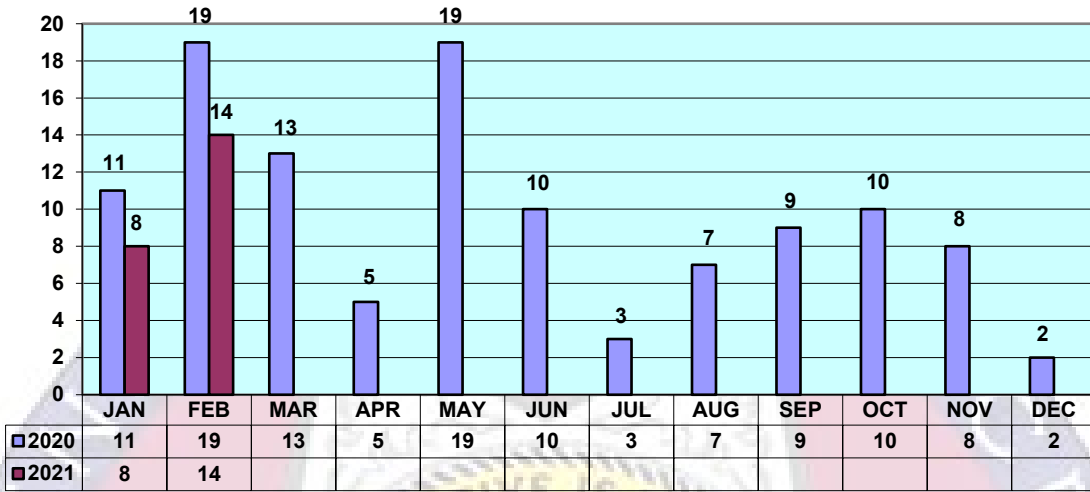
- Death (x3): Barricade (x2), Pursuit

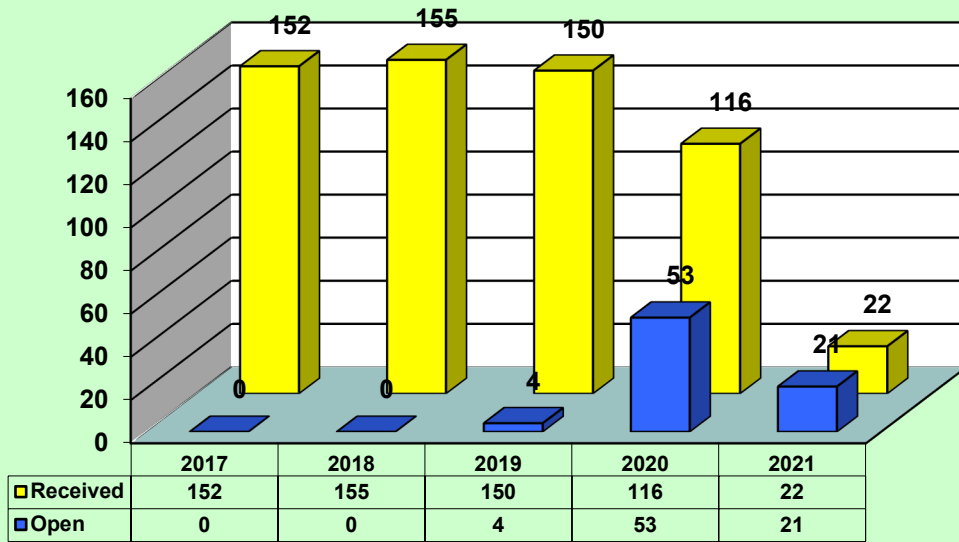
