CLERB LETTER OF CONCERN

Dear Chairperson Pintar,

I write to update you on the status of the multiple requests for information submitted by the Citizens' Law Enforcement Review Board (CLERB) contractor, The Mountain Whisper Light (TMWL), in conjunction with the study TMWL is conducting that was the subject of the CLERB's November 12, 2024, dated Letter of Concern. To date, TMWL has submitted seven (7) requests for information seeking records spanning up to a twelve (12) year period. Many of those requests included multiple subparts, four of which contained twenty or more subparts. Copies of those requests are attached.

The information requested is spread out over multiple record systems, locations and databases, including archived information, and required significant time and resources to extract and compile information responsive to the requests. In an effort to assist TMWL, the San Diego County Sheriff's Office has been producing responsive records on a rolling basis for those requests that include multiple subparts. For example, request S002147-061824 contained twenty (20) subparts. Rather than wait for records responsive to all twenty (20) subparts being ready for production before producing anything in response to that request, records were provided as they became ready for production. In the case of request S002147-061824, ten (10) of the twenty (20) requests have been fulfilled as of this writing. The same is true for other requests.

To date, the San Diego County Sheriff's Office has devoted hundreds of hours extracting, compiling and producing records responsive to the requests for information, resulting in thousands of pages of responsive records being produced. A summary of the requests and the status of the responses appears below.

1. S000257-012224_Documents and SDSD_Population_PRA - Closed 10/25/2024

- a. Population Statistical Data and Nonstatistical Data
 - i. (10 requests total)
- b. In-Custody Death Statistical Data and Nonstatistical Data
 - i. (11 requests total)

The request required extensive research across multiple Detention Services Bureau (DSB) divisions to determine the existence of the requested information, its content, and whether it could be extracted or would require the creation of new records. For the records that were retrieved, significant redactions were required to ensure compliance with applicable restrictions and exemptions. Over 1,000 pages of data was provided to the requestor.

2. S000894-031324 - Closed 12/5/2024

- a. Mental Health Statistical Data
- b. Mental Health Policy and Procedure Questions.
 - i. (21 requests total)

The request required extensive research within the Medical Services Division and the Jail Population Management Unit to determine the existence of the requested information, its contents, and whether it could be extracted or would require the creation of new records. For the records that were retrieved, significant redactions were required to ensure compliance with applicable restrictions and exemptions. Review, extraction, and redaction of 23 DSB and Medical Services Division policies and procedures from 2012 to 2024 were processed. Over 500 pages of data was provided to the requestor.

3. S003542-092524 - Closed 10/03/2024

a. This requested 15 data points for all IPs at all jail facilities from 01/01/2012 to 01/01/2024

This request was denied in its entirety as it requested twelve (12) years of criminal history information. We offered to provide contemporaneous information (30 days prior to the request) but no response was received.

4. S002147-061824 – Open – Partial response provided 1/21/2025 (10 of 20 requests completed)

- a. Staffing/Personnel Statistical Data
- b. Staffing/Personnel Nonstatistical Data, and
- c. Staffing/Personnel Questions.

This request required extensive research within Personnel, DSB Command, Training Units, and the Medical Services Division to determine the existence of the requested information, its contents, and whether it could be extracted or would require the creation of new records. For the records that were retrieved, significant redactions were required to ensure compliance with applicable restrictions and exemptions. Over 40 documents have been provided to the requestor. In addition, the requestor was provided with 12 years of Excel data sets for Detentions personnel. We are still working with Personnel to review archived statistical data that may be responsive to the request.

5. S003540-092524 -Closed 12/04/2025

a. Total number and dates of all in-person visits for all incarcerated persons at all jails from 01/01/2012 to present date.

This request required consultation with the DSB Principal Data Research Analyst to determine if the data could be extracted. The requestor was provided with 12 years of Excel data sets, each ranging from 1,000-2,000 pages.

6. S003984-102424 - Open - request in progress; no records provided yet

a. Requests P&P recommended and/or enacted in all jails and information about vendors, state entities, and others "involved" in preventing in-custody deaths.

The requestor was previously referred to the public website for similar questions and requests referencing facility updates, recommendations, and implementation of policies, programs, or initiatives related to the prevention of in-custody deaths.

This request includes an additional 37 items of any activities and/or initiatives that the San Diego County Sheriff's Office implemented over the last 12 years to prevent (or reduce) the number of in-custody deaths. This request requires reviewing any documents that may mention a change due to an in-custody death. There are many avenues by which changes may occur and we do not necessarily document changes as a response to a particular an incustody death incident. Therefore, this not only requires the review of archived documents but also requires working knowledge of the evolution of all activities and/or initiatives the Sheriff's Office has implemented.

7. S003985-102424 - Open– Partial response provided 1/16/2025 (5 of 8 requests completed)

a. Requests mental health information for each jail facility from 01/01/2012 to present.

This request required research within DSB, the Medical Services Division, and the Detentions Investigation Unit to determine the existence of the requested information, its contents, and whether it could be extracted or would require the creation of new records. For the records that are retrieved, significant redactions are required to ensure compliance with applicable restrictions and exemptions. To date, the requestor has been provided with approximately 90 pages of statistical data. We are still working on reviewing archived statistical data that may be responsive to the request.

Please be assured that the Sheriff's Office has been diligently working to process all of the requests submitted by TMWL within the confines of the law and will continue to do so.

The California Public Records Act (CPRA) applies to a request for a copy of records that reasonably describes an identifiable record. Gov't Code § 7922.530. "'[P]ublic records" includes any writing containing information relating to the conduct of the public's business prepared, owned, used, or retained by any state or local agency regardless of physical form or characteristics." Cal. Gov't Code § 7920.530. Your request to "explain this discrepancy, having more releases than bookings" is not a request for an identifiable public record.

If there was an effective influx of people that was not captured by the bookings, please provide the monthly breakdown of those extra individuals for the same time period: from 01-01-2012 until 01-31-2024.

The Sheriff's Office is providing the requested booking data from January 1, 2012, to January 31, 2024 to include Not Fit For Jail Bookings (NFFJB). The Sheriff's Office typically includes NFFJB in release statistics only- see "SDSD Bookings_Releases_2012_2024_Updated.pdf".

On January 22, 2024, the San Diego County Sheriff's Office received your request for records under the Public Records Act. The San Diego County Sheriff's Office responded on May 31, 2024, and amends its response to the following:

2. [t] he name of the decedent and the total number and dates of telephone calls, emails, in-person and video visits for each person who died in custody starting with 1/1/2012 through to the present date.

The Sheriff's Office amends its original response to include the following:

The Sheriff's Office does not have records containing the statistical data requested as it pertains to telephone calls, emails, or video visits; nor does the Sheriff's Office have a means of extracting the total number and dates of each communication. To provide the requested information, the Sheriff's Office would need to 1) identify the decedent; 2) identify the relevant booking number (as an individual may have various bookings); 3) access that person's booking information; 4) pull records for that specific interaction; 5) create an inventory of the relevant information as it pertains to that individual; and 6) combine this information for all identified decedents. Additional steps would be required as the request pertains to email because an incarcerated person's emails are not differentiated from other forms of electronic notification in that person's account. For example, an incarcerated person may receive an electronic receipt for items purchased from the commissary or an electronic notification that money has been added to that person's books. The Sheriff's Office would need to review every single item to determine whether it qualifies an email communication. In doing so, the San Diego County Sheriff's Office would "generate new substantive content" and "create inventories of data in response to a records request." See Sander v. State Bar of Cal., 26 Cal. App. 5th 651 (2018). The CPRA does not require public agencies to create records. Id.

Lastly, telephone calls and video visit records have an approximate retention period of five years, based on storage of the third-party communication system utilized. Thus, the Sheriff's Office has no means to provide the statistical information requested for these interactions.

The Sheriff's Office is able to extract the total number and dates of in-person visits for each person who died in



custody starting with "1/1/2012 through to the present date." The Sheriff's Office is providing the data requested for 1/1/2012 through to the date of the request date of January 22, 2024. The information is based on the Jail Information Management System (JIMS) History Entry –Social Visitor Arrived. Once the visitor has arrived and checked in for their visit, the data is input into JIMS as "Arrived Visitor". This does not include attorney and professional visits conducted. Incarcerated individuals have the right to refuse visits at any time. Whether a visit was refused and/or if the incarcerated individual could not attend is not indicated in this data set. Additionally, visits can be cancelled for several reasons. Scheduled visit cancellations, where the visitor did not check in, are not included in this data set. Note, social visits ("in-person") were suspended during the Covid-19 pandemic which may have resulted in a gap in the data being provided. Lastly, the individuals that died in-custody this year, as of the date of the request, did not have any social visits completed, therefore, they are not included in this file.

9. All non-medical request forms submitted by each person who died in custody starting with 1/1/2012 through to the present date, including the decedent's name.

The Sheriff's Office has reevaluated this request for records responsive to this request and amends it response as follows:

Incarcerated persons requests are filled out by hand by the incarcerated person and either placed in a box for collection or handed directly to a sworn officer. The request is distributed to the division relevant to the request and then returned to the incarcerated person with a written response. The Sheriff's Office does not have a procedure or policy of retaining "non-medical requests" submitted by incarcerated persons or of tracking these requests or responses. The Sheriff's Office conducted a search for the requested records and did not locate any responsive records.

11. All grievance forms submitted by each person who died in-custody starting with 1/1/2012 through to the present date, including the decedent's name.

The San Diego County Sheriff's Office previously responded on May 31, 2024, and incorporates the previous response.

On July 1, 2024, California Senate Bill 519 ("SB 519") went into effect. SB 519, codified in Penal Code section 832.10, makes records relating to an investigation conducted by a local detention facility into a death that occurred in the custody or supervision of the local detention facility available for public inspection pursuant to the CPRA. The San Diego County Sheriff's Office is fully committed to complying with the law. As such, the Sheriff's Office is reevaluating this request for records responsive and releasable pursuant to Penal Code section 832.10.

To the extent that any grievances are not included in the death investigation file pursuant to PC 832.10, your request for grievances in denied pursuant to Government Code section 7922.000. Government Code section 7922.000 exempts records that "on the facts of the particular case the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure of the record." Grievances are the process by which incarcerated persons may seek formal administrative review of issues that impact their personal



confinement. Public disclosure would discourage incarcerated persons from reporting issues and seeking review.

On August 12, 2024, the San Diego County Sheriff's Office received the following clarification from Nawras Hakak on behalf of TMWL in regard to #S000257-012224: "Please confirm that Section A. Question 1a-h. of the Population PRA has been corrected so that the word "Decedent's" has been changed to "Inmate's." If it has not been changed, please let TMWL know so that it can send the correct version to you and you can forward it to the liaison." As the current request is a derivative of S000257-012224, the Sheriff's Office has likewise processed this request (#S003542-092524) with the term "Inmate" in place of "Decedent" for bullets a-h.

Records and information disclosed under Government Code section 7923.610 are limited to current information and records pertaining to contemporaneous police activity. *County of Los Angeles v. Superior Court* (Kusar), 18 Cal.App.4th 588, 601 (1993); *Kinney v. Superior Court*, 2022 Cal. App. LEXIS 293 (2022); 89 Ops.Cal.Atty.Gen. 204 (2006). The San Diego County Sheriff's Office defines contemporaneous as 30 days prior to the date of the request.

Your request for an incarcerated person's (a) Name; (b) Inmate Number; (c) Age; (d) Race/Ethnicity; (e) Gender; (f) Custody Status; (g) Projected Release Date (i) Date in-Custody Status Began (or Date of Booking); (j) Arrest Offense and/or Criminal Charges Filed; (k) Bail Amount (where applicable); and (n) Name of Jail Facility from January 1, 2012 through January 1, 2024 does not qualify as a contemporaneous request. As such, your request for non-contemporaneous booking and release data is denied in part pursuant to Government Code section 7923.600. Records of a law enforcement investigation, or any investigatory or security files compiled by a law enforcement agency are exempt from disclosure. Cal. Gov't. Code § 7923.600. Additionally, your request is denied in part pursuant to Government Code section 7927.705, incorporating Penal Code section 13300 et seq. and California Constitution Article 1. This request seeks local summary criminal history information, as defined by Penal Code section 13300, subd. (a), the production of which is prohibited by the terms of Penal Code sections 13300-13305. The Sheriff's Office is able to provide "statistical or research information obtained from a record, provided that the identity of the subject of the record is not disclosed." Pen. Code § 13300, subd. (h).

Your request for incarcerated person's (h) Classification Status; and (o) Type of Housing Unit (e.g. dormitory, single cell, double cell, restricted housing, infirmary, etc.), are denied pursuant to Government Code section 7923.600, Government Code section 7927.700, and Government Code section 7927.705, incorporating Penal Code section 13300 et seq. and California Constitution Article 1. Records of intelligence information or security procedures, records of a law enforcement investigation, or any investigatory or security files compiled by a law enforcement agency are exempt from disclosure. Cal. Gov't. Code § 7923.600; *Haynie v. Superior Court*, 26 Cal. 4th 1061, 1071-72 (2001). Pursuant to Government Code section 7927.700, personnel, medical, or similar files, the disclosure of which would constitute an unwarranted invasion of personal privacy, are exempt from disclosure. Classification records contain both investigative and security records compiled by, but not limited to, the Sheriff's Office. An incarcerated person's initial classification is



determined by their original booking charges, criminal history information, medical and psychiatric issues or additional special conditions, and information obtained from the incarcerated person interview. The incarcerated person is assigned to the most appropriate housing location based on their classification designation. Housing assignments are based on the incarcerated persons classification designation. Disclosing this information reveals personal and confidential information as to the individual. Additionally, disclosing the location of where an incarcerated individuals are being housed raises significant security concerns for the individuals incarcerated and those working in the facility.

The Sheriff's Office does not have records which contain the information "m. Realigned Population Status (Part of realigned population: yes or no)". To identify if a person was impacted by Assembly Bill 109, the Sheriff's Office would need to look at a series of factors (arrest type, arresting agency, charge, charge disposition, etc.) to determine if they were subject to Post Release Community Supervision (PRCS), Penal Code section 1170, etc. at some point during their stay in custody. Additionally, any type of population "status" that is calculated can change throughout a person's stay in custody as they proceed through the judicial system. For example, they could be booked on a PRCS violation and then remain in custody sentenced on a new non-PRCS arrest. In this example, they would be both "realigned" and "not realigned". The Sheriff's Office would need to conduct a custom analysis of each incarcerated person's unique circumstances on a specific date in order to provide the requested information. A local agency has no duty to create a record that does not exist at the time of the request. *Sander v. Superior Court* (2018) 26 Cal.App.5th 651.

Sentence length is given by the courts and is stored in the court's system and/or the District Attorney's case management system. Your request for an incarcerated person's "(I) length of sentence (where available)" is denied as to any records that the Sheriff's Office has containing this information pursuant to Government Code section 7927.705, incorporating Penal Code section 13300 et seq. and California Constitution Article 1.

Your request as it does not pertain to available contemporaneous information, as outlined in Government Code section 7923.610, is additionally denied pursuant to Government Code section 7922.000. Government Code section 7922.000 exempts records that "on the facts of the particular case the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure of the record." This request is for 12 years of criminal history information. Disclosure of such an extensive body of sensitive data would not only violate the privacy rights of the incarcerated person's involved but also result in the creation of a new private data base of criminal offender record information.

Please let us know if you would like to receive the booking and arrest information requested for the 30 days prior to this request.

A reply must be received within ten (10) business days of the date this email was sent or your request will be closed, and a new request will be required. Please respond in writing via the <u>Records Request System</u> so that there is a record of your response.

This request seeks local summary criminal history information, as defined by Penal Code section 13300, the production of which is prohibited by the terms of Penal Code sections 13300-13305.

Your request is additionally denied, in part, pursuant to Government Code section 7922.000. Government Code section 7922.000 exempts records that "on the facts of the particular case the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure of the record." Releasing the name of every individual incarcerated in a San Diego County Sheriff's facility from 01/01/2012 through the present day would be a significant violation of individual privacy rights. Additionally, the release of this information is contrary to reentry efforts. There is a social stigma associated with incarceration. This information is sought to assist the San Diego County Citizens' Law Enforcement Review Board (CLERB) in discharging its duties under the San Diego County Code (SDCC) and Charter. As you know, SDCC section 340.15 requires "all officers and employees of the County" to give CLERB "complete and prompt cooperation" when it is discharging its duties. The assertion of discretionary exemptions to disclosure under the CPRA is inconsistent with this legal obligation. If you assert any type of discretionary exemption to disclosure, then with your response please also explain how your choice to assert that exemption rather than cooperate with CLERB does not violate SDCC 340.15.
