*Investigation into San Diego Sheriff's Office Officer-Involved-Shooting*

*Yesterday, Wednesday, November 5, 2025, at approximately 7:30 p.m. an officer-involved shooting (OIS) occurred on the 1700 block of Kyrsten Terrace Ct. in Alpine, California. The OIS incident involved personnel from the San Diego County Sheriff's Office and unfortunately resulted in the death of one individual. Following the officer-involved shooting, it was subsequently determined that the handgun that was pointed at deputies was a replica firearm.*

*The San Diego Sheriff's Office will be releasing Body Worn Camera footage and a Critical*

*Incident Video in the coming days with details of the shooting.*

*Today the California Department of Justice (DOJ), pursuant to Assembly Bill 1506 (AB 1506), announced that it is investigating and will independently review this officer-involved shooting (OIS).*

*Following notification by local authorities, DOJ's California Police Shooting Investigation Team initiated an investigation in accordance with AB 1506 mandates. Upon completion of the investigation, it will be turned over to DOJ's Special Prosecutions Section within the Criminal Law Division for independent review. ## Update - Death Investigation

*Cause and Manner of In-Custody Death- San Diego Central Jail*

The San Diego County Sheriff's Office is releasing the cause and manner of death of an 82-year-old man, Karim Talib, who was in custody at the San Diego Central Jail (SDCJ). On Monday, July 28, 2025, Sheriff's Homicide investigators were notified of Mr. Talib's passing while in custody at SDCJ.

On July 28, 2025, at around 8:40 a.m., Sheriff's Deputies and a facility nurse were distributing medication when they discovered Mr. Talib unresponsive inside his cell. Upon observing the situation, the deputies immediately activated 9-1-1, requested additional assistance from the facility's medical staff, and began CPR.

Paramedics and the San Diego Fire Department assumed lifesaving measures upon their arrival. Despite their efforts, Mr. Talib was pronounced deceased at the detention facility at about 9:10 a.m.

Mr. Talib had been in Sheriff's custody since May 27, 2025, and was facing charges for mayhem, assault with a deadly weapon, and elder abuse. He was pending a court hearing related to his mental competency.

The Medical Examiner's Office has completed an autopsy of Mr. Talib and determined the cause of death was hypertensive and atherosclerotic cardiovascular disease complicated by acute pyelonephritis due to enterobacter hormaechei cystitis. The manner of death was classified as natural.

The San Diego Sheriff's Office extends our sympathies to the Talib family and all those affected by Mr. Talib's passing. A Sheriff's Family Liaison Officer will continue to support the family as they navigate through this difficult time.

The Citizens' Law Enforcement Review Board (CLERB) was notified regarding the incident. As is the protocol for all in-custody deaths, the Sheriff's Homicide Unit responded and is conducting a thorough investigation to ensure all aspects of this incident are examined.
