

NAME: ENVIRONMENTAL HEALTH ADVISORY BOARD,
SAN DIEGO COUNTY

LEGAL AUTHORITY: County Administrative Code, Article XV-A, commencing with Section 249; Amended by Ordinance 9031 (NS), adopted on 4/28/99 (8).

**MEMBERS
APPOINTED BY:** Board of Supervisors

**MEMBERSHIP
COMPOSITION:**

The Board shall consist of seventeen (17) members. Members shall be nominated by the following for appointment by the Board of Supervisors:

One (1) Representative of Hazardous Materials Regulated Industry to be nominated by the Supervisor, District 1.

One (1) Representative of the Restaurant Industry to be nominated by the Supervisor, District 2.

One (1) Representative of Occupational and Radiological Health Regulated Industry to be nominated by the Supervisor, District 3.

One (1) Representative of Regulated Retail Food Establishments (not restaurants) to be nominated by the Supervisor, District 4.

One (1) Representative of Land Use/Housing Regulated Industry to be nominated by the Supervisor, District 5.

Two (2) Public Members, one each, to be nominated by the Supervisors, Districts 3 and 5.

Two (2) Public Safety Members (i.e., representatives of Fire Department, Law Enforcement, or Prosecutorial Agencies), one each, to be nominated by the Supervisors, Districts 2 and 4.

One (1) Representative of Community Environmental Organizations to be nominated by the Supervisor, District 1.

Seven (7) Members to be nominated by the Director of the Department of Environmental Health from among the following categories:

Technical Experts:

One (1) Water Quality/Liquid Waste Disposal

One (1) Toxicologist
One (1) Epidemiologist
One (1) Land Use/Housing expert
One (1) Vector Borne Disease expert
One (1) Representative of State Agencies
One (1) Academia

TERMS: Members shall serve a term of office of three (3) years and shall be eligible for reappointment.

If a vacancy occurs, a new appointee shall serve for the unexpired term of the member being replaced.

DUTIES: The Board shall have the following duties and responsibilities:

- To provide technical input and guidance concerning major issues on environmental health at the request of the Director.
- To provide technical input and guidance regarding development and implementation of new programs in environmental health proposed by the Director.
- To review proposed State and Federal legislation and to provide technical information and advice to assist the Department of Environmental Health in developing programs and policies to favorably influence legislation and anticipate legislative mandates.
- To review and provide advice concerning fee policies at the request of the Director.
- To perform such other duties as may be assigned by the Board of Supervisors.
