Our Summer Certified Legal Interns participated in the 10th Annual George Bennett Closing Argument Tournament. This event gives the interns a chance to showcase their oral advocacy skills while receiving training and feedback from experienced trial attorneys. The interns are given a closed universe mock case file and are asked to craft an 8-minute closing argument based on what happened at the trial. The competition honors the legacy of George Bennett, the epitome of a “prosecutor's prosecutor,” by focusing on improving argument and advocacy skills while stressing the importance of ethics and professionalism. 19 interns participated in the tournament and more than 25 DDAs volunteered as judges.
